The Transformation of Rural India

Rapid agriculture growth and rapid rural employment growth were always the focus of India's policy makers. Mahatma Gandhi envisaged India as a Nation of self-sufficient tonomous village republics. Land the summum bonum of rural existence, and agricultural structure was the most important determinant of India's development. Highly skewed distribution of land responsible for agricultural backwardness. As land was the critical income generating asset of rural India, changes in agricultural holding structures were necessary to ensure prosperity of the rural population. Accordingly, India's State policy focused on State Governments formulating and implementing Land Reforms legislations. These included the Land Ceiling Act, the Tenancy Act, the Land Revenue Act and broadly adopted the land to the tiller policy Surplus arable government lands were distributed to the poor and needy peasants for livelihoods. These policies were envisaged to promote agricultural growth and alleviate rural poverty.

After the bank nationalization in

July 1969, a big push was given towards expansion of banking activities. Rapid expansion of bank branch network into rural areas and expansion of bank credit to agriculture and related activities Priority sector lending targets and interest rates were introduced as part of a social banking approach. The rural bank branch expansion significantly lowered the rural poverty and increased nonagricultural growth. However, as time progressed, divergences emerged between the levels of development in States. The richer

and faster growing States were better at reducing rural poverty while growth was volatile in the poorer States. The faster growing States had formulated laws for amalgamation of farm holdings into viable units for investments, productivity and growth. In the poorer States, the alienation of small and marginal farmers from their lands and subsequent conversion to landless agricultural labor made them entirely dependent on the vagaries of the market. Large scale labor migration was witnessed in areas where rainfed agriculture practices were prevalent. The richer States also attracted higher investments and had better infrastructural development which resulted in higher per capita incomes as compared to the poorer States. It was in this backdrop that the In this backgrop that the Indian State implemented a series of welfare programs for the rural population. These included the Desert Development Program, the Drought Prone Area Development Program and the Watershed

Development Program. These programs were taken up in a decentralized participatory developmental model. The objective was to treat vast stretches of land areas with watershed treatment practices including construction of check dams, development of pastures and promotion of improved animal husbandry practices. A second crop in rainfed areas, essentially meant higher farm incomes and lower migration of farm

The Indian State also implemented several major direct beneficiary programs for asset generation, skill development, residential housing and employment generation. The Department of Rural Development

implements the major schemes of National Rurban Mission, Pradhan Mantri Awas Yojana (PMAY). Pradhan Mantri Gram Sadak Yojana (PMGSY), the Deen Dayal Upadhyaya Grameen Kaushalya Yojana (DDU GKY) and the Mahatma Gandhi National Rural Employment Guarantee Act (MGNREGA) programs. The implementation of the MGNREGA on a pan India basis with assured employment on individual and community based programs has resulted in significant employment and asset generation in rural areas. The National Rurban Mission was launched in February 2016 as a new initiative for development of a cluster of villages that preserve and nurture the essence of rural community life with focus on equity and inclusiveness without compromising with the facilities perceived to be essentially urban in nature. The DDU GKY essentially focused on youth between 15 years and 35 years from poor families, is tasked with the objective of adding diversity to the incomes of rural poor families and caters to the career

aspirations of the rural youth. Indian farmers were always concerned about the availability of adequate credit at reasonable cost in a timely manner. One of the major steps forward in this direction was financial inclusion. The Pradhan Mantri Jan Dhan Yojana represents the National Mission for Financial Inclusion to ensure access to financial services. The Jan Dhan Yojana provided the bankers with the necessary confidence to promote credit culture across the deprived population and resulted in significant increases in credit flows to rural sector. A Nation of India's size requires

significant increases in food production. The year 2016-17 witnessed the highest ever food grain production of 273.38 million tons which is 6.37 percent higher than the last 5 years average production and 8.6 percent higher than 2015-16. Government introduced the Soil Health Card Scheme (SHC) in 2015 to be issued on a bi-annual basis to all land holders of the country with the objective to conduct farm level soil analysis. In July 2015, Government introduced the National Agricultural Market (E-NAM) to link 585 wholesale agriculture production marketing committees across the country through a common e-platform. The portal has been made available in several Indian languages and has empowered the farmers with vast information dissemination. The State continued to make rapid strides in the implementation of the Pradhan Mantri Fasal Bima Yojana and the Pradhan Mantri Krishi Sinchayee Yojana covering all risks of the crop cycle and providing incentives for improved irrigation practices.

The Government's initiatives for empowering the farmers and improving the infrastructure at the village level have been largely successful in reducing poverty and enhancing education and health care indicators. The improvement in farm incomes and the transparency in subsidy transfers would enable the creation of a 21st century India that is dynamic and forward looking. Two IAF commandos, two militants killed in J&K gunfight

Srinagar, Oct 11: Two commandos of the Indian Air Force elite Garud commando unit and two militants were killed on Wednesday in a gun battle in Jammu and Kashmir's Bandipora district.

"The two Garud personnel were killed in action while operating with the Army for operational experience and training," Defence Ministry spokesman Colonel Rajesh Kalia said.

The gunfight between the security forces and the terrorists took place in the Hajin area, Kalia described it as an "intense operation". Earlier both the defence sources

and the police had said that the security personnel killed in the Hajin encounter were from the Indian Army. At least one more soldier was also injured in the encounter.

The earlier reports said the gun battle erupted when the security

personnel surrounded the Paribal village early on Wednesday following specific inputs about the militants' presence inside a house. The hiding militants triggered the encounter firing at the security forces approaching the house. Two militants were immediately killed. Three soldiers sustained injuries. two of whom were critical and later succumbed," the police sources

"The Chinar Corps commander and

all ranks salute the Martyrs and offer condolences to the bereaved families." Kalia added.

The Garud commandos are a special unit of the Indian Air Force with only over a 1 000 commandos It was formed in September 2004. The unit derives its name from Garuda, a divine bird-like creature of Hindu mythology.
The Garud commandos are trained

along the lines of Navy's MARCOS and Army's para commandos.

US flies bombers over Korean peninsula as Trump discusses options

Seoul, Oct. 11: The US military flew two strategic bombers over the Korean peninsula in a show of force late on Tuesday, as President Donald Trump met top defence officials to discuss how to respond to any threat from North Korea.

Tensions have soared between the United States and North Korea following a series of weapons tests by Pyongyang and a string of increasingly bellicose exchanges+ between Trump and North Korean leader Kim Jong Un.

North Korea has launched two missiles over Japan+ and conducted its sixth nuclear test in recent weeks as it fast advances towards its goal of developing a nuclear-tipped missile capable of hitting the US mainland

The two US Air Force B-1B bombers were joined by two F-15K fighters from the South Korean military after leaving their base in Guam, South Korea's Joint Chiefs of Staff said in a statement on Wednesday.

After entering South Korean

airspace, the two bombers carried out to-ground missile drills in waters off the east coast of South Korea, then flew over the South to waters between it and China to repeat the drill, the release said.

The US military said in a separate statement it conducted drills with Japanese fighters after the exercise with South Korea, making it the first time US bombers have conducted

training with fighters from both Japan and South Korea at night. The US bombers had taken off from

the Andersen Air Force Base in Guam. In August, Pyongyang threatened to fire intermediate-range missiles towards the vicinity of Guam. a US Pacific territory that is frequently subjected to sabre-rattling from the North.

Guard raised

South Korean and US government officials have been raising their guard against more North Korean provocations with the approach of the 72nd anniversary of the founding of North Korea's ruling party, which fell on Tuesday.

Trump hosted a discussion on Tuesday on options to respond to any North Korean aggression or, if necessary, to prevent Pyongyang from threatening the United States and its allies with nuclear weapons. the White House said in a statement. Trump was briefed by Secretary of Defense James Mattis and Chairman of the Joint Chiefs of Staff General Joseph Dunford at a national security

team meeting, the statement said. US and South Korean wartime operational plans, including a plan to wipe out the North Korean leadership, were stolen by North Korean hackers last year, a South Korean ruling party

lawmaker said on Wednesday. Some 235 gigabytes of military documents were taken from South Korea's Defence Integrated Data Centre in September last year, Democratic Party representative Rhee Cheol-hee said in radio appearances on Wednesday, citing information from unidentified South Korean defence officials.

In May, an investigative team inside the defence ministry announced the hack had been carried out by North Korea, but did not disclose what kind of information had been taken.

The United Nations Security Council,

which has imposed a series of ever

tighter sanctions on North Korea, has banned four ships from ports globally for carrying coal from North Korea, including one vessel that also had ammunition.

The vessels are the first to be designated under stepped-up sanctions imposed on North Korea by the 15-member council in August and September over two long-range ballistic missile launches and Pyongyang's sixth and largest
