Call for sustainable tourism echoed during World Tourism Day at Phayeng

Imphal, Sept. 28: World Tourism Day on the theme "Sustainable Tourisma Tool for Development' was observed at Phayeng Village, Imphal West yesterday. Speaking as the Chief Guest, Karam Shyam, Minister of Consumer Affairs, Food & Public Distribution and Revenue said that, the government led Chief Minister N. Biren Singh is giving special emphasis to tourism sector.

He said the Chief Minister currently in New Delhi is meeting Union Ministers and officials in this regard. Karam Shyam also said sanction to build ropeway connecting Siroi to Ukhrul, Marjing to Pheidinga and Sendra to Karang has been approved. A proposal for direct flight between Delhi and Imphal (3 flights in a week) is also being sent to the Central Government for

consideration

Minister Karam Shyam said Phayeng is an appropriate location to celebrate World Tourism Day as the village is rich in natural beauty. He also said that the welcome accorded to him following the age old traditions and customs with men and women of the area wearing the traditional dress is in line with the theme of the observation. He applauded the locals for preserving the culture and traditions of our forefathers and said that it is heartening to be sitting at the dias(stage) along with the Kullakpa (Village Head) of Phayeng who is

wearing the traditional dress.

Karam Shyam highlighting the contribution of Tourism in the economy said the sector accounts for 10% of global GDP and has generated 1 in 10 jobs in the global

workforce. He said it is unfortunate. that the State is unable to tap the full potential of the natural beauty which is blessed with green forest cover and rare species of flora and fauna. The Minister said to boost tourism. the State should become tourist friendly, provide a secure environment by improving the law and order situation. He called upon the citizens of the State to help the Government in making Manipur a favoured tourist destination. He also said water harvesting structure will soon come up at Lamphel and land encroachers will be evicted after giving suitable notice, following the law of the land.

Sapam Ranjan Singh, Chairman of the Tourism Corporation of Manipur Limited (TCML) said that marketing in an important constituent needed to boost tourism. Stating that emphasis is being given to promote rural tourism, Shri Sapam Ranjan Singh said in the upcoming Sangai Festival homestays will be promoted to unable the tourists to experience the lifestyle of the people.

Heikham Dingo Singh, MLA Sekmai A/C said that the State is rich in arts and culture and tourism can reach its full potential if the locals collaborate with the Government. He also said for the State to develop, the villages must be developed first. As part of World Tourism Day, the locals of the Phayeng village performed cultural dances of Khou Chongba and Chakpa Phayeng Anoiba jagoi. Mukna demonstration enthralled the spectators along with Waa (bamboo) Chingba. The locals of Phayeng also submitted memorandum to the Chief Guest Karam Shyam Which was addressed to the CM.

PRADHAN MANTRI AWAAS YOJANA – GRAMIN (PMAY-G)

Information to all Village Authorities/Gram Panchavats/General Public

- Government is committed to provide 'Housing for All' by 2022. Erstwhile IAY has been restructured into Pradhan Mantri Awaas Yojana -
- Beneficiaries under PMAY-G are to be selected from SECC data. Beneficiaries to include all houseless and households living in zero, one or two room houses with kutcha wall and kutcha roof as per SECC data, subject to exclusion process prescribed in Guidelines. Ranking and prioritization among these beneficiaries to be done. Separate priority list for SC, ST, Others and Minorities for each Gram Panchayat to be generated.
- These lists are to be circulated to all Gram Panchayats/Village authorities concerned for verification by Gram Sabha/Assembly of Village Authority.
- Block Development Officers (BDOs) have been directed to convene awareness and sensitization meetings with all Pradhans and Village Authorities by giving wide publicity in electronic media and local newspapers. The Beneficiary selection method and procedure to be explained in these meetings. Post verification, BDO to ensure publicity of the lists provided by the Gram Sabha/Village Authority within the Gram Panchayat/Village for atleast seven days.
- Window period of fifteen days to be given for submission of complaints regarding the lists be any aggrieved person to the BDO concerned. BDO to enquire and submit a report to Appellate Committee headed by Deputy Commissioner within fifteen days. Appellate Committee to resolve and dispose of cases within fifteen days.
- Appellate Committee may also receive petitions and applications from applicants who are not in SECC data but claim that they are needy and deserve house as per PMAY-G Guideline. Appellate Committee may receive such recommendation/report from Gram Sabha/Village Authority also. Appellate Committee to have such claims/reports/complaints verified by BDO or designated officer. Appellate Committee to recommend list of such non-SECC claimants as are found genuine after enquiry to rural Development and Panchayat Raj Department.
- The selected beneficiary will receive Rs. 1.30 lakhs from PMAY-G component for construction of house. Additionally, a sum of Rs. 12,000/ is to be provided from MGNREGS for construction of low cost toilet. Further, 95 person days of wage employment may be granted for construction of own house of beneficiary there in an additional amount of Rs. 19,380/- may be provided from MGNREGS component. Thus, effectively, the total unit cost to be received by the beneficiary would be Rs 1.30 lakhs + Rs. 0.12 lakhs + Rs. 0.19380 lakhs = Rs.
- The amount shall be released to the beneficiaries under PMAY-G as per stages of houses construction given below:

Release of Second and Third instalments shall be preceded by site visit by designated officials and verification of work details which shall be uploaded mandatorily to AwaasSoft along with supporting photographs

- Houses to be constructed under the technical supervision of trained and certified Masons. Districts will be provided trained mason. Training of masons to be conducted by government of India accredited agencies.
- 10) Geo-tagged photo of beneficiary's current house and proposed location will be mandatory before release of funds. All funds will be directly to beneficiaries bank account in electronic transfer mode
- 11) Annual Tentative Plan (Year wise) for construction PMAY-G house are listed below:

12) Households that deserve assistance under PMAY-G but have not been included in the initial beneficiaries list drawn SECC-2011 data may apply to the Appellate Committee headed by Deputy Commissioner for inclusion in the beneficiaries list. Such deserving households shall be included in the beneficiaries list for next year after obtaining due approval from competent Authority in the Central Government.
