This process is compulsory as follow up for Kidney treatment which is done at Nephrology department.

However, as the doctors at the Surgery section refused to undergo the CAPD, the patients are advice to do the same at private clinic which cost from Rs. 10,000 to Rs. 20,000. Patients from poor family have to undergo it as it is essential procedure by

spending the huge amount. CMHT a pioneer scheme of the Chief Minister have no meaning if the patients are tortured by the doctors of institution like RIMS. #### SC to hear review pleas on SC/ST verdict on May 3

# Agency New Delhi, April 27

The Supreme Court will hear the Centre's plea seeking review of its judgment on the Scheduled Castes and the Scheduled Tribes (Prevention of Atrocities) Act

(Prevention of Atrochtes) Act (SC/ST Act) on May 3. Attorney General K K Venugopal mentioned the matter for early hearing before a bench comprising Justices A K Goel and Deepak Gupta and said he had already filed his written submission in the

matter. "The last line of your last order says that list the matter after written submission is filed. I have filed my written submission. Four states have also filed review petitions. Please give us a date,"

Venugopal told the bench. Justice Goel said the matter

The government, in its review petition, told the Supreme Court that its March 20 20 verdict will violate Article 21 of the Constitution for the SC/ST communities and sought restoration of the provisions of the Act.

The apex court had on March 20 said that on "several occasions", innocent citizens were being termed as accused and public servants deterred from performing their duties, which was never the which was never the intention of the legislature while enacting the SC/ST Act.

Hasin Jahan, estranged wife of Indian cricket team pacer Mohammed Shami, has made yet another allegation against the cricketer and his family. saying that her case is similar to that of Kathua rape case, which rocked India

Jahan was participating in a protest march to condemn the horrific Kathua rape case, where an eight-year-old girl was raped and killed in the state of Jammu and Kashmir. "Those who are guilty of th

crime should be punished. Even my case is similar to this. But I am alive. Even I have been subjected to what happened in that case," said Jahan earlier this week during the protest.

ney had planned to rape me kill me and then dump my body in a forest. It's been almost two months that I am fighting against all this," she added. Shami had taken the cricketing world by storm in last month as she accused Shami of having extra-marital affairs. She took to her Facebook to

share the photos of cricketer's alleged WhatsApp and Facebook Messenger chats

with several women. Jahan later claimed that Shami's mother and brother tortured her and tried to kill her and Shami, on his return from India's tour to South Africa, beat her. She went on to claim that Shami wanted her to have physical relations with his brother.

While Shami had denied all the allegations, he was interrogated by Kolkata police earlier this month after Jahan filed a written complaint against the cricketer. An FIR was lodged against Shami and his four family members in Kolkata's Jadavpur police station under several Indian Penal Code (IPC) sections including section 498A, which amounts to cruelty to a woman by her husband or his

relatives. Jahan filed a case at the Alipore court against the Team India pacer, demanding Rs 15 lakh as maintenance charges for her and her daughter Aairah.

A division bench, comprising Justices K K Sasidharan and R Subramanian, had reserved the order on April 24 on the the order on April 24 on the plea by Nalini, challenging the order of a single judge rejecting her prayer for premature release under a 1994 state government scheme

for release under Article 161 (powers of Governor to grant pardon). In a February 22, 2014 representation to the state government, Nalini had sought premature release under the

premature release under the 1994 scheme and had later moved the court. The state government had opposed the plea citing pendency of a similar matter in the Supreme Court then. Following this, the single judge had asked it to consider the representation subject to the outcome of the apex court

The Supreme Court had in its March 2016 order made it clear that for premature release pleas

HC rejects Rajiv case convict's plea under CrPc Section 435, concurrence of the Centre was required in cases handled by central agencies such as the

CBI Upholding the single judge's order, the division bench said Nalini will have to wait for the outcome of the matter pending before the Supreme Court, and dismissed her appeal. "The bench is in full

agreement with the views expressed by the learned single judge," the bench said. During arguments before the bench, Nalini's counsel Radhakrishnan said the apex court order was nowhere connected with the present case as his client had sought premature release under Article 161.
