## Pakistan caught in quicksand, may be blacklisted by global terrorist financing watchdog by June

Agency Islamabad, Feb. 26: Pakistan's luck might soon run out as it continues to support and finance terrorist nisations and individuals. Days after receiving the temporary relief of being put on the 'grey list', Pakistan is likely to be blacklisted by the global money-laundering watchdog in next four months.

Pakistan may find itself on the blacklist of a global financial watchdog if it does not prepare a comprehensive action plan to eradicate terrorist financing by June. reported the country's national daily Dawn.

Last week. Pakistan received a temporary reprieve after the 37-nation Financial Action Task Force (FATF) put the nation on its 'grey list' instead of a blacklist. The anti-money-laundering monitoring group maintains grey and black lists for identifying countries with weak measures to combat money

laundering and terror financing.
Pakistan is yet to work out the proposed plan with the FATF, which is why it's not on the list yet.
"Between now and June, Pakistan will

have to work out the details of the evaluation process with the FATF and

a failure to do so could trigger another process, which may push Pakistan on the blacklist of wilful violators," said the article.

US, along with its European allies which includes UK, Germany and France – nominated Pakistan to be put on Financial Action Task Force's (FATF's) list in mid-February. Last week, China, Turkey, and the Gulf Cooperation Council (GCC) - who had initially been opposing the US-led move against Pakistan - also dropped

move against Pakistan – also dropped their opposition. Unhappy with Pakistan's attitude to terrorism, the United States froze a \$2 billion military aide in January 2018. US President Donald Trump accused Pakistan of giving nothing to the US but "lies and deceit" and providing "safe haven" to terrorists in return for \$33 billion aid over the last 15 years. US openly blamed Pakistan for sheltering Mumbai attack mastermind Hafiz Saeed – a globally designated terrorist who co-founded Lashkar-e-Toiba and is the chief of Jamaat-ud-

Being on FATF's blacklist will mean a serious impact on Pakistan's economy, with a risk of being downgraded by lenders such as IMF, World Bank and ADB

# Conservative rural politician sworn in as Australia's New **Deputy Prime Minister**

Agency Sydney, Feb. 26: A conservative rural politician who once expressed strong anti-gay views was Monday chosen to replace scandal-plagued Barnaby Joyce as Australia's deputy prime minister after he resigned over an affair with his now-pregnant aide.

Michael McCormack, 53, was chosen

by the Nationals — the junior partner in the governing Liberal-National coalition - to take over as leader and deputy PM in an internal party

"We are the party for small business and farmers and we want to make sure that continues and that can only continue with a close relationship with the Liberals," McCormack told reporters in Canberra after winning

'Look forward to having a good discussion with (Prime Minister and Liberals leader) Malcolm Turnbull in a few moments," he added.

McCormack, who had been the veterans' affairs minister was sworn in as deputy PM and infrastructure shortly after his appointment

He was widely expected to win the leadership role after other Nationals MPs withdrew from the race.

Mayerick Queensland MP George Christensen launched a late bid for the leadership, but was defeated. The vote count was not released. McCormack is not as well-known as Joyce, who made international headlines for threatening to euthanise Hollywood star Johnny Depp's dogs over a quarantine

hands as the Liberal and National parties seek to repair their relationship after the Joyce scandal.

Tensions between the two parties rose after 50-year-old Joyce's affair with ex-staffer Vikki Campion, 33, was splashed across the frontpage

of Sydney's Daily Telegraph in early

February.
Revelations about the affair and allegations that Joyce breached ministerial rules made daily headlines, prompting Turnbull to harshly criticise his deputy's behaviour and impose a formal ban on sex between ministers and their staff.

Joyce in turn slammed Turnbull's comments as "inept" and initially refused to step down, before resigning Friday after a separate sexual harassment complaint was lodged against him. He denied the

Turnbull welcomed McCormack's appointment, saying he expected the more than 70-year coalition between the two parties would continue under his leadership. The coalition has endured a

tumultuous few months, with the scandal coming on the heels of a dual citizenship crisis that involved some of its lawmakers, including Jovce, and threatened its wafer-thin

parliamentary majority.

McCormack, first elected to the lower House of Representatives in 2010 representing the rural region of Riverina in southwest New South Wales state, is not without

controversy.

More than two decades ago as a local newspaper editor he wrote a column in which he described homosexuality as "sordid behaviour".

In August, as he oversaw a voluntary nationwide postal vote on same-sex marriage as the minister in charge of the government agency running the poll, he "apologised wholeheartedly for the comments at the time".

McCormack later voted in parliament in support of amending the Marriage Act to legalise gay

## OBC fraud: CBI registers Rs 109 crore loan default case against CMD of Simbhaoli Sugars

New Delhi, Feb. 26: The Central Bureau of Investigation has filed a case against Bombay Stock Exchange listed-Simbhaoli Sugars Limited, one of the largest sugar refining companies-for allegedly cheating Oriental Bank of Commerce (OBC) of Rs 109 crore in 2011 on the pretext of financing sugarcane

Among those named by CBI in its FIR include Simbhaoli Sugar's Chairman and Managing Director Gurmit Singh Mann, Deputy Managing Director Gurpal Singh and eight others including CFO, executive and non-executive directors of the company apart from unknown officials of the public sector bank. The bank and CBI have claimed that Gurpal Singh is Deputy MD of the company while Simbhaoli's website claims he is a Director.

One of the senior management executives of the company is said to be related to a top political leader in Punjab

This is the second FIR in three days registered by CBI+ on the complaint of OBC pertaining to bank fraud. Earlier, as first reported by TOI, CBI filed a case to probe Rs 390 crore fraud committed with OBC by Karol Bagh based Dwarka Das Seth International diamond trader Sabhya Seth and associates.

Once again, like Dwarka Das fraud. CBI did not act on OBC's complaint for three months in Simbhaoli's fraud even though the bank approached the central agency asking to register a case on November 17, 2017. Earlier, CBI sat on OBC's complaint in Dwarka Das case for six months.

In the latest FIR, CBI has alleged that

Oriental Bank of Commerce sanctioned a loan amounting to Rs

148.59 crore to Simbhaoli Sugars in December 2011 after the company approached it with a proposal for financing sugarcane farmers under the tie-up arrangement with the company (with a maximum limit of Rs 3 lakh

per farmer).
The company supplied to the bank the names of individual farmers' along with their details of land holding and cane supplied by them in the previous season. It was also supposed to submit the KYC and other requisite documents along with the loan application of individual farmers.
The bank's Hapur branch

disbursed loans to 5,762 farmers between January and March 2012 totalling Rs 148.59 crore. The loans were disbursed through individual loan accounts opened for farmers and consolidated amount of each disbursement was credited in the Escrow (current) account of Simbhaoli Sugars on the basis of undertaking given by the company that inputs like seed, fertilizers and other necessary equipments etc have been supplied by it to all the individual farmers.

It turned out that Simbhaoli issued improper KYC certificates in the names of farmers. The company transferred diverted the funds from the Escrow account to other accounts maintained by it with SBI, Puniab National Bank and UCO Bank through RTGS. This way, OBC claimed, Simbhaoli Sugars has misappropriated the money lent by it and "there is clear cut division of funds".

The loan account of Rs 148.59 crore was declared non-performing asset (NPA) in March 2015 and a fraud in May 2015 for an outstanding amount of Rs 97.85 crore.
