The RBI has decided that its offices and all designated branches of agency banks conducting government banking will keep their counters open up to 8.00 p.m. tomorrow for greater convenience to taxpayers. Electronic transactions can be also done till midnight tomorrow. In order to facilitate

Government receipts and payments, necessary arrangements have been made to conduct special clearing

Centralised payment systems, such as the RTGS and NEFT, will also be operational with the extended business hours. The RBI adds that Monday has been declared as a holiday to enable banks to close their yearly accounts, but RBI offices will work on that date. However, centralised payment systems, such as RTGS and NEFT, will not be operational. Meanwhile, state government had cancelled its earlier order which announced full time working hour for government employees on Good Friday. Late at evening issued by the government said that only employees in the Finance section and those related to bank will have to work full working hours while the rest of the employees will enjoy the holiday. Echoing views from other cities, students here were terribly miffed they were being made to suffer because of the board's carelessness. Students in Kochi were also completely anguished upon hearing about the board's decision. Looking forward to their vacations, their holiday plans are now hostage to the

board's announcement. Students in Mumbai are upset since the wait for a new exam timetable will force many to cancel their vacation plans and it will also eat into preparation schedules for competitive examinations.

Dama Vaiphei of Lingsiphai village, from their worksite located at Nabil Khuman Village, Churachandpur district, during the intervening night of March 25-26, 2018. According to reliable sources,

the efforts of the contractor and family members of the kidnapped workers to secure their safe release has failed to yield any positive results so far though a full three-day have passed since their abduction. The mental and emotional stress, tremendous anguish and agony which the families of the kidnapped persons and the contractor have been forced to go through are bevond

description. The Federation share in the pain and suffering of all concerned, and fervently appeal to the kidnappers to cafely relation safely release Mr. Lalmalsawmlian and Mr. Khuplal without further delay on humanitarian ground. The Federation would also like to appeal to the kidnappers to shun the path of evil, playing with innocent lives, and making a business out of peoples' life, which is a gift of God.

The Federation also note with regret the failure to protect innocent lives and the recurrence of kidnapping for ransom in the district. The security forces are urged to pull up their socks, and if need be, turn heaven and earth to ensure the safe release of the two kidnapped persons and nab the culprits and award befitting punishment as a deterrent for its repetition.
