

## 3 Barrel guns, 1 Activa without document recovered

**Imphal, March 9:** State police today recovered 2 double barrel guns, 1 single barrel gun and a white colour Activa Honda two wheeler vehicle possessed without any valid documents while conducting search operation at Lillong Arapti Maning laikai today morning.

A police source said that the operation was conducted from 4.30 am to 6.45 am today morning by a team of Thoubal police comprising of female personnel under the supervision SDO Thoubal district Police.

A total of 270 male and 200 female were verified during the operation.

The 2 double Barrel guns and the Single Barrel gun as well as the Activa vehicle were recovered from one person identified as Md. Md. Niyamatulla (age abt. 60 years) son of late Md. Amalutula of Lilong Chaobok Mairel Khul. The police source added that the Activa vehicle appeared to be a stolen one. However, it is

yet to be verified. The person along with the seized items were handed over to police station.

## Suicide claims of army man denied by family members ; Demands Justice

**Imphal, March 9:** Suicide claims by authority over the dead of army personnel Lance Naik Yangmi Muyo (34 yrs) has been refuted by the family member.

Talking to media persons at Manipur Press Club, Majorkhul this afternoon, wife of the deceased jawan expressed suspicion to the way her husband died.

"No notice was sought to the family member's of Lance Naik Yangmi Muyo about the incident which occurred on January 18,

2017 between 10am to 11 am by the concern army department though the news was pass through by a native known to the family members stating Yangmi Muyo has been hospitalized in serious condition", said Timrawon Muyo , the 29 yrs old lady and wife of the deceased jawan, Yangmi Muyo.

Expressing disappointments over the negligence of the army officials who could have inform the family members about the incident, Timrawon Muyo said that

none were allowed to get near the lifeless body of her husband.

Despite the officials has claim the death of her husband is suicide, it was found out that her husband has been murdered through the received report of post mortem, she added.

Family members had lodged an FIR on January 19, 2018 at Sapomeina Police Station under Senaopati District to find out the truth on the suspicious death of Lance Naik Yangmi Muyo but till date no positive action or

response has been made, even though they decry, the officer who is handling the case viz Kakai, ASI of Sapomeina Police Station won't take up the case stating unreasonable response which is not related with the case, Timrawon Muyo asserts.

Since the case on the suspicious death of Lance Naik Yangmi Muyo remains unsolved and neglected, family members appeals the state government and concern department to look into the matter so that justice can be serve at the earliest and the culprits are made to pay the price of their deeds

by the law of the land, asserts family members.

Mention may be that Lance Naik Yangmi Muyo was serving as Territorial Army at 165 Battalion in Laimakhong in wireless department with three other colleagues (1 tangkhul, 1 Muslim and 1 Kuki) and Lance Naik Yangmi Muyo was found dead at the store room where the four of them were posted with his throat slice three times.

Lance Naik Yangmi Muyo (34 yrs), son of Diamond Muyo of Halang Village in Ukhrul District left behind his wife and a son who is just 3 yrs and 10 months old.

Scholar, editor-publisher, translator, lexicographer, bibliophile, Samik

Bandyopadhyay was the Rabindranath Tagore National Fellow at the School for Arts and Aesthetics, JNU, New Delhi (2015-2017) and Member, Publication Committee, Sangeet Natak Akademi, New Delhi (2016-). He was Visiting Professor, SAA, JNU, New Delhi (2005-2012, 2014); Visiting Professor: ICCR Chair at the Department of Theatre Studies; Freie Universität, Berlin (April-July 2014); Vice-Chairman, National School of Drama (2006-2010); and Member National School of Drama Society (2005-May

2014). He was also Lecturer, Departments of English Literature and Drama, Rabindra Bharati University, Calcutta, 1966-73. Additionally, he was Regional Editor, Oxford University Press, Calcutta, 1973-82, and was Founder-Editor, Seagull Books, 1982-88. More recently he was Founder-Editor, Thema, a small publisher based in Kolkata (estab. 1988). His vast experience includes stints as Producer Emeritus, All India Radio and Doordarshan, 1989-92.

Research Professor, Asiatic Society, Calcutta, 1995-97; Member, General Council, Sangeet Natak Akademi (2 consecutive terms) and Central Board of Film Certification (1970-80); Member, 14-Member Indian Delegation to the East-West Theatre Seminar organized by the International Theatre Institute, New Delhi 1966; Panelist at seminars on Indian Theatre as part of Festivals of India in USSR (Tashkent 1987) and Germany (Berlin 1992). The lecture will follow with the famous Manipuri Ras Leela Dance.

## KCP refutes IUCB clarifications

**Imphal, March 9:** Armed rebel group Kangleipak Communist Party (KCP) while refuting the clarification by G. Tharaksana Devi, General Manager of Imphal Urban Co-operative Bank (IUCB) and Ng. Priyogopal Singh, Manager Banking of the said bank in a press conference held on March 7 said that the clarification is nothing but to conceal their misdeed. In a press statement signed by Member in charge of Information and publicity, the outfit said that the ban by RBI was not mainly due to the rise

in the Non-Performing Asset. But the major reason was because of the meeting of the TAFUCB (Task Force Co-operative Urban Bank) which resolved to keep the IUCB under SAF (Supervision Action Framework) following the rating of 'D' on CAMELS (Capital Asset Manager Earning Liquidity System) in the RBI inspection report. Reminding the misappropriation by GM Tharaksana and Manager Banking Ng. Priyogopal, the KCP said that the two persons - in violation of the SLR (Statutory Liquidity

Ratio) under the RBI Investment rules had invested the Security Purchase and Sales Investment. Following this, a 3 member committee headed by A Somorendro as Chairman conducted an enquiry and as per the finding both were put under suspension. The statement also stated on how the two had misappropriated the bank money in violation of the RBI regulations. When the mode of punishment have been under consideration, an appeal for reinvestigation of the case was received.

Meanwhile, GM retirement was on Feb 28, 2018 and taking advantage of this the GM suspension was revoked. Without clearing the Pay, Pension and Gratuity, Tharaksana was restored to her post. But in contrast to the decision which said that all necessary payment related to Tharaksana will be made after departmental enquiry by an expert committee, the ban against her has also been revoked by concealing the misdeed by using RCS. The statement said that the clarification by the two is seriously noted by the KCP and said the outfit will not keep silence into the matter.

## Maoist warns Chatholic Schools for standing against indigenous people

**Imphal, March 9:** Armed rebel group Maoist Communist Party Manipur has warned the Catholic schools in the state for their stand against the indigenous people of the state. In a statement, the outfit said that the Catholic schools are trying to avoid participation of the indigenous people in the school administration so that the administration can be done by the non-Manipuris. Maoist said such a stand is against the interest of the indigenous people of the state. It said, the Maoist never interfere to the religious activities of the Catholic missionaries but cannot accept administration of the Catholic Schools without the participation of the indigenous people. The rebel group also blamed the Nirmalabas, Little Flower and St. Joshep Schools in Imphal for collecting huge amount of money in the name of admission. "These 3 schools (Nirmalabas, LFS and St.

Joshep) selected only about 100 students on lottery for new admission and allowed other 200 on quotas to CSOs and others who came through the Bishop. The CSOs were allowed only 2 seat each", the statement said. On the other hand the Maoist statement said that admission fee for the Catholic School Canchipur is only Rs. 3600 but Nirmalabas, LFS and St. Joshep took nearly Rs. 6000 as admission fee per student. The Maoist said that it had already warned regarding the rampant corruption on admission and also negligence to indigenous people 10 days back. As no positive response is being received from the school authority the outfit will take a decision in consultation with the indigenous people of the state on what action should be taken up. The outfit further said any unwanted consequences should be the responsibility of the Bishops who had come from outside the state.
