N. Biren terms NSCN-IM's 3 state formula as an impossible dream

IT News Imphal, Oct 17: Reacting to Imphal Times news report about NSCN-IM proposal for 3 states formula in Naga areas, MLA N Biren today said that the dream of the NSCN-IM will never be

possible.
"They can put up any demand but the question is whether it will be accepted or not, 3 state formula as mentioned in this newspaper is the demand of the NSCN-IM but it is impossible", Biren said. Giving reason on why it is not possible. Biren said that and the allegations by the NSCN-IM about the division among Naga is 100% wrong. "When Manipur was not

merged to the Indian Union Mao, Tamenglong, Ukhrul etc. were all parts of the erstwhile kingdom however upto Mao it was Maipur North, and Ukhrul as Manipur east but a Tangkhul politician had had converted the region into districts based communal line", Biren said. He further added that there were no issues between Manipur and Nagaland.

by either India or the British The journalist turn politician, who is now an MLA in the Manipur Legislative Assembly also said that When British restored Independence to Manipur on August 14, 1947, the territorial council of the free Manipur consist of Tangkhul, Mao and other communities.

'The main agenda of the NSCN-IM is to disintegrate Manipur, but the attempt will never be succeeded as long as a single Manipuri survive", the bold MLA reiterated.

Biren also said that NSCN-IM do not represent all the

The office is temporarily open at the office bungalow of the Chairman of the Hill Area Committee Manipur until the construction of the permanent building is completed at Mantripukhri where the state government has allotted 5 acres of land. "As the Naga political issue has entered a new phase after signing of the Framework Agreement on August 3 by the Government of India and the NSCN(IM),

we are badly in need of unity at this crucial time, if the Framework Agreement is to translate into a conclusive and peaceful resolution of the Naga political issue," Zeliang said during a function here.

The DAN government has adopted a state logo that has the word Unity in it, the Chief Minister said.

Leaders of political parties, church, tribes and Naga nationalist groups would

have to address the needs of the situation and unite forgetting their differences for the sake of the present and future generation of the Nagas, he said.
"This is not the time to

criticise but a time to think seriously what is good," he said while calling upon all to step forward to put the talk into action and decide which direction Nagas should walk. Zeliang said youths would have to be roped in if the movement is to make a meaningful and significant impact.
"I would like to see young

leaders arise in Nagaland, who should set new agendas of social change through the process of changing our mindset," the CM said. Naga Mothers Association

Manipur is yet to implement 99% of provisions under People With Disability (PWD) Act 1995

IT News Imphal, Oct.17: Manipur is yet to implement 99% of provisions under People With Disability (PWD) Act 1995 which defines Equal Opportunities, Protection of Rights and Full Participation Act. said L.Nabakishwar Singh, IAS, The State Commissioner for the Persons with Disabilities,

Attaining the opening ceremony of the 8th Fortnight Barrier Free Campaign 2015 today held at Manipur Press Club, Imphal, Nabakishor said section 44,45,46 of PWD Act 1995 clearly states that, there should be (1) adaptation of Universal Design in transport system like Bus, Railways, Aircrafts, (2) ramps in public

buildings including Hospitals, banks and Hospitals, banks and Schools, Institution, market shade etc. (3) Causing curb cuts and slopes to be made in pavements for the easy access of wheel chair users (4) Braille symbols and auditory signals in elevators or lifts and installation of auditory signals at red lights in the public roads (5) in the public roads (5) engraving on the surface of the zebra crossing for the blind or for persons with low vision and (6) Pasting

Symbols at proper places. However, he said regarding the effective implementation of the provisions the state, he has written letters to the concern departments including transport and medical, but no positive report has come so far. Imphal Municipal Corporation (IMC) too has written clearly in their bye laws regarding the provisions for PWD, but he said it still remains a matter of discussion. In Manipur, 99% of the provisions under the act still fail to be implemented, he added.

He further said, PWDs will able to be free from barriers only when the facilities under the Act are implemented effectively.

MLA Biren asks Neiphio Rio to study before making comment on ILPS issue

Imphal, Oct 17: Member of Manipur Legislative Assembly, Nongthombam Biren has questioned the authority of Nagaland MP, Neiphio Rio and Chief Minister of Mizoram, Lal Thanhawla who are urging the Government of India not to give consent to the

nent came after Neiphio Rio recently justifies about his letter to Prime Minister of India urging the government of India not to give its consent to the bills as it reportedly against the welfare, desire and will of the tribal people.

While requesting the MP of Nagaland and Chief Minister of Mizoram to mind their own business rather than to be a part in the division of Manipur, N Biren also asked their (Neiphio Rio and other politicians from Nagaland and Mizoram) problems in introducing permit system for non-Manipuri people in Manipur on lines with other three northeastern states-

unachal Pradesh, Mizoram and Nagaland where ILPS was already implemented to protect their land and people from the alleged looming threats posed by large scale non-local migrants. He also urged the MP of Nagaland to study the Bills

thoroughly before making any comments as their unsolicited remarks might add fuel to communal tension and divide the state of Manipur in communal

After yearlong protests under the leadership of Joint Action Committee on Inner Line Permit System (JCILPS), the Manipur Assembly had passed the three Bills- The Protection of Manipur People's - 2015; Manipur Land Revenues and Land Reforms Bill (MLR & LR) (Seventh Amendment) - 2015, and The Manipur Shops and Establishments Bills (Second

Amendment)-2015 on August 31, 2015. However, soon after the bills were passed some tribal organisations opposed Bills with the apprehension

that the "Anti-tribal Bills" would undermine the existing land ownership pattern in hill areas and majority community-Meitei would grab their lands. In an exclusive interview with this reporter of Nelive at his Majorkhun official residence, N Biren, who is also a member of drafting committee of ILPS Bills clarified that there is no question of argument over the Bill (MLR & R) as it is an amendment to the existing undisputed MLR & LR Bill. In consultation with legal experts, the bills were amended "within the scope of the Bills and relevant to the subject matter of the clause to which it relates" as per the Rules of Procedure and Conduct of Busines

"There is no inconsistency with the existing MLR & LR which is currently in force in Manipur and two other Bills. However, if any human errors are detected and found to be stand against any section of the indigenous people of Manipur, the state government is ready to call back the Bills," the MLA retorted.

The hills areas in Manipur are protected under Article 371 (C) as Scheduled Land under which no one could settle at the specified areas except by the scheduled tribes of the state. The objective of the Bills is to protect the land and people of the state from the unchecked influx of non-Manipuri and safeguard the holistic interest of the indigenous people. "Since it does not affect the interest of the any

community of the state, there was no room for consulting Hill area development committee at the time of amending the MLR & LR Bill. While Any Bill should be prospective and not retrospective," the MLA

Condemning the recent unrest at Churachandpur district and death of civilians during anti-ILPS Bills protest demonstrations, the MLA also said that such rumours spread out by political leaders and som section of the society misled the people that led t instigation of public uproar against the Bills.
