

Trump mocks Indian call center, but says India a great nation

Washington, April 23: Republican

presidential front runner Donald Trump has used fake Indian accent to mock a call center representative in India.

as a great place, asserting that he is not angry with Indian leaders. The billionaire from New York said

that he called up his credit card company to find out whether their customer support is based in the US or overseas

"Guess what, you're talking to a person from India. How the hell does that work?" he told his

supporters in Delaware. "So I called up, under the guise I'm checking on my card, I said, 'Where are you from?'" Trump said and then he copied the response from the call center in a fake Indian

accent.
"We are from India," Trump impersonated the response.
"Oh great, that's wonderful," he said

as he pretended to hang up the phone. "India is great place. I am not upset

with other leaders.

I am upset with our leaders for being

so stupid," he said.
"I am not angry with China. I am not angry at Japan. I am not angry with Vietnam, India...all these countries.' Trump mentioned the fake call to India during his remarks on what he described as "crooked banking." Delaware, is a hub for the America s banking and credit- card industry.

'They are making a lot of money," he said.
"You can't allow policies that allows

China, Mexico, Japan, Vietnam, India. Our jobs are being taken. We are losing at every front. There is nothing good. Our country does not win anymore. The jobs are being stripped. Factories are closing. We are not going to let this happen anymore," he said.

Trump said he has as many as 378 companies registered in Delaware, where the Republican presidential primaries is scheduled on April 26 along with several other states

He is leading in polls against his other primary rivals.

In his speech, Trump praised Delaware's status as a tax shelter and slammed President Barack Obama for not using the term "radical Islamists" in the fight against terrorism.

"I want to run against crooked Hillary," he said, reiterating that a Trump vs Clinton race would bring the greatest turn out in the history of the American elections.

"We will stomp on Hillary Clinton no one s ever done."

He was also critical of Indian-American South Carolina Governor Nikki Haley, who did not endorse him during the primary.

Delaware has 16 delegates. Trump nas 845 delegates, followed by Cruz (559) and John Kasich (148).

President's rule is back in Uttarakhand

Uttarakhand, April 23: The National

Democratic Alliance (NDA) government at the centre got a breather on Friday after the Supreme Court brought back President's rule in Uttarakhand by staying a state high court order delivered a day earlier

The high court had on Thursday set aside the presidential proclamation in the state and reinstated the Harish Rawat-led Congress government. It also ordered a floor test on 29 April enabling the government

demonstrate a majority.
"It is directed that the judgement of the high court remains in abeyance till 27 April 2016... the Union of India shall not take any action to revoke presidential proclamation till the next date of hearing," the apex court's order

Attorney general Mukul Rohatgi assured the court that no action will be taken to revoke President's rule in the state to allow formation of a new government.

The bench comprising justices Dipak Misra and Shiva Kirti Singh also directed the high court to make its order available to all parties by 26

April.
The Supreme Court's order prolongs the political uncertainty in the state, which was thrown into a crisis after a rebellion by nine Congress MLAs emboldened the opposition Bharatiya Janata Party (BJP) to approach governor Krishan Kant Paul and stake its claim to forming a

Suspected Islamist militants kill Bangladesh teacher - police

Dhaka, April 23: Suspected Islamist militants brutally murdered a university professor on Saturday in northwestern Bangladesh, a police official told reporters, the latest in a spate of attacks on liberal activists. Two or three assailants rode up on a motorcycle and attacked Rezaul Karim Siddiquee, an English professor at Rajshahi University, slitting his throat and hacking him to death, said police official Golam

Sackline. "We are investigating the killing," Sackline said. The pattern of the murder was similar to other recent attacks by Islamist militants, he said The Muslim-majority nation of 160 million has seen a surge in violent attacks over the past year in which liberal activists, members of minority Muslim sects and other religious groups have been targeted.

Soon after, the nine MLAs were sent notices by speaker Govind Singh Kunjwal, asking them to explain why they should not be disqualified for violating the party's whip and aligning with the BJP. They were subsequently disqualified on 27 March.

The governor scheduled a floor test for 28 March.

A day before, on 27 March, the centre imposed President's rule in the state on grounds of "breakdown of governance"

Earlier on Friday, the central government moved the apex court against Thursday's Uttarakhand high court order quashing President's rule. The nine disqualified MLAs have also

moved the Supreme Court.
Rohatgi and Harish Salve, among a battery of lawyers representing the centre, told the Supreme Court that the high court judgement reinstating the government could not be acted upon in the absence of a copy of the ruling.

Youth charged with abduction and rape of Dalit girl surrenders in Muktsar

Chandigarh, April 23: Nearly a month after a Dalit woman was dragged, abducted and allegedly raped in Muktsar district Punjab, the accused youth surrendered before a court in the

The accused was caught abducting the woman on a CCTV camera installed in a nearby shop in Malout in Muktsar. Muktsar's SSP Gurpreet Singh Gill said on Saturday that the accused youth surrendered before a court in Muktsar and has been remanded to police custody for three days. The woman, a Dalit, was dragged by the youth from a computer centre in Malout in Muktsar. The CCTV footage showed the accused forcibly dragging the woman, said to be in her early 20s, out of her office in broad daylight on March 25. The woman is seen struggling to break free from her alleged abductor, identified as Gurinder, aged around 25.

After abducting her, the accused took her to Tapa Khera village in Muktsar district and allegedly raped her. The SSP said that about five days after the incident, the woman had got an FIR registered in the case after which the police were on a lookout for the accused.
A case had been registered against the accused under various provisions of the law including for abduction and rape against the accused, he said.

Both the accused, who is into farming, and the victim hail from same village in Muktsar district. "He surrendered before a court at Muktsar yesterday and subsequently we took him on remand," Gill told reporters over phone on Saturday. Gill said the car in which the accused had abucted the victim was yet to be recovered.

decorated and properly well set and illuminated as the bout was held in the night time. There were massive outbursts of cheers and non-stop applause when Babu Singh emerged in the Boxing ring. People also looked with awe when Babu Singh's opponent, Ashok Ganguly appeared in the ring. He was slightly taller than Babu Singh. The match was refereed by Captain Harnet, NCC Commander, Manipur and Formerly ADC of Nizam of Hyderabad, Just at the start of the Bout, Ganguly landed him a couple of hard hitting punches. Spectators just simply could not remain seated. They rise up at seeing Babu remaining ineffectual. They shout to cheer and encourage Babu Singh to land Ganguly his fatal left hand blows. They kept seeing hoping that Babu Singh will knock out Ganguly once he unleashes his flurry of left hand shots. They waited till the last and round to see his left hand shot. But without seeing any, Ganguly convincingly defeated him. He was immediately taken at a stretcher to the then District Hospital situated on the north just at a stone's throw distance from Imphal polo Ground. It left the spectators disheartened with disbelief. Many attributed Babu's Singh defeat to the numbness and evil spell casted on him using black magic by the Bengal Boxer, But to Babu Singh's modesty. he admits that they are no match to those who are properly trained availing all the required required infrastructural facilities.

Though Babu Singh was defeated in the first Bout, people waited as there were still two more other Boxers. In the second bout Thokchom Nabakumar from Keishampat Thokchom Leikai ascended the ring to fight with Ajit Banerjee of Bengal. He was knocked out in the first round.

The third and final bout was the turn of Yumnam Tombi of Khagempalli, Imphal to fight with Jambu @ Mohammad Prabhakar, But he didn't turn up. So, Indramani, persuaded Kunjaraj to take Tombi's place. It took Kunjaraj by surprise. But he accepted, thinking it to be the opportunity of showcasing the indomitable spirit and bravery of the Meiteis. In the second round, Kunjaraj could not do much as he was dominated by Mohd. Prabhakar. Kunjaraj could not connect Prabhakar with his punches. Fatigued and left with no option, as his last frantic effort, he

grabbed Prabhakar and floored him down by means of one of the throw technique from the Manipuri traditional wrestling. The referee awarded penalty for his foul play and Kunjaraj eventually surrendered sensing the futility of his effort. Though defeated, the crowd cheered him shouting: "aduni! Tougadabani!nupa haibadudi aduni! Loujakhisanu! Makhoina ngamba sakchakhisanu! Eikhoidi Pelley!", stating that they are satisfied with his performance Though local Boxers suffered defeat in all the three bouts, the proverbial 'Bau Singh gi Oina Leiri' was born that day and it is still very much in use. Babu Singh as police personnel served at various places of Manipur till his retirement as Sub Inspector. After marriage, he was blessed with two daughter and two son. Babu Singh passed away on Friday, 10 September 1999, but the proverbial 'Bau Singh gi Oina' which he gifted is very much alive and still in usage (Translated from Saratchand Thiyam, Warinahouraba Babu Singh Oina, in ed., Saratchand Thiyam, Manipur Amasung Atei Wareng Khara, tr.
