IGTU freezes as students stage protest by shutting down Administrative Block

IT News Imphal, April 6: Normal functioning of the Indira Gandhi tribal University was disrupted today as student body of the university went on protest against the authority's failure to appoint a regular Director. Large number of volunteers of the University gathered in front of the University Administrative block and waited for the concern authority reply to the demand of the students' body. However, as the authority fails

reply to the demands, the students then takes out their books and burnt in front of the Administrative block. Later, the irate student shut the administrative block which is being set up temporarily at Adimjati Campus.

Speaking to the media persons

president of the IGNTUSU Hemkholen Haokip said that the student union has submitted memorandum to the vice chancellor of IGNTU Amarkantak demanding appointment of regular director of the IGNTU-RCM which has

remained vacant more than 3 years. Haokip also said that the student body had also submitted memorandum to shift the campus to Makhan of Sanapati besides appointment of faculty for sociology denartment

Nigerian rapes Manipuri girl; family faces racial slurs in Delhi

Imphal, April 6: A 22-year-old girl from Manipur has been allegedly raped by a Nigerian national in Panchsheel Vihar while attending a birthday party along with three of her friends from Mizoram on the night of 30

According to the complaint, after the Nigerian guy rapped her inside washroom, she fled away into the room. "When I told to my friends, they started thrashing me along with another Nigerian guy. They all beat me up instead of helping," she said tearfully.
"I ran out of the room and

shouted for help. Some locals

called up police and police took us to police station", she added. Complaint has been lodged in Malviva Nagar Police Station. The complaint was taken to Safdarjung hospital for medical test and also produced before the magistrate. A case of rape has been registered. However

no arrest has been made so far. Manipuri Family Faces Racial Slurs In Delhi

Meanwhile, a drunken man claimed to be the landlord's son, suddenly barged into the room of one Manipuri family residing in Vasant Kunj, South Delhi on 31 March 2016 in between 10.30pm-11pm, and started abusing them racially by calling "Chinky", "Manipuri", etc.

After receiving information, NESCH (Media Incharge) rushed to Vasant Kun (North) Police Station and assisted the complaintant in filing FIR at around 2am, according to source.

Police told us you will get the copy of FIR in the morning. When the complaint went, the police told him that the SHO is in Court, come in the evening, said the complainant. But whenever the complaint went, police keep saying the same sort of tactics till today. A copy of FIR has not been received by the complainant.

MUSU blames MU authority for the disruption in recruitment test

Imphal, April 6: While practices in recruitment, Manipur University Students' Union (MUSU) has maintained that the varsity authority is responsible for the disruption of written test for the recruitment of Assistant Registrar post by Assistance
DESAM (Democ (Democratic Manipur) on April 3. In a statement President of

MUSU, Ch Manglemton Meetei said that despite of

restriction from DESAM not to conduct any recruitment till the varsity publicly clarify on corruption charges against the University VC in previous recruitments, the Manipur University conducted the test without listening to the demands of DESAM. Showing the high headedness of the university authority conducted the written test for the recruitment of 4 Assistant Registrar posts on April 3 and the varsity authority is solely responsible for the incident.

He also said that the posts of Assistant Registrar were lying vacant for years. However sudden recruitment notification for the posts and conducting the written test by the incumbent VC, who is going to retire from service after four months, is suspicious.
The President also said that

MUSU always stand against corruption and practices, and it will fight relentlessly and support in steps to save the university campus from corruption and nepotism.

Bamon Leikai locals stage protest against blast at IMC chairman accused by the locals.

Imphal, April 6: Meira paibi's of Brahmapur Aribam Leikai and Mange Makhong today staged a sit-in-protest at Brahmapur Social Club, Bamon Leikai against the bomb attack at the residence of IMC chairperson A Nimai Sharma at

around 9:30 pm of April 4. Speaking to the media person Memton Devi, Secretary of the meira paibi denounced the lobbing of bomb at a residential area terming the attack as unfortunate. Memton appealed to all

concerned group and members

not to repeat such inhuman act in the future and demand the concern authority to take up the case at the earliest

It may be mentioned that two accused were caught by the locals at the night of the blast and were hand over to the Porompat police who rushed at the blast site.
Both the accused

undergoing treatment at Shija hospital, Langol after they sustain serious injury after the locals assaulted them. A gun licence and an ID card of Royal Riders Manipur were recovered from one of the two

injured except for some damage on a residential gate of the neighbouring house and wall of the chairperson's residence. On the other hand, Chairperson of IMC clarifies to the media persons that the family have not received any kind of threat or any monetary demands from underground

organizations.

NSCN (IM) cadre arrested for involvement in attack on Army convoy

National investigating Agency (NIA), Guwahati branch, have arrested a 30-year-old hard-core militant namely Nevton Nokbi alias Leyton.

Levton, a resident of Tirap district of Arunachal Pradesh. was arrested on April 4 for his involvement in the terrorist attack by a group of NSCN cadres for firing and planting near old Tupi village of Tirap district in Arunachal Pradesh, which resulted in death of three injuries to three others.

Leyton is a self-styled Sergeant of the National Council of Nagalim (Issac Muivah faction). The accused, who was

produced before the Special NIA Court at Yupia on April 4, has been remanded to NIA IEDs on a convoy vehicles of the Indian Army on April 2, 2015, police custody for seven days for his custodial interrogation.

'College authourity, police harass NIT Students'

Jammu (J-K) April 6: The students of Srinag National Institute Srinagar's Technology (NIT) on Wednesday accused the college administration and

police of harassing them. The students complained that when they were trying to walk out of the college premises the administration ordered the police to take charge after which the cops ruthlessly baton-charged them.
"The director called on a

meeting with students, there he threatened us and said that if you rake this issue more we will fail you and delay your degrees. At this time, we students got to know about the media presence at the gate of the institution. So, we went to interact with them but were stopped at the gate of the college and then the police baton-charged us. No one was speared, Girls,

handicapped all were beaten by the police," said one of the students

'No one is questioning those who raised anti-national slogans instead we are facing atrocities of the local police and collage administration,' said another student.
Unrest was witnessed again

at NIT campus yesterday after the scene of clash which took place last week, with outstation students expressing a sense of insecurity and attempting to leave the campus, leading to a confrontation with the police in which some were injured. Tension simmered in the NIT campus last week after India lost the World T20 semi-final

to the West Indies.
Some engineering students from outside the state claimed Kashmiri students had chanted anti-India slogans and burst firecrackers after India's defeat.

NIA officer's murder: Sleuths zero in on personal enmity angle

Lucknow, April 6: The Uttar Pradesh police probing the killing of National Investigation Agency (NIA) officer Mohammad Tanzil Ahmed believe personal enmity to be the motive behind the murder on Tuesday, as they released photographs of two unidentified guests at a wedding the cop attended as

prime suspect.
A police officer said the investigation team has important leads and the case night be worked out in a day or two, he said.

Eight teams had been

constituted to work out the murder case. The teams also probed terror aspects, role of fake Indian currency note and narcotics smugglers and hawala traders active in West

"We tried to find out if the terror outfits retaliated with eliminating a proficient officer", said a police officer. He added there was not enough clues to suggest so. The modus operandi of the killer also points toward the personal enmity. The shooter fired 24 rounds mortally injuring Ahmed. The killers did not touch the children and his wife received bullet injury since she was seated on the

Slain NIA officer's wife, who is undergoing treatment in a Noida hospital, is critical but stable. Quashing rumours of her death, authorities at Fortis Hospital in sector 62, Noida, said that her vital parameters are stable and she's being treated in an intensive care

hospital sources said. One of

the bullets has pierced

unit (ICU). Farzana, 40, was brought to Fortis Hospital with four bullet injuries on Sunday. She was hit in her abdomen and leg,

through her intestine, and a lifesaving surgery was performed immediately after she was brought to the hospital emergency. SP, Bijnor, Subhash Singh Baghel, said, "On Monday the

police team scanned the video footage of the wedding but family members failed to identify two persons present in the wedding. Now, one person has been identified as Aarshi, a family friend. The identification of the second person is yet to be established."

During investigation, cops found that Ahmed's family had a property dispute with

villagers. Ahmed had visited his native place, Sahaspur, frequently in recent days. On Tuesday, family members identified one person in the wedding video footage. The second person is yet to be identified. Talking to HT, IGP, Bareilly

Zone, Vijay Singh Meena said: "Police have not released the video footage and photographs of the photographs of the motorcycle-borne people moving on Seohara-Sahaspur highway on Saturday night. They are on job and the case is likely to be worked out soon," he said.
