Mopin festival is a celebration of the harvesting season held in the Galo months of "Lumi" and "Luki". This festival is celebrated by the inhabitants of Arunachal Pradesh as they believe it brings them relief from negative things in life like diseases, calamities, evil spirits and

They believe celebrating Mopin also brings good luck and prosperity along with a good ĥarvest The festival commences with a

ceremony where the people smear rice powder on each other's faces. Since rice is their staple food, this is considered a holv ritual by the Galo people.

'The Galo tribe of Arunachal Pradesh celebrates Mopin festival in every corner of Arunachal Pradesh with great fervor. The significance of this day is that in our life we can at least celebrate such Jayanti and we are fortunate

enough," said a local. "Mopin festival has become a cultural identity for the Galo tribe. Such festival has been celebrated

since age-old tradition," he added. Mopin festival is marked by young girls and boys dancing. They perform a special form of dance called 'Popir'. The young girls wear traditional white attire and

put on colorful headgear. They also wear multi-coloured beaded ornaments. The dancers

engage in rhythmic dance steps on folk songs.

"This festival reminds me and us of our responsibilities to preserve this culture because if you lost your identity everything is lost. The world today is fighting for identity," he said.

Barack Obama arrives in UK with royal lunch, Brexit on the menu

London, April 22: US President Barack Obama has arrived in Britain, where he is set to wade into the poisonous Brexit debate and have lunch with Queen Elizabeth II. Air Force One touched down at London Stansted Airport, northeast of the British capital, at around 9:45 pm (local time), beginning what is Obama's fifth and likely final presidential visit to the kingdom. The president, along with First Lady Michelle Obama, will pay tribute to the queen, who turned 90 yesterday,

when they meet at Windsor Castle, west of London. "The president has very much enjoyed his engagements with the queen over the years," said top Obama foreign policy aide Ben

Rhodes. The queen has reigned since 1952, during which time she has met with a string of US presidents from Harry Truman to Obama, who leaves office in The popular monarch has little

influence on politics despite her role as head of state, but over the decades she has been a figurehead and ballast for Britons navigating imperial decline, the Cold War and

China seething after India issues visa to Uyghur 'terrorist' population and government forces. Exiled Uyghur activists Beijing, April 22: Beijing has China Dharamsala-based Tibetan

reacted angrily after India granted a visa to a Germany-based a visa to a Germany-based Uyghur activist, branded a terrorist by the Chinese government, to attend a conference on democracy in Dharamsala later this month.

Munich-based Dolkun Isa, from the World Uyghur Congress (WUC), has been accused of terrorism and conspiracy to kill people in Xinjiang in China's remote northwest. The WUC is a grouping of the Uyghur community outside China.

The moves comes against the backdrop of China blocking an Indian bid to sanction Pakistan-based Masood Azhar, the head of the banned Jaish-e-Mohammed. at the UN Security Council. China imposed a "technical hold" on the move, saying more information is needed on the matter.

"Dolkun Isa is a terrorist on red notice of Interpol and the Chinese police. Bringing him to justice is a due obligation of relevant countries," China's foreign ministry told Hindustan Times in an emailed response late on Thursday. The brief reaction was couched

in diplomatic language but reflected Beijing's anger. The conference to which Dolkun

Isa has been invited will be held between April 28 and May 1at Dharamsala, the seat of the Tibetan government-in-exile, and this has added to Beijing's
