## Dr. Najma A. Heptulla sworn in as governor of Manipur

Imphal, Aug 21: Dr. Najma A. Heptulla was sworn in as the Governor of Manipur on Sunday. Acting Chief Justice of the High Court of Manipur Shri Justice Rakesh Ranjan Prasad administered the oath of office and secrecy to Dr. Najma A. Heptulla at a ceremony held at the Darbar hall of Raj Bhavan. Imphal. She is the 18th Governor of Manipur.

The ceremony was attended by Chief Minister Shri Okram Ibobi Singh, Speaker, Shri Th. Lokeshwar Singh, Deputy Chief Minister Shri Gaikhangam, Ministers, Lok Sabha MP's Dr. Th. Meinya and Shri Thangso Baite, Rajya Sabha MP, Smt. M.C. Mary Kom, MLA's, Chief Secretary. Director General of Police, and other senior officials of the state government, police, Army and Senior citizens.

Soon after the swearing-in-ceremony the Governor also inspected a guard of honour. In an interaction with media persons, the Governor said

"my first priority even before taking the oath as Governor of Manipur is to work for the people. Manipur is many many miles away from Delhi, but they are not far away from our hearts. I will be working for the development of Manipur State. I would like to first what are the priorities for the people of Manipur. Manipur is so rich in culture so, I would spread to the rest of the country". People should know about Manipur, she added. Dr. Najma A. Heptulla, who

resigned as a Union minister last month, was appointed as the Governor of Manipur on Wednesday. She received her Doctorate in Zoology (Avian Hearts) at the young age of 22. She also worked in the scientists' pool of the Council of Scientific & Industrial Research (CSIR), Government

Dr Nazma Heptuuallh is also a former vice-president of the Bharatiya Janata Party (BJP), and a five time member of the Rajya Sabha, the Upper House of the Indian

parliament, between 1986 and 2012, and Deputy Chairman of the Rajya Sabha for sixteen years. She was a member representing Rajasthan from July 2004 to July 2010. She was nominated by the BJP for the Rajya Sabha in 2012 from Madhya Pradesh, and assumed her office on 24 April

presidential election held in August 2007 but lost to Hamid Ansari by 233 votes. She took oath as a cabinet minister in the Narendra Modi headed government on 26 May 2014. Heptulla joined Bharatiya Janata Party in

Heptulla's appointment as Manipur governor comes after her resignation from the NDA Union cabinet last month on "age" grounds. The government is believed to have set an unwritten '75-year age bar' for ministers and has kept veterans such as L K Advani and Murli Manohar Joshi out of the cabinet.

Imphal, Aug 21: The KSO General Headquarters has expressed serious concern over the gunfight that occurred at Molcham village

in Henglep sub-division between 2/5 Gorkha Rifles and ZUF cadres. In a press statement the KSO said that the ZUF cadres are using the Kuki villagers as human shield.

"It is being reported that in the course of the gunfight ZUF cadres fled to other Kuki villages in the vicinity and have been holing up inside the villages ever since. This is amounting to using Kuki villagers as human shield at times of gunfight by the ZUF cadres", the statement added. The statement added that the presence of ZUF in the villages has posed a grave situation and threat to the villagers.

It said the Kuki civilians have lost their lives in the past because of ZUF's misdemeanours.

The KSO also cautions all militant groups to refrain from making Kuki villages as battle fronts as enough civilian lives have been lost and that innocent villagers have suffered enough because of them. On the other hand the KSO

appreciated the Gorkha Rifles for restraining by not for restraining by not attacking the militants hiding in the village as it has prevented the warring groups from inflicting heavy civilian

casualties.
The KSO appeals to the Gorkha Rifles to further take all necessary precautionary measures so that the villagers are not subjected to unwarranted suffering during raid and operation.

## Naga businessman mishandled by NSCN(U)

Imphal, Aug 21: Ayoung Naga businessman was reportedly manhandled at gun-point by cadres of NSCN (Unification) for not paying the "yearly tax" to the underground group. The incident took place on Friday at Old Ministers' Hill Kohima, where the Proprietor of Seven Six sustained profuse bleeding after being struck with a pistol by a cadre of NSCN(U) for not paying the yearly collection, said officials of Naga Business Association Kohima (NBAK) in Kohima yesterday. NSCN (U) had reportedly given a demand slip in the name of yearly tax in March this year but in June another worker of the same faction gave a separate demand slip while also

directing that the "yearly tax" should not be paid to the first group. NBAK officials said that the proprietor reportedly paid five thousand rupees to the second group of NSCN(U)

second group of NSCN(U) after negotiations. Nonetheless, three member of the first group of NSCN(U) on Friday barged into the victim's shop and physically assaulted

him while also threatening the workers at gun-point demanding payment of the yearly tax. NBAK while taking serious note of the incident has strongly condemned it and also filed an FIR at South Police Station Kohima demanding appropriate action against the accused cadres of NSCN(U).

#### MARRIAGE- It's Rules and Practices in Meitei Society prohibited in Meitei

In every society, whether primitive or civilized, marriage in much aspect is the most important social institution. Marriage is a socio-religious institution. It is a social contract for the satisfaction of physical, biological, psychological and spiritual needs of Man and Woman leading to the formation of a family. Thus the growth and development as well as the stability of human society depend upon this universal and primary institution. On account of this vital importance, the sanctity and permanence of marriage has been emphasized in most societies and the Meitei Society is not an exception in this regard. The paper tries to present the rules and forms of the marriage system which has been prevailed in Manipur from the very early times. The Meitei concept of marriage implies the sacred and ceremonial union of a man and a woman with due

religious rites. The vernacular term for marriage is "Luhongba" which is a combination of two words, "Lu"

which means "head" in archaic Manipuri and "Hongba"

to solemnize. Hence Luhongba is the ceremonial union of the "Lu" of the man and the woman implying the oneness of their heart and soul rather than the state of their being double. In the long journey of life the Meiteis believed that woman is called oigilamdang (left way) and man Yet Ki lamdans (rightway). Thus Meitei marriage is primarily conceived as lifelong physical and spiritual companionship between the wife and the husband. The Meiteis are generally exogamous



endogamy was found in the early times. Khaba Shokchremba alias Leirenhan the father in law of Panthoibi (now worshipped as the

goddess of Meitei) married Women of his own clan (Panthoibi Khongul, M Chandrasing, P.70, 1973) Actually this endogamous system is society but his practice is prevalent among the members of the hill tribes (T.C. Hodson, The Meitheis, Page 75). Politically, the introduction of the practice of exogamy can broaden and strengthen the power of the clans. Polygamy was also very popular. It was also prevailing custom among the Meitei that as a symbol of success in the war, the victor took the wife of the vanquished, weak rules or chiefs used to offer their daughter to the powerful king. Thus powerful kings had many

wives or queens. Their example was followed by the nobles and well-to-do families and lastly to commor

In Meitei society both in early and present days there are certain taboos and rules connected with the institution of marriage. If anybody breaking the rules was expelled from the common society to Haochongpal or Samupal which were known as loi areas (socially boycotted areas). The important rules to be strictly prohibited in marriage are 1. Yekthoknaba or Putinnaba (belonging to the same clan/kinship) 2) Shairuk tinnaba 3) Pentinaba and 4) Mugnaba.

Yek thoknaba

Marriage within the clan or yek is strictly prohibited. This is a long time honoured custom in the Meitei society. Meitei are socially divided into seven clans known as salais or yeks viz, Ningthouja, Angom Khuman, Luwang, Moirang, Khaba Nganba and Chenglei. Marriage within the same yek is forbidden as it is descended from a common ancestor. So yek thoknaba also known as Pu-tinnaba ( Pu-forefather, tinnaba-same origin ). (Contd. on page 2)
