Imphal, August 30: Police has picked up two MLAs of Bharatiya Janata Party (BJP), K Joykishan and Th Bishorjit from Pangei today morning around 7.30, while a team of BJP members led by the duo stormed at Manipur Police Training Centre, Pangai in their bid to foil the fresh recruitment of Manipur Police constable

Led by the MLAs along with hundreds of BJP workers stormed at the northern gate of police training centre. The situation turned hostile after the agitators and state police forces started skirmishing each other. A team of Manipur Police led by SP of Imphal East rushed at the spot, however as the situation turned more as the situation turned more violent the police resorted to pick up the MLAs. The two MLA are being detained at Porompat police station, according to police source. Meanwhile, a team of 9

## Surrendered militants call 65 hours Bandh from September 2

association, All Manipur Surrender Welfare Association (AMSWA) by surrendered members of 6 proscribe groups UNLF, PLA, KYKL, PULF, UPK and KCP KK Nganba group has called 65 hours general strike/bandh in the entire state of Manipur from 5am of September 2 till 6pm of September 5, 2016 against none fulfillment of the MoU signed with the state government in the year 2011. Speaking to the media persons here at Manipur Press Club, Majorkhul, Kazi Umar, Secretary of AMSWA said that the surrendered militants signed an MoU with the state government for payment of Rs 4000 every month as salary in 2011, but so far the state government has not cleared the agreed amount. Kazi Umar also said that it has

been already 3 years that the surrendered people have not received a single penny from the government side. All together each person has to receive a sum of 3.5 lakh as per the MoU. Kazi Umar further said that

despite already passed the CID and IG scanning process, none of the surrendered had not received any

compensation from the

The 65 hours general strike is being called in protest against the government failure to fulfil their demand.

On the other hand, the surrendered militants also plans an internal meeting to decide the future course of agitation if the government fails to give positive response to the demand of the government.

## Rijiju to take part freedom fighter Rani Gaidinlui's memorial function at Nungkao

Imphal, Aug. 30: Security measures have been tightened in Tamenglong district ahead of the Union Home Minister of State, Kirar Rijiju visit to attend programme in memory of freedom fighter Rani Gaidinlui scheduled to hold tomorrow at Nungkao Village. Source said an advance team

comprising of officials from Union Home Ministry has arrived here in Imphal today to take stock of the situation.

According to a source, the Union Minister is expected to be accompanied by the Additional Private Secretary to Mos(Home), Sonam Gechem Agola. He is expected to arrive Imphal airport at around 9.10 am tomorrow by a special flight of BSF.

From Imphal Tulihal Airport he is expected to fly upto Helipad of 23 AR at Kaimai by Helicopter. From Kaimai he will further proceed to the function site at Nungkao Village by land route and After attending the function, the Minister is expected to reach Imphal Airport around 2.20pm by the same Helicopter from Kamai.
After having lunch at the

Airport, the Minister is expected to leave Imphal at around 3.30pm for Delhi by the special BSF flight. Before leaving Imphal, the Union Minister for State Rijiju will meet state BJP leaders to discuss the prevailing law and order condition of the state.

# NSCN-K claims snatching of weapons from 2<sup>nd</sup> MR personnel; claims attack to army at Arunachal Pradesh

Imphal, Aug 30: Rebel group NSCN-K has claimed responsibility to the snatching of 4 weapons from 2<sup>nd</sup> MR personnel along the national high way 37 in tamenglong district yesterday evening.

In a press statement the NSCN \_K said that the Elite Strike
Unit of Naga Army, NSCN/GPRN on combat patrol detained
several armed security personnel at a bridge near Barak
Sibilong Village at Jiribam-Imphal Highway 37, Tamenlong
District on August 29 around 5 PM.

The statement said after the Naga Army learnt the identities of the personnel as indigenous WSE-Asians from Manipur belonging to 2<sup>nd</sup> MR, they were freed unharmed but the Indian Government supplied weapons were confiscated which included two AK rifles and two Insas rifles along with ammunitions.

"This is a caution to all the ethnic WSE Asians serving in the Indian Security Forces and engaged in activities detrimental to the cause, that action deemed befitting shall



be taken against them henceforth, unless they exercise restraint but continue confrontationist stance in collaboration with Indian Army", the statement added On the other hand, the rebel group also claimed attacked to

Indian Security forces near Rilangkang village under Changlang District of Arunachal Pradesh during wee hours of August 28. The outfit in an emailed to Imphal Times also stated that the Naga army had inflicted heavy casualties and injuries on the side of the Indian Army during the

The statement said that the Assam Rifles were returning to their camp after laying failed ambush on our Army, in a counter-measure, the Naga Army counter-attacked the Assam Rifles with concentrated heavy bombardment with Machine Guns, Sub-Machine Guns, 40 mm grenades, Explosives and

hand grenades for more than one hour.
"The Assam Rifles were pinned down and nearly annihilate but for darkness, later the Naga Army sanitised the area and recovered one night vision goggle, several blood stained first aid-paraphernalia and bloody cotton and bandages strewn all over the spot. Many AR soldiers were heard whining in pain. The foliage and ground were soiled with heavy blood spill", the NSCN-K statement added.
