## CBSTDC demands govt. to do its part before ST Demand movement turns hostile

Imphal, August 19: Amidst Manipur bandh called against the arrest of JCILPS former convenor Kh Ratan, who had been announced as wanted by State Home department, the Coordinating Body on Scheduled Tribe Demand Committee (CBSTDC) has continued their relay sit-in-fast/hunger strike at Wall Club Ground, Wangkhei Angom

Leikai here today. Speaking to Imphal Times, Mutum Churamani, Convenor of CBSTDC said that as part of the ongoing demand for inclusion of Meitei/Meetei in the list of ST category the body will be continuing their relay 12-hours-sit-in-fast till 31 August 2016 at the ground along with different likeminded people and groups, besides organizing public meetings at different locations.

Reiterating the resolutions made during the Public Meeting regarding the inclusion of Meitei/Meetei in the ST category which was held at Iboyaima Shumang Leela Shanglen on May 22, 2016, Churamani said

demanded that Manipur government should take a decision during the upcoming state legislative assembly session and recommend the Ministry of Tribal Affairs to include Meitei/Meetei in the scheduled list of 432 (1) of the Constitution of India.

Since the day one of the demand for inclusion of Meitei/Meetei in the ST list, the CRSTDC hard the CBSTDC has been resorting to only democratic forms of agitations. The body would also organize a mass public rally on 18 September 2016 in the state capital city. Even if, the state government failed to comply with the

demands of the ST demand body, it would be compelled to launch various severe forms of protest demonstration including fast-unto-death, Churamani said, while informing that a team of 10 people about 80 years old is ready to undergo fast-untodeath.

# Assam Gets Hi-Tech Cancer **Detection Machine**

# Guwahati, Aug. 19: Assam Chief Minister Sarbananda

Sonowal inaugurated a Positron Emission Tomography-Computed Positron Tomography (PET-CT) scanner system along with a cyclotron at the Guwahati Medical College and Hospital. giving a much needed boost to Cancer care in the state. The PET-CT scan is a type of nuclear medicine imaging device. Along with the cyclotron, which is a

radioactive isotope making machine, the PET-CT scanner will enable doctors at GMCH to detect hidden cancer cells in the patient's body in the

shortest possible time. Congratulating Health minister Himanta Biswa Sarma and doctors and officials of the GMCH for successfully installing the PET-CT scanner system, Sonowal said that his government had given top priority to improving health and education in the state. Health and Family Welfare minister Himanta Biswa Sarma said that installing such highly-advanced cancer detecting machines would go a long way in making Assam successful in effectively treating and preventing the disease. Sarma claimed that the GMCH and the All India Institute of Medical Sciences (AIIMS) were now the only government-run health institutions in the country to

possess both PET-CT scan and cyclotron machines. Sharma said that the cyclotron can produce the radioactive isotope, fluorodeoxyglucose, which when injected into a patient's body can help the PET-CT scanner detect hidden cancer cells in the patient's body in a very short

period of time, "With an alarming rise in the number of cancer cases in Assam, the BJP-led government soon after taking charge in May decided to install the PET-CT scanner immediately so that cancer could be detected at the earliest, treated, cured and eventually prevented in the state," Sarma said. According to Sarma, the government has several plans in the pipeline to ensure availability of good quality and highly advanced cancer treatment facilities for patients in the state. The 200bed cancer hospital will be functional from October.
