Imphal, Aug 29: Body formed by constable recruitment test for 2013 batch has called 24 hour total bandh in Imphal East district starting from midnight today in protest against the fresh recruitment test scheduled to hold tomorrow at Police Training

Center Pangei.
The 'bandh' called was announced today by Md Zaheer khan, the spokesperson of the constable recruitment appeared candidates at Manipur Press Club to design nipur Press Club today in the presence of other members of the candidates

Speaking to media persons, Md Zaheer khan, while clarifying that the body had no hands in the burning of the government offices recently including the Government Advocate office at old Guwahati High court complex, blamed the state government for putting the blamed to the candidates who are asking their rightful demand.

He further added that if any irregularities has been found during the recruitment process the blamed should be to those conducting the recruitment test and not to the candidates

appearing.

by government official harassed the candidate by sabotaging their career?" Md Zaheer khan asked.

He further added that the recruitment process was conducted along with video recording and front of press media and if candidate who scored 0 mark in written test were called on for interview then whose fault is that, asked the spokespersons.

If any irregularities are found during the process then those responsible for conducting the test should be held responsible and should be awarded appropriate

punishment, he added. He further added that all the member of the constable recruitment appeared body of 2013 batch will not participate the recruitment rally and warn to the state government to declare the result instead of conducting fresh recruitment.

85th Martyr Day of Haipou Jadonang observed

DIPR Imphal, Aug 29: The 85th Martyr Day of Haipou Jadonang was observed today at the Haipou Jadonang Park located at Keisampat in Imphal. The day was observed in commemoration of the hanging of Haipou Jadonang, one of the pioneer freedom fighters of India, by the then colonial Britishers on this day in 1931. The observance of the day was organised by the Haipou Jadonang Statue & Park Development Committee,

Deputy Chief Minister Gaikhangam, who was present at the observance, paid floral tribute to the statue of the legendary freedom fighter. A two-minute silence was also observed as homage to the departed soul of Haipou Jadonang. During the observation, Haipou Jadonang Prayer Hymn was also presented as a dedication to the celebrated freedom fighter.

The observance of the day was also attended by Deputy Mayor of Imphal Municipal

Council Maibon Phaomei. Chairman of Haipou Jadonang Statue & Park Developme Committee, Manipur, Ph Thambaliao and Rajita Golmei. Member, Manipur State Women Commission amidst the presence of several people from the Zeliangrong community.

Born on 10 June 1905 at Kambiron village of the present day Nungba Sub-

Division, Haipou Jadonang grew up as a deeply religious person since his childhood. As he grew up, Jadonang saw the growing influence of Christianity in Naga territory as a sign of foreign imperialism. He considered it a threat to the traditional religion and society of the Nagas. He urged his people to fight for national prestige and social change.

January 1931, the British received reports that Jadonang was planning to declare war against them by the end of that year. They decided to suppress his movement permanently. On 19 February 1931, he was arrested and imprisoned at Silchar, and a month later on 19 March that year, he was brought to Imphal. On 13 June 1931, Jadonang was declared guilty of the murder of four traders at his native village, and subsequently on 29th August, 1931, Jadonang was hanged to death on the bank of the Nambul River, behind the Imphal Jail, at the very place where his statue stands today. Since then, this day has been observed as the Martyr Day of Haipou Jadonang.

India should seize the opportunity to build ties with Myanmar

President U Htin Kvaw comes to India as a guest of Indian President Pranab Mukherjee, who will hold a banquet for the delegation.
The visit follows External

Affairs Minister Sushma Swaraj's one-day trip to Myanmar on August 22, the first high-level official from India to visit since the National League for Democracy (NLD)

came to power in April.
At the time, Myanmar government officials told Ms Swaraj that they would not allow any insurgent group to use Myanmar's territory to attack India

Ms Swaraj's visit took place

st days after the Indian Army had an encounter with militants from the National Socialist Council of Nagaland-Khaplang (NSCN-K) who were allegedly trying to enter the country from Myanmar. There were reports that the Indian army had crossed over to Myanmar to pursue the militants, but this militants, but this was officially denied by New

It will be important for Indian leadership to continue engaging President U Htin Kvaw's administration in substantive talks on cross border security issues.

The timing of the visit is good for both New Delhi and Nay Pyi Taw as the NLD

government holds talks with several ethnic armed groups and prepares for thepivotal Panglong pea conference later this week

Though the NSCN-K is not currently engaged in talks with the Myanmar government, the Modi government could use this

visit to discuss the group. President U Htin Kyaw's visit also comes within a week of State Counsellor Daw Aung San Suu Kyi's own four-day

President Htin Kyaw hold bilateral talks with PM Modi

New Delhi, Aug 29: President of Myanmar U Htin Kyaw hold bilateral talks with Prime Minister Narendra Modi this afternoon in New Delhi. The two leaders discussed a host of issues, including border management and ways to contain militant activities along the Indo-Myanmar border. Both countries share more than 1,600 kilometer

India's concerns has been the presence of insurgent groups along the border. Ways to boost trade ties between the two countries will also be

figured during the talks. Mr Kyaw arrived in New Delhi from Agra yesterday on the last leg of his four day visit to India. Mr Kyaw was accorded ceremonial reception at the forecourts of the Rashtrapati Bhawan this morning. He was received by the President Pranab Mukherjee and Prime Minister Narendra

Mr Kyaw is also scheduled to meet President Pranab Mukherjee and External Affairs Minister Sushma Swaraj and hold discussions on mutual interest. This is the first visit by the Myanmar President after assumption of office by the new government in March visit to China, a traditional rival

During the China visit, the two agreements on economic and technological cooperation that will result in the building of two new hospitals and a strategic bridge in Kunlong, 32 kilometres (20 miles) from the Chinese border in northeastern Myanmar

China is a major trading partner with Myanmar, with total twoway trade amounting to over US\$9.4 billion in the first 10 months of the 2015-16 fiscal year, according to Chinese

In an effort to improve bilateral ties, Myanmar has agreed to review several suspended dam projects backed by China in order to determine a

mutually agreeable solution. The Chinese leadership also assured the state counsellor that Beijing willcontinue to play a constructive role in promoting peaceful settlement of the decades-old armed conflicts in Myanmar.

In light of these developments. India should seize the opportunity of President U Htin Kyaw's visit to strengthen and enhance bilateral relations. In addition to cross-border security issues, there are three specific areas where India should seek to boost ties: the education sector, institution building and people-to-people relations.
