#### Prepaid counter opened; Cease work strike continues

Imphal, Dec 14: While the downed prepaid counters of electricity department has been opened from today, the Manipur electricity employees union (MEEU) still continues their cease work strike demanding their regularization of muster roll and work charged employees of Manipur State Power Distribution Corporation Limited (MSPDCL) at Keisampat.

Speaking to media persons, one of the employees said the union members had already met the Commissioner and discussed their demands and

to which the Commissioner gave them assurance that the matter will be taken up with the Chief Minister personally stating that the demands are legit.
The employee also said that

despite the current unstable situation, the Chief Minister have not given any positive response so far to the union. Instead of a written assurance, verbal assurance has been received which the union consider very unfortunate but will wait for the result, the

employee added. The union threatens to continue the cease work stir at the Corporation complex which began from December 6, 2016, until their demands for service of muster roll and work charged employees is regularized at the earliest.

The union has been demanding the government to regularise the service of muster roll and work charged employees since 2014 whereas the state government has regularised the service of muster roll and work charged employees for some other departments of the state. Manipur State Power

Distribution Corporation Limited has 38 muster roll and work employees.

### Gaidon and Stephen remanded in police custody for 7 more days

IT News Imphal, Dec 14: Police today remanded UNC president Gaidon Kamei and Publicity Secy. Sangkhel Stephen for 7 days in police custody for the second time.

The two were arrested by a team of Manipur police from Pheidingga on November 25 on charge of disrupting traffic at National Highways of the state. Both were produced on December 8 to the court but were re-arrested by Tadubi Police Station in connection with a case registered against them and remanded in police

custody for 14 days. Advocate S Inaobi and Advocate Achamliu Golmei appeared on behalf of them. After being produced to the court the police seek more time for investigation to the court. As per the submission by the police some volunteers or supporters of the UNc which has been enforcing the economic blockade along the national High ways had torch a loaded truck bearing registration number MN-01-9194 near Tadubi at around 6.25 am of November 21. The truck was transporting 600

bags of chicken feeds from Jalpaiguri, Silguri. The truck was set ablaze by 5/5 persons suspected to be supporters / activist of UNC and as they were involved in with full conspiracy of the organization, both Gaidon Kamei and Stephen were highly required in Police custody for further investigation. Following the plea, the Chief

Judicial Magistrate Imphal East granted 7 days remand of both the accused in police custody. The Court directed them to produce before the court on 20/12/2016.

#### BJP conducts signature campaign on demonetization under Wangkhem AC

#### Delhi HC to hear pleas against demonetisation on December 22

New Delhi, Dec 14: Delhi High Court on Wednesday adjourned till December 22 the hearing on pleas challenging demonetisation move after it was informed that the Supreme Court is seized of the matter. As the bench headed by Chief Justice G Rohini did not assemble today, the counsel for the petitioners sought a date after December 15 as the apex court will hear similar is: The court adjourned the matter to December 22. One of the petitioners, Pooja Mahajan, who runs a designer showroom, has questioned the government allowing certain public utilities including hospitals and petrol pumps to use the old notes. In her plea, she has also claimed that the government has taken a dual stand as on the one hand it was encouraging people to deposit old notes in bank accounts and on the other hand, it was threatening them of prosecution for depositing

#### Reviewing Unification Politics of Manipur Nagas through Ethnicisation of Education (2006-2008)

The issue of affiliating schools and colleges in Naga inhabited districts of Manipur to Nagaland Board of School Education and Nagaland University first came into notice as a delegation of All Naga Students Association Manipur (ANSAM) met the Nagaland Chief Minister, SC Jamir to press their demand. It urges to facilitate affiliation of schools and colleges in Naga inhabited districts of Manipur to NBSE and Nagaland University. The representation claimed that 'displaced' Naga students, who left Imphal valley in the wake of the anti-ceasefire students, who left imphal valley in the wake of the anti-ceasetire agitation, failed to pursue their academic career due to the hostile environment compelling the students to take admission in schools and colleges in Nagaland.

The demand for affiliating the schools in the four hill districts of Manipur to NBSE in lieu of the Board of Secondary Education

Manipur (BoSEM) and subsequent replacement of BoSEM textbooks with that of NBSE in Manipur's four hill districts of Chandel, Tamenglong, Ukhrul and Senapati which was being

launched as a part of the non-cooperation movement by a section of the sponsored Nagas in pursuit of its agenda for Naga unification resurfaces in July 2006. In its pursuit, thousands of BoSEM textbooks were confiscated and consigned to flames alleging that syllabi of BoSEM underrate the cultural, social and traditional values of the Nagas. Such a move is very much related with the common Naga aspiration BoSEM text books are allegedly instrumental in subjugating the culture and tradition of Nagas and other ethnic groups of hill districts on the grounds that it amounts to imposition of Meitei culture over other ethnic groups. Naga Students Union. Mettel culture over other etimic groups. Naga Students Union, Chandel (NSUC), Naga Students Federation (NSF), Angami Students Union (ASU), ANSAM, Tangkhul Katamnao Saklong, Zeliangrong Students Union Manipur (ZSUM) were the organizations involved in the burning of books. The Naga organizations involved in the demand for shifting to NBSE affiliation alleged the state government of imposing Meitei script, but it was denied by the Manipur Education Minister stating that pursuing the Manipuri language/ Meitei script by tribal students is optional. In view of the Naga Peoples Conventions (NPC) resolutions of August 8 and 9 in the year 2001 and 4th of November 2005, the movement for affiliation to NBSE and Nagaland University was statedly launched by ANSAM as part of the non-cooperation movement against the 'present state of Manipur' in pursuit of the demand for unification of all Naga homeland. UNC, Naga Womens Union Manipur (NWUM), and Naga Peoples Movement for Human Rights (NPMHR) too supported the pursuit for affiliation to NBSE. UNC, NWUM, NPMHR, and ANSAM issued a press clarification stating it as inevitable to set the record straight to justify the resolute stand of the Naga people for common administration. The joint statement outrightly rejected the allegations that the demand for introducing of NBSE syllabus in the four hill districts was planned by the NSCN-IM as a (Contd. on page 2)
