Counter blockade at Khurai: At Khurai in Imphal East too large number of people stopped vehicles carrying ods towards Ukhrul district Vehicles found with edible items including vegetable were halt and those volunteers pull down whatever found inside the vehicles. A min truck carrying food items for army was also halt and volunteers pulled down the materials. However after army rushed and claimed the items for use of those security forces stationed at Ukhrul district it was let go. NH 37
