

Chaoba lambast state govt for under performance of MGNRES scheme in Manipur

Imphal, Feb 4: The state government celebrated the completion of one decade of MGNRES scheme. While many states in the country have added the number of work days up to the tune of 50 days over the minimum guaranteed 100 days of work and doing successfully for the welfare of the people, in Manipur, however, despite the

guarantee of providing 100 days of work, only 20 to 30 days of actual work is the norm and have never completed even 50 days in a single year during the one and half decade long rule by congress government of Manipur. The above statement was said by president of the BJP Manipur Pradesh Th. Chaoba in a press meet held at its office at Keisampat Nityaapat chuthek today.

He further added that 25 % of the MGNRES funds were misused by the ministers and higher authorities and the state government has never contributed the 10% as required under the scheme. Demanding a white paper of the MGNREGS of the 10 long years from the state

government, he further added that the state government should bear responsibility for non-implementation of Food Security Act in the state. He also disclosed that state government has taken all the ration items at low price from the central government but never distributed to the people.

Under the Modi government Union ministers have been visiting the state every month not as tourists, but to provide funds for the development of the state. However, the union ministers despite their positive intentions failed to provide the funds to the state due to the unsystematic functioning of the state government, a clear example being the central government



having sanctioned for a sports university, the state government has failed to provide the necessary land as they plan to construct it on a disputed area, raising the question about the state government not entertaining the offers from various groups for suitable alternative sites for the same.

Sovakiran demands speedy construction of temporary market shed

Inaction over demand for dam irks Tousem villagers

Imphal, Feb 4: Villagers of Tousem sub-division under Tamenglong District voiced disappointment over state government's failure to fulfill their long-standing demand for a dam project over Chakungtoo stream.

Speaking to the media persons, TR Ringthengning, president of Tousem area village chairman committee said that the state government has failed to take

up a project for water supply which could be conveniently accessed by more than ten villages of Tousem sub-division under Tamenglong district. TR Ringthengning also said that since the development of Tainingang village forests, the running water of Chakungtoo stream has been available the whole year.

More than 10 villages will have access to this water resource if a dam could be

made on the very stream, Ringthengning said, adding that so far the state government has failed to comply with the villagers' wishes despite the submission of memorandum for a project to construct dam on the stream.

Villagers of the Tousem sub-division are working as one to make the water resources available in their villages as the government did not show any interest, he added.

Police officer allegedly slapped a person for enquiring the reason for arrest of his brother

Imphal, Feb 4: At what could be term as another misused of power by state police force, one 2nd OC of Nambol Police station had allegedly slapped a person for enquiring the reason for arrest of his brother. Joy Leikangbam (Aged about 33 years), son of L. Mangi of Nambol Chingmang Bhandier, under Nambol Police station was arrested by a team of Nambol Police as according to a report filed by a neighbour of the accused identified as Sarangthem Sanaton (Age 58 years) on charge of killing a dog at around 10 am yesterday.

In a press conference held today at Manipur Press Club, brother of Joy, Ranjan Leikangbam said that he was slapped by the second OC of



Nambol Police Station for enquiring about the reason for arrest of his brother. He said as he was not at home at the time of his brother's arrest he went to the police station at around 1 pm and enquired about the FIR no. and reason for arrest of his brother joy.

The 2nd OC allegedly mishandled him with defamatory language and

finally slapped him at his face telling him that he did not have any authority to question about the arrest.

Ranjan said he was fainted at the strike and was evacuated to RIMS hospital by members of his family. 3 tooth were seriously affected and is still reported bleeding.

General Secretary of Chingmang Bhandier Meira Paibi, Atom Memton, who was also present in the press meet vehemently condemn the act of the police officer and appealed concerned government department for taking action against the police officer.

On the other hand the dog died after consuming red cake (a pesticide used to kill red) which were spread under the granary store of Joy's family.

War of words continue to haunt MPP

Widow alleges in-law of derogatory remarks and diversion of murder case

Imphal, Feb 4: Tensubam (O) Ibetombi, wife of late Tensubam Premananda @ Taton, along with her maternal family members alleged Wahengbam Sumati (Ekhi), aunty of Premananda for spreading defamatory statements about Ibetombi in the locality and diverting the issue from the actual case.

Yambem (O) Tampha (38), sister-in-law of Ibetombi alleged that one Wahengbam Sumati (Ekhi), aunty of late Premananda who was murdered by his own younger brother Babi (24) on December 20 last has spread derogatory statements about the unfortunate widow. Tensubam Premananda of Takhel mamang laikai under

Imphal East was found dead on December 21 2015. Premananda's own younger brother T Babi (24) admitted to the murder and is now in Saijwa jail and the case is under trial.

Tampha said her family is deeply disappointed with the lack of cooperation from the JAC which was formed against the killing regarding

her sister-in-law's future after her husband was murdered. The family is unhappy in their failure to safeguard Ibetombi's dowry gifts while the mob burnt down the murderer's house, further blaming the aunt for trying to divert the case which is under trial by spreading derogatory statements against her sister-in-law.

CAG examining alleged lottery scam in Mizoram

Aizawl, Feb. 4: The Comptroller and Auditor General of India (CAG) is examining alleged malpractices in the lottery being run by the Mizoram government, officials today said.

The exercise was slated to be completed within two months as important documents had already been collected from the agency, Institutional Finance and State Lottery (IFSL), officials in

the Principal Accountant General's office here said.

Opposition Mizo National Front (MNF) has alleged that crores of rupees were lost annually due to malpractices by government employees.

MNF had also alleged that Chief Minister Lal Thanhawla had accorded undue favour to a lottery agent after overruling the decision of the Mizoram State Lottery Committee (MSLC).

Budget session of Parliament from February 23 till May 13, 2016

New Delhi, Feb. 4: Budget session of Parliament will begin from February 23 and will continue till May 13, 2016 subject to exigencies of Government Business with recess from March 17 till April 24, 2016 to enable the Department Related Standing Committees examine the Budget proposals of different ministries and departments. The details of Budget session schedule were informed by the Minister of Parliamentary Affairs Shri M. Venkaiah Naidu, after the Cabinet Committee on Parliamentary Affairs firmed up the schedule today. Shri Naidu further stated that

the session opens with the Address of President Shri Pranab Mukherjee to the Members of both the Houses at a Joint Sitting in the Central Hall of Parliament on February 23, 2016. Presentation of Railway Budget will be on February 25, Economic Survey the next day and General Budget on February 29, 2016. Budget session will have a total of 31 sittings spread over a total duration of 81 days. Budget session of Parliament this year will run full course with recess in between unlike in 2011 when the recess was done away with on account of Assembly elections in five states that are going to polls this year also. These states are

; Kerala, Tamil Nadu, Puducherry, West Bengal and Assam.

Ministers Shri Rajnath Singh, Shri Arun Jaitley, Shri Venkaiah Naidu, Dr. Najma Heptulla, Shri Ramvilas Paswan, Smt. Smriti Zubin Irani and Shri Mukhtar Abbas Naqvi attended the CCPA meeting.

Before the CCPA meeting Shri M. Venkaiah Naidu, Home Minister Shri Rajnath Singh and Shri Mukhtar Abbas Naqvi, Minister of State for Parliamentary Affairs consulted leaders of different parties seeking their views on scheduling of the Budget session keeping in view the Assembly Polls in five states.

In his opening remarks, Shri Venkaiah Naidu said that the Government favoured a normal and full length session with sufficient recess in between to enable the work of Standing Committees. Shri Naidu said that the dates could be adjusted based on the suggestions of different parties.

CCPA later firmed up the session schedule keeping in view the requirement of Speaker of Lok Sabha and Deputy Chairman of Rajya Sabha to attend the Commonwealth Parliamentary Conference, suggestions from the leaders of various parties and holidays in the month of April, 2016.

Shri Ghulam Nabi Azad, Shri Anand Sharma and Shri Deepender Hooda from the Congress Party, Shri Rangpol Yadav (SP), Shri Sharad Yadav and Shri K.C. Tyagi (JDU), Shri Bhartrihari Mahtab (BJD), Shri Ambeth Rajan (BSP), Shri Derek O'Brien (TMC) and Dr. Venugopal (AIADMK) participated in the consultations with the Government. Ratification of Ordinance relating to President's Rule in Arunachal Pradesh and passing of a Bill in respect of Ordinance regarding Enemy Properties will be taken up on priority during the session.
