## Govt. department turns blind eye to the plights of unfortunate minors

Imphal, Jan.24: It was really

shocking to come across the missing person report of Hijam Somorjit (15), elder brother of Hijam Naobi (12), a hotel-boy based on whom a news article "Interrupted Childhood: need for state intervention and assistance was published on January 15. Two days back when this reporter visited Naobi's locality at Singiamei Wangma Pebiya Pandit Leikai for this follow up story, it was informed that their parents were looking for Somorjit who went missing since a couple of days back. According to localities who do not want to disclose their names, the two brothers were too young to be bread earners of the family. When enquired about their parents, it was informed that Hijam Naba, the father of the two boys is a government pensioner with a known condition of mental instability whose pension book is believed to be mortgaged. Both parents were described to be of ill health and unable to perform any physical work. It was also told that the parents- especially the mother, Hijam Hemabati was the kind of person who is overly superstitious, resorting to rituals to address anv issue

The localities were worried as the younger one has already started eating Talab- packed mixture of betel nuts and worried about their future too. According to them the elder boy was good in study too and they have the enthusiasm for pursuing further studies,

even complaining to their mother for not sending them to school.

The brothers were reportedly disturbed when their mother comes to their work places to take money since they felt it was an embarrassment to them.
There must be innumerable

stories like Naobi's and Somorjit's who were forced into physical labor by circumstances to eke out a living and look after the family at such tender ages.

#### Editors Guild of India condemns threat to Siddharth Varadarajan January 20, 2016. the V-C in his office along with

Imphal, Jan. 24: The Editors Guild of India strongly condemns the blatant acts of intimidation and threats to Siddharth Varadarajan, Editor of The Wire, by student members of the ABVP in Allahabad University that forced the police to intervene to escort him to safety. Varadaraian had been invited to deliver a public lecture on "Democracy, the Media and Freedom of Expression" by the president of the Allahabad University Students' Union at the university's Senate Hall on Varadarajan states that after students belonging to the ABVP threatened violence, the Vice-Chancellor withdrew permission for the programme and got the district administration to prohibit it administration to promibil it frombeing held on campus. The ABVP declared that Varadarajan was "anti-national" and would not be allowed to set foot inside the university campus. Varadarajan was forced to deliver the lecture at a hall near the campus. After the lecture, when Varadarajan went to meet

the students' union president, the ABVP surrounded the exit. The university security warned Varadarajan that they could not guarantee his safety, and it was only after the police arrived that he was escorted to safety. For a senior journalist to be

threatened in such a manner at a leading university is deplorable. It is a brazen attack on freedom of expression, and the Editors Guild of India finds this mob mentality to silence those with divergent views unacceptable.

## Seminar on Conflict and Mental Health in Northeast India

### Root cause of armed conflict in Manipur is due to the dehumanising condition of the Manipuri people – MC Arun

Imphal, Jan 24: A National Seminar on "Conflict and Mental Health In Northeast India" was held on January 23, 2016 at the Conference Hall, Tribal Research Institute, Imphal. The seminar was organised by the Department of Social Work Indira Gandhi National Tribal University (IGNTU), Regional Campus, Manipur and sponsored by ICSSR, New Delhi. Prof. Akshyakumar, Clinical Psychologist, formerly with Department of Clinical Psychology, Regional Institute of Department of Culinical rsychology, Regional institute of Medical Sciences, Imphal and Prof. MC Arm, Director, Centre for Manipur Studies, Manipur University were the Presidium Members of the Inauguration Session of the seminar. Prof. Akshyakumar delivering the keynote address stated that when the armed struggle started in Manipur or Assam,

many people have lost their lives. It is the people who are related to the deceased who suffers. It is them who acquire the problem of mental health. The prevalence of mental health such PTS, anxiety, depression, etc. on account of armed

conflict in Manipur is high. He stressed that what is important is to identify whether people are maintaining mental health. In order to find these out, one has to be aware of the early signs and symptoms such as sleeping hours, allergy, physical pain, feeling of unusually confused, upset, worried and other forms of behavioural changes (including mood fluctuations and persistent thinking about an incident), etc. The person who is suffering from mental health problem may not be able to recognise these early signs. Thus, persons who are close to these people must be of help. He added that mental health problem can develop at any time in the life of a person. Then he spoke about the characteristics of a sound mind. A person with a sound mind can have quality time with his surrounding with a sense of happiness, purpose and security. The opposite are the characteristics of a person with unsound mind and often live under hallucination.

Prof. MC Arun stated that the root cause of armed conflict in Manipur is due to the dehumanising condition of the Manipuri

people. There was contradiction between the minority superiors and the majority inferiors in the state and this gave birth to the phenomenon of insurgency. Initial targets of the insurgents included rapists and corrupted officials including doctors so as to remove the dehumanising condition. At this initial phase, the people gave tacit support But after the 80s, the insurgents have been perceived by the commoners as another oppressor who imposes what to wear and what to speak, etc. Since then, the people are caught in between two oppressors, the State and insurgents, thereby increasing the incidences of mental health. There is a decrease in the intensity of armed conflict but the intensity and incidences of mental health are ever increasing. Prof. MC Arun cautioned that these understandings largely remain hypothetical. Therefore, proper study to document the evalence of mental health is a must, a task to be undertaken with professionals such as doctors
