## CBI re-open July 23 Khwairamband keithel fake encounter killing case - Th. Chaoba

**Imphal, Jan 31:** Following the confession made by head constable Th. Herojit, CBI has reopened the case of the alleged fake encounter case of July 23, 2009. This was stated by Th. Chaoba, President, Manipur Pradesh BJP in a press meet held today. The BJP Manipur Pradesh president also re-iterated its demand for resignation of Manipur Chief Minister Okram Ibobi Singh on moral ground for presenting concocted report to the floor of the Manipur Legislative Assembly on the day of the incident. Confession of the Manipur Police head constable Th. Herojit on how he shot death an unarmed 23 years old youth Ch. Sanjit in broad daylight of July 23, 2009 is adding another score to the BJP which has been harnessing all effort to throw

out the congress regime. The BJP Manipur Pradesh president is not sparing this favourable opportunity except a little worried about their newly enrolled member, former DGP Yumnam Joykumar, whom the head constable had stated that he too along with the Chief Minister of Manipur Okram Ibobi Singh were given prior information about the order to kill the unarmed youth by the then Additional SP Dr. Ak. Jhalajit, who is now the SP of Imphal West district police. Now adding a twist to the already troubled Okram Ibobi Singh government, the BJP Manipur Pradesh today demanded his resignation on Moral ground. The party also demanded suspension of Imphal West district SP Dr. Ak. Jhalajit until the final verdict of the case has been spelled out.

CM Okram Ibobi Singh was that time in-charge of Home department when the (staged) encounter took place at most crowded place in Imphal city. Assembly session was underway on the day, and in the August house of state legislative Assembly the Okram Ibobi Singh stated that the police had left with no choice but to exterminate Ch. Sanjit. President of the BJP Manipur Pradesh said that 1528 cases of alleged fake encounter remains pending in Supreme Court of India. Out of this 1528 cases happened during 2002 to 2012 when congress government is in power in the state with Okram Ibobi Singh as the Chief Minister. The killing of pregnant woman Rabina and 23 years old youth Sanjit in staged district SP Dr. Ak. Jhalajit until the final verdict of the case has been spelled out.

## MSPDCL readies to recover outstanding due from Prepaid consumers without giving any harassment

**Imphal, Jan 31:** The Manipur State Power Distribution Company Limited (MSPDCL) is all set to recover the outstanding due from prepaid consumers in the state but without giving them any harassment. According to a press statement issued by R. Sudan, IAS, Managing Director MSPDCL, the decision to recover the outstanding due is taken as it is mandatory to clear the dues to be paid by MSPDCL to CPSUs like NHPC, NEEPCO, PGCIL etc. As per official record the MSPCL is yet to clear an amount of Rs. 109,92,48,722 to the CPSUs for purchase of energy and transmission charges as on December 31, 2015. The press statement of the managing director stated that recovering the outstanding due need to be transparent and for that the company may take 2 months starting from February 1, 2016 to complete the exercise. At present the MSPDCL has installed 76,456 prepaid meter to consumers in

Imphal. Similar exercise will be undertaken for the remaining consumers of Imphal Area after conversion of prepaid consumer by April 2016. **Methodology of adjusting Outstanding Dues:** Presently, in case of Prepaid Consumers of Imphal, areas amount is not collected. Once the consumer wise outstanding dues is fixed through transparent process of personal verification by the Consumer, the same figure shall be transferred to the Data Server and deduction can begin from the periodical recharges the Consumer does as indicated below. **In case of Single Phase and LT 3 Phase Prepaid Consumer:** Outstanding due (Principle, Surcharge, and Security Deposit) once agreed between consumer and MSPDCL, will be frozen while Principle amount will be migrated to consumer database for future deduction. Surcharge and Security Deposit will be separately migrated and its deduction will be based on Government approval in

future. Each time this consumer recharge, 20 % of the recharge amount shall be adjusted in payment of outstanding dues. Suppose a consumer has an outstanding dues of Rs. 12,000/- and the consumer comes to recharge for Rs. 500/- then 20% of Rs.500 i.e. Rs. 100/- will be adjusted in payment of arrear and gets a recharge of Rs. 400/-. The outstanding due then changes to Rs. 11,900/- in the server Database, Primary adjustment of payment made will be taken up against the Principle component of the total outstanding amount. All the details such as remaining dues, amount adjusted shall be shown on the recharge token. Each time these consumer recharges, 20% of the recharge amount shall be adjusted in payment of outstanding dues. **Similarly in case of HT 3 Phase Prepaid Consumer:** The Consumer shall have to pay - 10% of the Total Outstanding dues + Current recharge amount. The amount paid against the outstanding

dues shall be adjusted accordingly. In both the above cases, the deduction as per the above methodology is mandatory. But if a consumer prefers to pay more than the mandatory deduction, so as to avoid accumulation of surcharge, the same shall be allowed. **Process of Verification of Outstanding Dues by Consumers:** List of all the consumers with their outstanding dues will be available in their respective sub-division office and the date of publication of the said list shall be published in local dailies in a phased manner (starting from 1/2/2016). The details will also be uploaded in MSPDCL website - www.mspsdcl.com. For those Consumers who have registered themselves with MSPDCL for mobile sms delivery services, their outstanding details shall also be shared through sms. Consumers may reconcile with the Sub-division office regarding the outstanding due amount within 20 days from the date of notification.

## 757 people insured at RPLI camp at Mayang Imphal by Manipur postal dept.

**Imphal, Jan. 31:** A new record was created by Manipur Postal Dept for very first time by covering 757 persons with new policies under Rural postal life insurance scheme in a special campaign organised in Mayang Imphal. This has been done for the first time during the camp 53 Recurring Deposit accounts and 42 Savings Bank accounts were opened on the spot. This special campaign was launched in here for promotion of Postal Life insurance schemes and other flagship social security schemes including Pradhan Mantri Suraksha Bima Yojana (PMSBY), Pradhan Mantri Jeevan Jyoti Bima Yojna (PMJJBY) and Atal Pension Yojana (APY). In camp 36

person were covered under PMSBY accounts. Shri Vinod Kumar, Director (Posts) Manipur inaugurated the function as President while Md. Sikander Ali, Pradhan, Hayel Hangoon Gram Panchayat was the Chief Guest and Shri M. Rameshwar, SDPO Mayang Imphal Police Station was the Guest of Honour. Dr. Rheizuddin Sheikh, Principal Manipur College was also present as Special Invitee. Shri Kumar intimated the Department of Posts is working hard to promote social security schemes to spread awareness in every nook and corner of the Manipur state and this camp at Mayang Imphal is a step in this direction. He mentioned that under PMSBY, one can

insure against accidents for Rs. 2 lakhs by paying just Re.1/- per month while one can get life insurance at Rs. 28/- per month under PMJJBY. He appealed to all the public to take advantage of such useful government schemes. On this occasion, Shri Vinod Kumar presented awards to star performers of the post dept as a measure of motivation. Shri L. Tiken Singh, Asst. Supdt. Of Posts, Manipur also spoke about Postal Life Insurance (PLI) and Rural Postal Life Insurance (RPLI) which gives more bonus at low premium. PLI can be availed by any person who has a govt or semi-govt jobs, nationalised banks, aided colleges etc while RPLI is meant for rural people at very low premium but high bonus.

During the camp 15 SSSY accounts were opened for girl Childs. Md. Nasir Ahmed, Inspector of Posts, spoke on Sukanya Samridhi Yojana (SSY) which is meant for girl children less than 10 years and gives an interest rate of 9.2 % compounded annually. He said that this scheme is especially applicable for the parents who wants to plan for the future of the girl child after 21 years. With this Yojana, the child will get Rs. 6,16,000/- when she attains the age of 21 years if the parent can deposit Rs. 1000/- per month for 14 years. Thus it can be utilised for her higher studies or a bright future. Shri Th. Gandhi, Marketing Executive gave a presentation on Post Office Saving schemes like Recurring Deposit (RD) and Saving

Bank (SB). He intimated that under RD, if a person deposit Rs. 100/- every month for 5 years, he or she will get a sum of Rs. 7450/- . Md. Sikander Ali, Pradhan, Hayel Hangoon Gram Panchayat expressed happiness at conducting such a Mela at Hayal Hangoon and Mayang Imphal as it gives awareness of the various useful social security schemes to the local people. Shri Kumar, Director congratulated Md. Riyajuddin, IPO 3rd Sub Division for the successful reation of record. Shri Kumar intimated that directions for organisation of these campaign have been given to all sub divisional heads and camps are being organised in various parts of Manipur.
