Manipur's Sushila to lead National hockev team to Rio *Olympic*



IT News Imphal, July 12: Pukhrambam Sushila Chanu of Manipur is leading the Indian Women's hockey squad to Rio Olympics.
The 24-year-old defender would lead the national squad as team captain. The selection board has also named another woman from the state, Thokchom Anuradha Devi (Forward) to the Indian women's hockey team for Rio Olympic. India's 16-member both men and women squads for Rio Olympics was announced on today afternoon in New Delhi by President of Hockey India, Narinder Batra. This is the first time a Manipuri woman leads the Indian hockey team to Olympic. In the Men's Hockey team, two more Manipuri lads Khadangbam Kothajit Singh (defender) and Kangujam Chinglensana Singh (midfielder) have been included. The women team is placed in Group B with Argentina, Australia, Great Britain, Japan and United States, while the men's team is also placed in Group B with

Meghalaya Police attempts to strike cord with civil societies for better policing

ANI Tura, July 12: Meghalaya police had vesterday made an attempt to strike a cord with civil societies and church organisations for better policing and reinstate confidence in the minds of the people.

The interactive meeting led by DIG (Western Range) S.S. Kynjing laid its thrust on suggestions and corrective ways for enabling police -public relation. It was attended by prominent civil organisations like Garo Students Union (GSU), Association for Democracy and Empowerment (ADE), among others.

At the meeting different issues were discussed including the new "no parking zone" in Tura town, which has posed several challenges to the public.

In absence of adequate parking space in prominent market places like - Ringrey Hawakhana and Araimile, the NGOs suggested that a regulated timetable in managed to ease the problem. They also suggested creation of new

parking space.

Apart from day to day problems confronting the citizens, the NGOs sought attention on speedy release of rehabilitation package for surrendered cadres of different outfits including those of the disband militant outfits.

In the meeting, Kynjing sought for people, religious leaders and social organizations to play a proactive role in taking Garo hills forward on the path to peace and development

Superintendent of police West Garo Hills Mukesh Singh said that interaction with various stakeholders was important to create a bonding between police and civil societies.

During the 15-minutes session, the Assembly moved for amendment of increment to salaries, allowances, other facilities of Chief Minister. other Ministers, Speaker, Leader of Opposition, Deputy Speaker and other Members of Nagaland Legislative Assembly, Parliamentary Secretaries and pension for ex-Members, Parliamentary Affairs Minister.

Nagaland's "Lokayukta" Bill will not come into reality soon

Kohima, July 12: The hope of getting "The Nagaland Lokayukta Bill, 2005" has been dashed after Levi Rengma, Parliamentary Secretary and Chairman of the Select Committee on the Bill has moved in the Assembly today for the extension of tenure of their "Select Committee" for another six months. The Select Committee has to present their Report within six months and table it in the Assembly. In fact, Governor PB Acharya was fumed at the delay of the passing of the Bill which, if passed, will check alleged rampant corruption, backdoor appointments in government departments and irregularities in implementation of schemes. Nagaland Chief Minister TR

Zeliang introduced the Nagaland Lokayukta Bill 2015 in last year Assembly Session. The "Lokayukta" is an "Anti-

Corruption authority' empowered to investigate into allegations of corruptions against public functionaries and related matters. It is a quasi-judicial body, which would act as a watchdog to pinpoint corrupt activities of the administration, look into complaints of the victims of corrupt elements and recommend measures to improve the efficiency of the Government. The people of Nagaland will not see their "Lokayukta" coming into reality so soon.

Nagaland Legislative Assembly: No Opposition, no sound as almost all the institutions

Kohima: TR Zeliang's historic winning of the "Vote of Confidence" of his Government has completed almost one-and-half years. He moved the "Confidence Motion" of his Government when 22 NPF dissident legislators led by G Kaito Aye threw an unprecedented challenge to his leadership in the NPF legislature party. The NPF had 38 legislators then and after 22 legislators

challenging his leadership, he was sent into a complete

defenselessness. But he survived the first political storm because NPF President

Dr. Shurhozelie had swiftly

placed seven of them placed seven of them including Aye under suspension. Soon, the beleaguered DAN Chief Minister turned the game of the NPF legislature leadership crisis into DAN Government crisis. The dissident NPF legislators criticized the move saying that they only challenged his leadership in the NPF leadership in the NPF legislature party. Interestingly, the dissident NPF legislators along with State's two MPs had even paraded in front of Governor, PB Acharya, in Kohima Raj Bhavan. Unfortunately, the State Government was kept in suspense for about a month

in the State were completely paralyzed following two groups – one led by Zeliang and the other by Aye – camping at de Oriental Hotel, Kohima and at Sovima, 7th Mile, Dimapur respectively. The worse sufferers were the common men. Acharya was finding difficulty as he could not interfere in a political party crisis while on the other, Zeliang managed to exhibit that all the legislators including eight Opposition Congress legislators in the State except that 22 dissident NPF legislators were on his side. And with all these unprecedented strange

bedfellows, he was trying to shift his political battle from the NPF turf to the Assembly by smartly working on to move a "Confidence Motion" of his seven-month-old Government. On 9 January 2015, Zeliang met Acharya with a proposal for the summoning of a Special Session of Nagaland Legislative Assembly for a "Confidence Motion" of his s e v e n - m o n t h - o l d Government. Since no reply was forthcoming from the Governor, he had a "Cabinet Meeting" on 15 January 2015 and forwarded a recommendation for summoning a Special Session

of Nagaland Legislative Assembly for a "Trial of Strength" of his government on 20 January 2015. This recommendation had literally sealed the Governor from seeking another route to his action. (Governor) finally summoned (Governor) finally summoned a "Special Session" of Nagaland Legislative Assembly on February 5, 2015, for a "Trial of Strength" of Zeliang Ministry in Nagaland. But this writer told Zeliang prior to the "Trial of Strength" of his Ministry that the dissident NPF legislators would never vote against it (Confidence Motion).
