Maoists set 48 hours deadline for distribution of allotted ration under **NFSM** 

IT News Imphal, July 20: Rebel group Maoist Communist Party, Manipur (MCPM) has extended support to the ongoing peoples' movement at Khurai and Khundrakpam Assembly constituencies against government authority's failure to distribute allotted share of ration under the National Food Security Mission (NFSM).

In a press communiqué signed by one Comrade Nonglen Meitei, Secy. Publicity and propaganda MCPM, the outfit warns MLAs of the two assembly constituencies to face serious consequences if fails to distribute the allotted share to the people within 48 hours. It also appealed the people to continue the movement until their rightful share has been distributed to them.

The rebel group also bombarded strong words against the two MLAs stating that if the people's rightful shares are not distributed within the period as mentioned, the outfit will take up the matter seriously as the act is nothing less than looting the people.

### Manipur Govt to Publish Indian Constitution in Manipuri

Addressing a press conference in Imphal, Assistant Director Toijam Devananda said on Tuesday that the directorate has plans to print updated Manipur Gazettes both ordinary and extra ordinary. He said that the directorate is equipped with modern machineries for printing including UV curving machine

machine. Section sewing machine, perfect binding machine, UV Curving machine and color digital printing machine.

Regarding upgradation of the directorate building, he said there has been restrictions from the government authority although the directorate was able to collect non tax revenue amounting to Rs 10.02 lakhs for the year 2015-16 against the target of Rs 3.46 lakhs fixed by the government and Rs 8.92 lakhs for the current year 2016-17 (till date). He said the

department managed to collect Rs 17.65 lakhs in non-tax

revenue collection for the year 2014 – 2015 against the target of Rs. 8.40 lakhs. The government press, Manipur was established as State Printing Press in 1919 after passing a resolution in the Manipur State Darbar in 1918. Later it was upgraded to a fullfledged Directorate of Printing & Stationery, Manipur on July 25, 1979 and since then the post of director has been held by Selection Grade MCS officer IAS officer.

Imphal, July 20: Fair price shop agents today have began distributing ration under the National Food Security Act (NFSA) to the beneficiaries of Kwakta Municipal Council and Kwakta Gram Panchayat areas under Moirang Assembly

Council. The NFSA rice was distributed to the priority card and AAY card holders of the Kwakta Municipal Council and Kwakta Gram Panchayat areas at the rate allotted by the Government.

Allotted rice which is 35-kg each of every AYY card holders and 5-kg each for

every priority householder was distributed accordingly. One of the Agent said that the rice which is being distributed is for the month of April due to late arrival for the Kwakta Municipal Council and Kwakta Gram Panchayat area though it is already July month

On the other hand, priority card and AAY card holders can avail their rations from their respective ward fare prize shop agents, the agent added.

As the distributing rice is for the month of April, the agent clarifies to the beneficiaries not to get confused thinking the rice is for the month of July.
