Locals seek immediate intervention of MLA over construction of retaining wall

Thoubal Kivam Siphai Babu Bazar and local clubs have appealed the concerned authority to expedite the construction of retaining wall near Kiyam Siphai Babu Bazar bridge as the condition of river bank have been worsened with the incessant rain causing inconvenience to villagers.
The pavement has been broken

owing to the construction of the retaining wall and with no other means of connectivity villagers are literally cut off from the rest of the state, said a local Meira

Paibi leader. IFCD started construction of the retaining wall from 9 May this year under the sponsorship of North East Council's Anti Erosion & Flood Control. However, only one third of the portion of the 90-meter-long wall has been completed. Since various earth movers and construction work, the river banks have been destroyed, said the Meira Paibi leader As the river bank was broken,

villagers have been worrying about possible flood from the river water. If the flood happens to break out, various household and agricultural lands would be under water, said an elderly person of the area.

Drawing the attention of local MLA of Wangkhem Assembly constituency, members of Kiyam Siphai Social Welfare Organisation also urged the concern authority to intervene with the ongoing construction work of the retaining wall and expedite the work progress at the earliest.

SC calls for probe into 1,528 alleged fake encounters by Army in Manipur

ANI New Delhi, July 8: The Supreme Court on Friday called for an investigation into the alleged 1528 judicial killings by the Army and other security forces in Manipur. The Apex Court also said that

the Army can conduct its own inquiries into accusations of these extra judicial killing till the court examines. The petitioners have alleged

the security forces escaped action because they operated under the controversial Armed Forces (Special Powers) Act.
The law makes it mandatory

for the local police to take Centre's permission before initiating prosecution against erring security personnel.

Meanwhile the court also agreed to examine National Human Right Commission's complaint that it has become a 'toothless tiger' and it needs



strongly in favour of the petitioners - human rights organisations - and referred to a court-appointed panel in support of her arguments.

The committee, set up by the court in 2013, probed six such encounters in which seven people were killed.

In its preliminary findings, the panel said all the six encounters were stagemanaged.

Department issues exact amount according to NFSA card holders: official

Imphal, July 8: Department of Consumer Affairs, Food and Public Distribution (CA & FPD) appeals to the people of state to initiate enquiry of National Food Security Act about not getting their allocated ration or cards, and should lodge formal complaints to nearby Grievance Redressal Mechanism (GRM) or District Grievance Redressal Officers Redressal in the respective districts in Manipur.

During the interaction program with media persons organised by DIPR, official of the CAF and PD said that the department has made available the actual allocated amount of ration to all the respective fair price shops of the state however if any consumer are

not getting the actual amount of ration then they should complain to GRM.

The officials further added that card holders should not be complacent or be satisfied with whatever amount they shops. The card holders should demand their rightful share of the ration under the scheme.

They further said that the department is currently focussing on proper implementation of NFSA in the state. To achieve the potential and objective of NFSA which was launched in the state by Chief Minister O Ibobi on April 25, all stakeholders need to be sincere in carying out their roles. Fair price shops agents and transpor contractors must be sincere.

NSCN has not given up on sovereignty, says Muivah

New Delhi, July 8: Thuingaleng Muivah (82), general secretary of the National Socialist Council of Nagalim (Isak-Muivah), which signed a framework agreement with the government last year, told *The Hindu* that the outfit had not given up its demand for sovereignty.

Mr. Muivah also said that a separate flag and passport for Nagas was not just a "demand" but a right as the "Nagas were

Nagas was not just a demand but a right as the Nagas were never under Indian rule."
"No, no. The understanding on shared sovereignty has been arrived [at] because the uniqueness of Naga history is recognised. We are not giving up on the demand of sovereignty," Mr. Muivah said in a rare interview since the signing of the agreement, and perhaps the first after the death of NSCN (I-M) chairman Isak Chishi Swu.

Minister of State for Home Kiren Rijiju had told *The Hindu* last year that the NSCN (I-M) had given up its demand for sovereignty and the rebel outfit wants "a solution within the Constitution of India

Mr. Muivah said the talks this time would succeed as the

overnment was positive. "We are confident because this time there is positivism from the Government of India.

Mr. Muivah, a Naga from Manipur who was associated with Mr. Swu for the past 52 years, dismissed the possibility of the talks running into trouble because of Mr. Swu's death.

"Well, there is no point in delaying the talks. The Nagas were kept divided, not by the Nagas but by external forces. But now things are clear. Indians are bound to accept the demand of the

On a separate flag and passport, Mr. Muivah said: "Well, it is actually not a demand. Why? The Nagas were never part of the Indian union by consent of the Naga people. That is why the Nagas will have the right to decide their role as we were never under Indian rule. We were ruled by ourselves, that is why theNagas will have a right to rule themselves. This has been recognised by the Indian side."

He said the framework agreement would have to be kept a secret to "save the course of the talks."

Time will come [when it will be shared with the public]. It is a secret because until a complete settlement is done, some secrecy

will have to be maintained," he said.

Mr. Muivah signed the framework agreement on behalf of the Naga outfit with interlocutor R.N. Ravi in the presence of Prime Minister Narendra Modi.

Naga outfits envisage a "Greater Nagalim" comprising the contiguous Naga-inhabited parts of Assam, Arunachal Pradesh, Manipur and Myanmar with Nagaland.

On August 3, 2015, at a much-publicised ceremony at the PM's residence, Mr. Ravi claimed to have signed a "peace accord" with Mr. Muivah to find a final solution for the Naga issue. Following the signing of the agreement, earlier referred to by the government as a "peace accord," the Chief Ministers of Assam, Manipur, and Arunachal Pradesh, which have a sizeable Naga population, said they were not consulted by the Centre on the population, said they were not considered by the Centro of the issue. Congress president Sonia Gandhi charged the government with being arrogant in not consulting them.

The Centre is yet to release the terms of the framework

agreement.

The government signed the agreement with NSCN-IM as it was the largest group representing the Nagas. (Courtesy The Hindu)
