

## NSCN-IM alleges violation of cease fire ground rule by 5 AR

Imphal, July 19: National Socialist Council of Nagalim (NSCN-IM) has alleged the 5th AR trooper of allegedly abducting one of its members and forcing him to sign as member of NSCN-K under duress. A press statement issued by the Ministry of Information & Publicity of the GPRN/ NSCN stated that the 5<sup>th</sup> Assam Riffles illegally abducted Aloto A.Sumi Razau Peyuof NSCN/GPRN, son of Ahoto Sumi of Aotsakilimi Village under Zunheboto District on July 18, 2016. at 3 am.

"It is very strange on the part of 5th Assam Riffle to let him forcibly signed as having belong to NSCN Khaplang", the MIP statement said.

It further added that the incident is the 4<sup>th</sup> such incident where NSCN-IM cadres were abducted by 5th Assam Riffles and forcibly made to sign as a member of NSCN-Khaplang group.

The MIP statement warns 5 AR trooper not to repeat such act in future and asked them to release Aloto A.Sumi Razau Pevu Sumi Region immediately. It said the NSCN can no longer tolerate such provocations and humiliations devoid of ceasefire agreed ground rulae

New Delhi, July 19: The Centre has set a target of creating food grain storage facilities storehouse with a combined capacity of hundred lakh tonnes by 2019. He said, government is increasing the storage facilities to avoid any damage to food grains. Mr Chaudhary said, his Ministry is also focussing on renovating the old storage facilities in the country.

## Hearing on 'Wanted' tag on Ratan to continue on 20 July

Imphal, July 19: The hearing regarding a petition filed by former JCILPS Convenor Kh Ratan challenging the 'Wanted' tag on his person by the state government was held under Division bench Chief Justice RR Prasad and Justice S Serto today lasting for over two hours. According to the argument put up by the representatives of the petitioner namely Sr Advocate Khaidem Mani, Sr Advocate I Lalit and advocate Rakesh Meihoubam, proper procedures under section 82 of CrPC was not followed while proclaiming offender, and the fact that the Wanted status was announced by the police PRO through a press

note in contravention of formal procedure and hence the Wanted tag should be quashed. Replying to the argument, the respondents represented by Advocate General Thokchom Ibohal and Addl Advocate General Namoijam Ibotombi contended that the police can proclaim an individual as Wanted under CrPC 157 citing various instances from the state and outside. The High court deemed the procedure unsatisfactory for not following section 82 of CrPC while proclaiming Ratan as absconder. Advocate general pleads for continuation of the deliberation on the next day to which the court gave its approval.

## RK Imo asks political leaders to stop giving unwarranted statements

Secretary (Admin) of Manipur Pradesh Congress Committee, RK Imo Singh has congratulated the youngest Chief Minister of the country Pema Khandu, who has been sworn in as Chief Minister of Arunachal Pradesh.

In a release, RK Imo said, "This was possible after the intervention of the Supreme Court for the second time in a year in Uttaranchal and

Arunachal terming it as unconstitutional. Stop blatant misuse of Article 356. If any party wants to come

to power in a State, go through electoral means by going to the people and not by unconstitutional means." There are also many leaders from other political parties who have been giving statements in the public domain that many MLAs from the Congress Party in Manipur will leave and join other political parties very soon. If we respect democracy under the Indian Constitution, then stop saying or giving statements which are unwarranted and

uncalled for."

"Please go the electorate in 2017 and come to power if the people are supportive of you and your party. Till then please stop giving such comments in the public. Let the Supreme Court not remind the political parties again and again not to act through unconstitutional means. If possible the post of the governor should be totally abolished as totally abolished as suggested by CMs of various states," said the MLA in a release

Curfew remains in force in Kashmir, death toll climbs to 42

Srinagar, July 19: A woman injured in clashes between security forces and protestors in South Kashmir succumbed at a hospital, taking the death toll in the ongoing unrest to 42, even as curfew remained in force in the Valley today. Neelofar was injured in retaliatory firing yesterday after the protestors pelted stones at an Army vehicle in Qazigund.

Two other persons, including a woman, were killed and seven others injured in the incident.

A police spokesman, giving details of the incident, said an army mobile domination patrol party while moving towards Devsar tried to clear a road blockade erected by some persons at Churaht Qazigund.

The security force party while removing the obstructions came under heavy stone pelting by the miscreants from two sides. The Army party warned the mob to maintain distance but it did not relent.

"Some miscreants tried to snatch weapons from them and tried to set ablaze the vehicles. Despite repeated warnings the mob did not disperse and army fired in self defence in an effort to move out from the spot," the spokesman said, adding six persons were injured in the incident out of which

two had succumbed last night. Curfew, meanwhile, remained in force across the 10 districts of the Valley as there was no sign of deadly clashes between

protestors and security forces ending. The clashes began soon after the killing of Hizbul Mujahideen commander Burhan Wani in an encounter with security forces on July 8.

Police and paramilitary personnel have been deployed in strength across the Valley for strict implementation of the

prohibitory orders, the official said. He said there were no reports of fresh violence from anywhere in the Valley so far.

Normal life also remained paralysed for the 11th day today due to separatist sponsored strike, which has now been extended till July 22.

In a joint statement, Syed Ali Shah Geelani, Mirwaiz Umar Farooq and Mohammad Yasin Malik yesterday said the shutdown in the Valley will continue till July 22. However, they have announced a relaxation of half day from 2.00 PM onwards on July 21.
