Imphal, June 17: In what would be termed as a small respite for the prolonged battle for justice against the numerous cases of extrajudicial killings being carried out by the security forces in the state, the state government have finally sanctioned ' 1,54,000/-(rupees one crore fifty four lakh) for payment of compensation of ' 5,50,000/ - (rupees five lakh fifty thousand) each to the next of kins of 28 (twenty eight) victims. The order is in compliance with the recommendations of the National Human rights

Commission and in compliance of Writ Petition (Criminal) No. 129/2012 of Supreme Court order dated 22/4/2016. It may be mentioned that The Extra Judicial Execution Victim Families Association (EEVFAM) filed two writ petitions under Article 32 of the Constitution of India which state that during the

IT News Imphal, June 17: Due to maintenance work of the deteriorating conditions of Irang Bridge, it will be closed down for 2hrs from 10:00am to 12:00pm for 2 days along NH37 Taobam. All kinds of vehicles plying along this road will be stopped during the said time

period May, 1979 to May, 2012, 1528 people were killed in Manipur in extra-judicial execution. The statement is mainly based on a memorandum prepared by 'Civil Society Coalition on Human Rights in Manipur and the UN' and submitted to Christof Heyns, Special Rapporteur on extrajudicial, summary or arbitrary executions, Mission to India, 19-30 March, 2012. The Memorandum compiles

the list of 1528 people allegedly killed unlawfully by the State Police or the security forces. The writ petitioners later on filed "Compilation 1" and "Compilation 2". In "Compilation 1" details are

given of ten (10) cases relating to the killings of eleven (11) persons (out of the list of 1528); in "Compilation 2", similarly details are given of thirteen (13) cases in which altogether seventeen (17) persons (out of the list of 528) are alleged to have been killed in extra judicial executions

The Supreme Court on 24 Nov 2012 questioned the "orientation" of the Manipur government over extra-judicial killings in the state and reprimanded it for drawing a parallel with the states of Gujarat and Maharashtra, which are already under the court's scanner over contentious encounters.

Manipur, in its response to a PIL which alleged 1,528 extra-judicial killings in last 30 years in the state, had requested the court to consider this matter along with two other pending cases relating to encounter killings

### Counter blockade continues on different routes of the state

Imphal, Junwe 17: In condemnation of the 10 day's economic blockade which is being imposed on National Highways, counter economic blockade which has been launched by different Meira Paibis and local clubs continues at different parts of the state today also. Different Meira Paibis and

local club volunteers of Etam Nungoi of Lamlai Police Station, Pheidinga, Moirang Lamkhai, Tronglaobi, Tera Khongsangbi, Khuyathong, Khonghampat, Kwakta Khongsangbi, Khuyatnong, Khonghampat, Kwakta Moirang Turel Mapal, Kumbi and many other areas of the state prevented transportation of any goods along roads

leading to different hill districts today. Meira Paibis and local club volunteers confiscated huge number of goods transported in different vehicles including passengers service from the areas where the counter economic blockade have been imposed since today early morning. During the counter economic

blockade, transportation of any goods from different areas of the state to hill districts were also prohibited while different Meira Paibis appealed to all the concern to call off the ongoing economic blockade along the National Highways at earliest. Until then, cou the economic blocked will be

continue to be imposed The ongoing 10-days economic blockade was called by the JAC Against Anti-Tribal Bills Manipur and the Outer Manipur Tribal Forum in denunciation of the three Bills passed by the Assembly on August 31 last year. Meanwhile, a large number of

50/60 male persons today came out on the street of Kangpokpi area in support of the ongoing economic blockade on the National Highways. Vehicles coming from Imphal and towards Imphal were detained. Vehicles were checked for transportation of goods.

### Indian Army planning to convert school into camp

Imphal. June 17: The 14 Sikh Regiment has approached the state Government through the DC of Tamenglong for utilization of school structure as their camp. A reliable input from our source informed Imphal Times that in a letter No. 3033/14-SIKH/Q dated 21/4/16 from the Commanding Officer, 14 Sikh Regiment requested the Deputy Commissioner Tamenglong for utilization of Jawahar Bal Bhavan at Awangkhul, Tamenglong District. In this

regard, a senior officer of the state government wrote to the DC seeking his comments. may be mentioned that Tamenglong District in Manipur is one of the most backward districts with very poor road connectivity and absence of public amenities especially infrastructures such especially infrastructures such as schools and educational institutions. Also, the district is infested by militants particularly ZUF, NSCM-IM, NSCM-K etc with frequent encounters between the rival groups and also with the

security forces. The present approach of the Sikh Regiment is observed as a decision to re-establish its presence and strengthen the position of the Indian security forces for the sake of security and an effort to bring tranquility and peace However, there has been an increasing outcry over the security forces occupying educational institutions and converting the school structures as their camp depriving the children of the area from getting their education
