Need for strategic changes

The greater Imphal area saw a large turnout of voters eager to exercise their universal suffrage right from the time the polling started, and is still continuing unabated. Contrary to initial apprehensions about this day, there have not been reports of any major disruptions in the polling process so far. The state government, anticipating attempts to disturb the normal polling activities from various quarters in the backdrop of the intensifying agitations for implementation of the Inner Line Permit system in the state by various civil organisations and students bodies, have already declared all 189 polling stations across the 20 wards of Imphal West District and 9 out of 66 polling stations in 7 wards across Imphal East as hyper-sensitive areas, 21 as sensitive and 36 as normal out of a total of 255 polling stations and appropriate security arrangements taken up with 945 polling personnel, around 1325 security personnel, 6 Sector Magistrate assigned duty in Imphal west and 330 polling personnel, 35 reserve will be manned in Imphal East. Seven armed and unarmed security personnel are being deployed for each polling station, including two women police.

The unexpectedly large turnout and the relative peace at the polling stations across the two valley districts have displayed the inherent trust and hope the people of the state still repose on the political system to bring about a positive change in their personal lives and the society. The matter-of-fact attitude by the public when it comes to exercising their voting rights have also driven home the point that given a fair opportunity, the public will take a peaceful and considered approach to airing their grievances and letting their complaints known rather than the alternatives which further disrupts and affects the laymen much more than the high ranking bureaucrats, politicians and officials who are well-ensconced and insulated from the officials who are well-ensconced and insulated from the destruction and mayhem purportedly carried out to disrupt their official activities. The toll on the public, and more significantly on the bleak prospects for the future generation cannot be stressed enough. The protracted method of using brute force and overwhelming with sheer number to press any issue forward may have worked on many counts. But there definitely has to be an alternative that minimize the negative another way - an alternative that minimize the negative and harmful fallout of such collective emotional outbursts yet have a more profound impact on the issue, not for this instance alone but as a means that will shift the focus on the efficacy rather than the sustainability of the issue which will set the trend for the future as well. Every individual under democracy has the right to protest, but when such protests and agitations usurps the individual freedoms or rights of another more than for those to whom such protests and agitations are being targeted at, then such a means would eventually prove to be the detrimenta factor preventing the issue from reaching its logical conclusion The state government and the representatives of the people being what they are, it is time to exercise restraint and follow the head rather than give in to the pent-up emotions and momentary impulses.

Broad gauge service to roll from Agartala by this June

Agartala, June 2: General Manager Northeast Frontier Railway (NFR) H.K. Jaggi on Thursday said that the Broad Gauge (BG) rail service will be inaugurated by the second or third week of this month from

He was speaking to media at the state secretariat after meeting Tripura Chief Minister Manik Sarkar and Transport Minister Manik Dev before finalizing the date of the

inauguration of the BG service.
The NFR GM had arrived here to review the preparation for flagging off BG train service from Agartala and inspection of the Agartala-Udaipur line said that due to heavy rain followed by landslip there has been damage of the rail line in the Silchar-Lumding sector and which

is delaying the inauguration. On the Agartala-Akhaura (Indo-Bangla) railway project, Jaggi said the Ministry Of Development Of North Eastern Region has already released the first installment of Rs 150 crore out of the total Rs 580 crores and by this month NFR is likely to get the fund and after which land acquisition work in the India part shall start. He informed that out of the total 15

km international rail project the 5 km India part of the project will cost around Rs 580 crores which will be totally borne by NEC while the remaining 10 km in Bangladesh will cost Rs 360 crores to be funded by the India External Affairs Ministry. Jaggi further added he had reque the Tripura government to expedite the process of land acquisition for timely completion of the project.

Usually, the blue colour is to show the reference and not to give the link to the official website of the same magazine or newspaper in which the article is published because it does not make sense to link the same magazine's website as a reference with blue colour in the midst of the article which discusses a serious "IB's confidential

report".

Can we do anything that can make a difference in our situation is always the question. It should be asked to keep us realistic. From my own experience I know that if we simply decide to be "The change you want to see in the world", change you want to see in the world", as Gandhij put it, more things happen in unexpected ways than we can imagine or understand. There is a verse in the Gita that says we are to do what we know is our duty leaving the results in His hands. There is more in this truth than we realize.

I shall cite two statements of conviction nd commitment given to the world from

and commitment given to the world from the Middle East. The first one: Landrum Bolling was a scholar, journalist and a widely respected worker for peace between Israelis and Arabs. He wrote, "The real Issue, significant for everyone, is whether the sterile negative of today's life in the middle east, by which all men are imperiled, can be converted to a pattern of human co-operation not yet known or seen among men. This is

not sentimental nonsense if we can believe that there are not hopeless situations, but only hopeless men." The second one: In the third week of May

this year the highly popular annual Euro-Vision musical extravaganza was held in Vision musical extravaganza was held in Norway. An Israeli actress-singer and a Palestinian Arab actress singer sang together in the competition projecting their common dreams for their peoples. They were not strictly from within Europe. But that was not questioned by anybody. They did not win the first prize but they stole the show by their vibrant sence and their sheer courage in taking a common stand. They said they were taking part in the contest to signal to their own peoples and to the world their conviction that "There must be another way" and it could not be abandoned, the way: and it could not be abandoned, the way of "acknowledgment of one another's right to exist", apologizing for the wounds and hurts inflicted to one another and "sharing" in the building of a common future. They were demonstrating what converting the "sterile negative of today's life" in their devastated region to

human co-operation would entail.

If there is to be another way, a better way, in all situations of prolonged disorder, distrust, vengeful hatred, despair and violence, the "sterile negative" in situations like ours in our region also has to be addressed with the region also has to be addressed with the seriousness that the problem deserves. "Sterile" according to the dictionary means, "barren, fruitless, incapable of producing offspring, results, ideas..." Is not this barrenness, this pervasive sterility that breeds despair and evil, one of the explanations of our crisis also?
We should know in what ways we are a part of the sterility and learn simply to end it for the sake of our common future

we must build together. I shall conclude what I have tried to convey by restating the main points of

* The quality of our response to the challenges and needs in our crisis decides the quality of our people and our society. This dictum of history allows

no concessions.

* Evil is born and it becomes malignant
when normal human failures and
shortcomings, or mistakes and wrongs
done, are denied, defended or justified because of pride, fear or selfishness. Hurts because of pride, lear or selfishness. Hurts not transformed are then transferred causing wider damage. "The most terrible process of all is not the war-making that takes lives and villages and towns, but the irrevocable damages to the majority who survive. The killing may stop ... But societies undermined by distrust, and burdened with criminalized economies do not recover". (Martin Wollacott, writing in 1998 on the disaster that overtook the former Yugoslavia).

* Sustainability of our ideas and plans

for solutions to our problems depends on our acceptance of reality and the ethical moral soundness of the values we live by. (Concluded)
