Imphal, June 22: Two surrendered militants including former Chairman of proscribed group PREPAK -VC, Ningombam Nabachandra aka Nongdrenkhomba were shot dead inside the 7<sup>th</sup> MR Complex at Khabeisoi at around 8.30 pm yesterday. The other person found murdered is identified as Leisangthem Sanjit Singh aka Chingkhei, aged 41 Yrs, son of L. Lalsing Singh of Thangmeiband Hijam Dewan Leikai.

## Tension gripped Sadar Hills, after AR arrested 4 cadres of KNF

IT News Imphal, June 22: Tension gripped Sadar Hills this afternoon after four cadres of the Kuki National Front (KNF) were arrested by personnel of 35 Assam Rifles

posted at Hengbung. Protesting the arrest, irate womenfolk of Sadar Hills imposed an indefinite bandh along the National Highway-2 in front of the 35 AR Henbung post since morning today.

The four cadres are reported to be body guard of KNF president, ST Thangboi, who is also the chairman of United Peoples' Front (UPF). UPF is one among the two conglomerates of the Kuki UGs which had recently held the first round of political dialogue with the Centre and the state. He was attending a traditional family function at Hengbung today when the incident happened. Report said that Maj. Gulati,

Commander, 35 AR Hengbung post arrested the four bodyguards of Thangboi when the KNF president was attending the function.

A leader of Sardar Hills Kuki Women Union, while speaking to this reporter alleged that, Maj. Gulati had some small arms with him before apprehending the bodyguards and later claimed to have recovered the same from the bodyguards. She said, "UPF and KNO had recently held the first round of political dialogue with the Centre and state

governments at New Delhi and it is an insult to the whole Kuki community that the 35 AR under the command of the 'arrogant' Major behaved ruthlessly with a dignitary of tripartite political talks".

She further alleged that the 35 AR personnel including the post commander have

violated the ground rules of SoO, and demanded punitive action fr authority. from the higher

The women folks also demand unconditional release of the four arrested bodyguards while warning that the sudden indefinite bandh along the NH-2 will continue until they are released.

Till filing of this report the women folks are continuing their protest in front of the AR camp; however there is no report of any untoward incident so far.

Meanwhile around 51 laoded trucks, 7 passenger bus and 3 Winger vehicles heading towards Imphal are reported to have been stranded due to the sudden blockade imposed by the women body of Sardar Hill. Vehicles supposed to leave Imphal for Dimapur and Guwahati have also been suspended today.

14 numbers of Wind-Solar Hybrid System Implemented in Manipur In order to promote SHP development in India, under the Under the Jawaharlal Nehru National Solar Mission ground level. Altogether 541 nos of S

Imphal, June 22 : Under the programme of Small Wind Energy and Hybrid System (SWES) of Ministry of New and Renewable Energy (MNRE), Govt. of India, had implemented 14 Nos. of Wind-Solar Hybrid System in the State with a capacity of 10 kWp each for electrification at 14 villages of the State. Manipur Renewable Energy Development Agency (MANIREDA) is doing the selection of the villages after conducting wind resource assessment to the hilly sites where wind energy can be

assessment to the hilly sites where wind energy can be tapped for power generation. The details of location of the selected villages are Chawangkining 10kW, Kotlane 10kW, Dolangkhunou 10kW, Tingkai 10kW, Sankumai 10kW, and Regional Potato Farm, Mao of Senapati District; Chorjeng Lunghar 10kW, Hongbei 10 kW, Phungyar 10kW, Phungyar HQ 10kW of Ukhrul District; Lamdan 10kW of Churachandpur District; Lamdangmei 10kW of Tamenglong District; Tengnoupal 10kWad Tengnoupal HQ 10kW of Chandel District. MANIREDA is the State Nodal Agency of the Ministry

of MNRE, Government of India. Upto 25 MW capacity, State Nodal Agency can take up Small Hydro Power (SHP) projects in the state too.

Small Hydro incentives schemes of MNRE, the Ministry will provide financial assistance for identification of new potential SHP sites and preparation of plan and preparation of Detail Project Report @ Rs. 2.00 lakhs for each project upto 1.00 MW capacity and Rs. 5.00 lakhs for each project with more than 1.00 MW & upto 25 MW capacity to the State Govt. departments/ agencies. Despite being endowed with rich Hydro power potential,

Manipur has been facing power crisis for a long time. For solving the need of power, the rich hydel resources are required to be tapped in a systematic way. Small/Mini/ Micro Hydro is attractive because it is a renewable energy sources that can never be exhausted which also avoids the pollution associated with burning fuels. Small/Mini/ Micro hydro power is generally run off river and therefore avoids construction of large dams/reservoirs.

Solar Thermal energy is also another area that MADIREDA is taking up for solving power crisis in Manipur. It can be utilised to heat water for domestic use. By installing a Solar Water Heater of 100LPD capacity (2sq.m collector area), it can save around five units of power/energy per day totalling 1500 units per year equivalent to electric geyser of 2kW capacity in a home.

(JNNSM), Govt. of India, MANIREDA has implemented 6680 sq. m. collector area equivalent to 3340 nos. of 100 Manipur which were completely commissioned on 26/ 06/2013.

Renewable energy sources particularly Solar energy is used to provide basic domestic light to remote and inaccessible villages where electrification through conventional sources is not viable. 90(ninety) villages had already been electrified by MANIREDA through solar lighting systems under Remote Village Electrification(RVE) programme of the Ministry of New and Renewable energy(MNRE), Govt. of India and another 3 villages by Biomass gasifier systems since the

year 2004-05 till 2008-09. Under the programme of Jawaharlal Nehru National Solar Mission(JNNSM) of Ministry of New and Renewable Energy(MNRE), Govt. of India, MANIREDA is implementing 1400 W-LED based Solar Street Lighting system at 9 (nine) District Head Quarters of Manipur with a total capacity of 280 kW. The system comprises 200 Wp SPV modules, 150 AH Tubular Gel Type VRLA battery, 45W luminary with a pole height of 7m from

ground level. Altogether 541 nos of Solar Street light has been installed at Imphal East (campus of Jawaharlal Nehru Institute of Medical Sciences (JNIMS), Porompat and Imphal West District (Manipur High Court Complex, Mantripukhri), Thoubal District Headquarter Highway, Moirang Sendra Road etc. Foundation work is underway at Churachandpur and Senapati District Headquarters. The MNRE has launched "Unnat Chulha Abhiyan" programme to promote the development of household and community level Improved cook stove (Unnat Chulha) in the country. Under this programme, the Ministry has allocated the targets of 1000 nos. of family type and 200 nos. of community type cook stoves chulha and released an amount of Rs.5.88 lakhs advance towards 1st instalment for implementation of Unnat Chulha Abhiyan (UCA) during the year 2014-15. Also, Rs. 4.55 lakh released as 1st instalment for 2015-16.

In line with National initiative on renewable energy, MANIREDA has identified the thrust area as Generation of Grid interactive Rooftop Solar Power, Addition of Offgrid Solar Power Plant, Implementation of Hydro Power projects, Electrification of un-electrified remote villages by SPV systems and to explore possibilities of continuation of Solar Water Heater programme.
