# Quake of 4.4 magnitude jolts Nepal's Sindhupalchok district

du, June 3: A light tremor of local magnitude 4.4 struck Nepal's Sindhupalchok district on Friday

# "All the University and College teachers across the country are angry with the UGC notification on API dated 4.5.2016" - AMCTA

On May 4, UGC notified significant amendments in its 2010 regulations, including altering teachers' workload requirements by redefining "direct teaching hours". Teachers from several universities. besides the All India Federation of University & College Teachers' Organisations (AIFUCTO), have issued statements in protest, and the Delhi University Teachers' Association (DUTA) has gone a step further — some 8,000 DU teachers have been boycotting evaluation of answer scripts of all subjects for roughly 1.3 lakh undergraduate students since May

Such issue comes after the UGC has made the changes in API scoring

The definition of "direct teaching hours" has been changed. It included lectures, practicals, project supervision and tutorials, all of which were treated at par. Tutorials have now been removed, and the definition narrowed to "Lectures/Practicals/Project(s).

The number of teaching hours was increased. An Assistant Professor was required to teach 16 hours weekly; Associate Professors and Professors 14 hours — including time spent on tutorials and practical. This was changed to 18+6 hours per week for Assistant Professors, 16+6 for Associate Professors, and 14+6 for Professors. The "six hours per week include... hours spent on tutorials, remedial classes, seminars, administrative seminars, administrative responsibilities, innovation and updating of course contents". No reason was given for the changes. It causes the problems mainly: 1) They will drastically increase teaching hours (including tutorials), and make it difficult to ocus on research and dministrative responsibilities; 2) The API (Academic Performance Indicators) target - on which teachers are promoted — set by the notification, especially for Assistant Professors, will make promotions impossible; and 3) With the reformulation of the workload, thousands of ad hoc teachers and Assistant Professors will lose their jobs.

The changes hit the promotions of teachers

Because the maximum points that can be got for teaching are 60 per year, but the points will be determined by dividing the "actual hours spent per academic year divided by 10". It means that any teacher who is interested in 60 points will have to teach 600 hours per year or 300 points per semester. In a semester of 15 weeks, this works out to 20 hours a week — a target that will be impossible to meet even if a teacher takes no leave at all, does not fall ill, does not enroll himself in Refresher Courses or do Research Projects." So, 20 hours per week is just four hours per day with two weekly offs, and most people work at least double that!

Teachers insist it doesn't work that way. These four hours are just teaching hours, and doesn't count for all the other work teachers have to do. "Lecturing for 18 hours and tutoring or conducting practicals for an additional 6 hours is madness.

Teachers will not get the time to prepare for lectures and tutorials. Usually, each hourly lecture takes at least 4 hours of preparation." Such move will increase their workload by 50%. It may be noted that "At any top international university, teaching hours are not

more than 6-7 hours per week".

A MHRD Ministry directive issued on May 26 said "the direct teaching-learning hours to be devoted by Assistant Professors (16 hours) and Associate Professors/Professors (14 hours) will remain unchanged", but did not address the complaints about the definition of direct teaching hours and calculation of workloads. It was a trick used by the government for suppression of the teachers' voices.

One day after a protest march by teachers at Jantar Mantar on May 30, the UGC issued a press note reiterating the MHRD directive. The UGC has called a stakeholders' consultation meet on June 6 to discuss Academic Performance Indicator (API) scheme and workload of teachers".
The UGC has invited AIFUCTO for

the discussion. The General Secretary, AIFUCTO has also issued an urgent communication to all the affiliates from across the country to rush the UGC, New Delhi on 6th June, 2016. Expected thousands of teachers may gather at the spot to show the solidarity of AIFUCTO.

# Congress expresses shock, disbelief over NIA 'clean chit' to Pak

New Delhi. June 3: Following the National Investigation Agency's alleged claim that there was no evidence indicating that Pakistan was directly complicit in the Pathankot terror attack, the Congress on Friday expressed shock and disbelief over the 'clean chit' and branded the entire development as a major setback

"It is shocking & unbelievable that NIA has given a give clean chit to Pakistan. Never heard of such a thing before! This is a big setback," Congress leader Shakeel Ahmed tweeted.

The reaction comes in the wake of Director General of NIA Sharad Kumar's interview to an English news channel where he said. "No evidence to show that Pakistan government or Pakistani government agency was helping Jaish-e-Mohammed or Masood Azhar or his aides carry out Pathankot attack."

However, reports have emerged of the NIA chief rubbishing the entire interview asserting that he never gave a clean chit to Pakistan

Earlier, the NIA had said that it has still not received any response from Pakistan on Supplementary Letters Rogatory sent to the neighbouring nation in connection with the probe on the Pathankot air force base

attack.
The Interpol had earlier issued a fresh Red Corner notice against JeM chief Maulana Masood Azhar and his brother Abdul Rauf for their alleged involvement in the Pathankot

According to NIA sources JeM uspect Shahid Latif is the main handler in the Pathankot attack and that his location at the moment should probably be in

Latif was first arrested in 1994, convicted in 1995 and his jail term was over in 2010. He deported to Pakistan after that through the Atari Border.

Masood Azhar, his brother Abdul Rauf and Latif are being touted as the main culprits into the deadly attack on the Indian Air Force base.

Four terrorists were killed when they carried out a suicide attack on the strategic Indian Air Force base in Pathankot during the intervening night of January 1-2. Seven security personnel were also killed during the 80-hour-long gun battle.

## UP DGP on Mathura clashes: Cops killed in unprovoked firing by encroachers

Lucknow. June 3: UP DGP Javed Ahmed said on Friday that two policemen, including an SP, and 22 protesters have been killed in clashes between cops and encroachers that broke out in Mathura district's Jawahar Bagh

area on Thursday evening.
"23 policemen are in the hospital. They were attacked brutally by protesters," the UP DGP told reporters on Friday. The DGP said that so far 124 people have been arrested in the matter. "47 locally-made pistols, 6 rifles and 178 live cartridges have been seized from

the site," he said.
The DGP admitted that cops did not expect that they would be attacked upon when they reached the Jawahar park to evict encroachers. "Two policemen lost their lives and others were injured in unprovoked firing by

encroachers," the DGP said. Ram Vriksha Yadav, one of the leaders of the group, is absconding and the National Security Act(NSA) would be invoked against him, the DGP said. The violence had erupted when police were trying to evict illegal occupants believed to be of Swadheen Bharat Subhash Sena (SBSS), from Jawahar Bagh on Thursday on the directions of the Allahabad high court.
"The activists used not only hand

grenades but also opened fire from automatic weapons after taking position on tree tops," DM Rajesh Kumar had said.
"The wrath of people against

encroachers was such that when they were retreating, they were severely beaten by the public," an official said.

Encroachers described themselves as "Satyagrahis"

The encroachers who call be made accountable for this. It is themselves "Satyagrahis" have dispersed and the disputed minister about it and they should Jawahar Bagh area, spread over 280 acres, is now under police

control. Over two years ago, the group had occupied hundreds of acres of land of Jawahar Bagh on the

pretext of 'dharna'. Their demand Their demands included "cancellation" of election of President and Prime Minister of India, replacement of existing currency with 'Azad Hind Fauj' currency, sale of diesel at the rate of 60 litres for one rupee and petrol at the rate of 40 litres for one rupee. The high court had, acting on a PIL, directed the authorities to vacate the land.

In April, Mathura district administration has issued a notice to the protesters asking them to vacate the land.

The land falls under the horticultural department of the UP government, and attempts by its officials to evict the people had
