Govt bans more than 300 combination drugs sold illegally

New Delhi, March 13: Government has

banned the

manufacture and sale of more than 300 combination medicines sold without its approval. Joint Secretary at the Health Ministry KL Sharma told Reuters that based on responses and assessment of products, more than 300 drugs have been prohibited. Fixed dose combinations are used worldwide to improve patients compliance, as it is easier to get them to take one drug rather than several. But inconsistent enforcement of drug laws in India has led to the proliferation of hundreds of such combination medicines entering the market based on approval from regulators of individual states. Nearly half the drugs sold in the country in 2014 were combination

Laishram Ranbir al, March 13: Days after Imphal Times report on the ailing Pony seen wandering in the streets of Imphal city fails to drew the attention of any government or non-government agencies, R.K. Nimai, consultant to the government of Manipur today said that as of now the state government has no policy for government has no policy for protection or raring of the ageing or ailing Pony.

"As of now the state government is preparing a

Pony Policy and is likely to complete for public circulation by May this year", RK Nimai said in an exclusive meeting

with our two reporters.

It is because of this that Pony cannot be declared as critically endangered species which number is not over 1000, added the consultant to the Govt. of

Manipur said.
On seeing the ailing pony

wandering in the streets of Imphal near state Veterinary Office, Sanjenthong, Imphal Times had not only carry news-report on how the ailing pony is being neglected but also filed written complaint to take care of the pony to the Director of State veterinary and Animals Husbandry department. The Director had assured Imphal Times representative to provide all possible treatment but said that they can no longer keep the pony if the owner failed to turn up by the next day. As said the Pony was seen once more wandering helplessly in front of the State veterinary office on the following day. There is no Veterinary doctor at the State veterinary hospital

However, there are certain critic in the last few years as the animals are seen left uncared in Imphal city.

'Home Department fails to implement Police reformation directives' MIC directs Special Secretary Home to fine Rs

17,500 for non-compliance of its decision

Imphal, March 13: Manipur Information Commission has directed the State Home Department to pay a sum of Rs. 17,500 as penalty over its failure to provide information seeks through RTI by Wahengbam Joykumar.

Joykumar seeks information regarding the failure of the State Home department to comply with the directives of the Supreme Court of india. In an RTI application the

appellant Joykumar asked SPIO/Special Secretary (Home)

to furnish information regarding directions issued by the Supreme Court of India in the matter of State of Guiarat vs Kishanbhai Etc., (2014) 5SCC 108 and a letter issued by the Ministry of Home Affairs, Government of India vide No. 24013/09/Misc./2014-CSR.III dated 24.03.2014.

However, RTI reply copy from the Manipur Information Commission (MCI) in response to an application filed by Joykumar stated that the Home Department failed to provide detail information on his 10points questions.
"The SPIO and FAA/Home
Department stated that information sought by the appellant cannot be provided as SPIO is not directly the custodian of all the documents," reads the RTI

reply copy. It also said that the

Commission directs the SPIO/ Special Secretary (Home) to pay a penalty of Rs 17,500 at the rate of Rs 250 per day within 45 days for not obliging the decision of the Commission and for not furnishing the information within the stipulated time granted by this Commission. The applicant also said that the Home Department as well as Police Department has failed to implement the directives of the order of the Apex Court and Manipur Police officials have failed to make charge sheets and thus no authority have failed to take necessary action against those erring officials. On the other hand, the Govt. of Manipur has availed

members of the Standing Committee constituted to implement the Court's directions with names, designations and contact details. The complete list of instances of acquittal in criminal proceedings examined by the Standing Committee till date and the considerations recorded by it indicating the IPC Sections and/or complete title of Special Laws with relevant Sections applicable to each instance of acquittal may

please be provided. In the application, he also asked to provide information on training materials developed for investigating and prosecuting officials as per the Court's directions along with the name and contact details of the persons / agency employed for designing and developing training materials.

He also sought the number of cases in which departmental action has been initiated against erring police officials and prosecutors till date in relation to acquittals and other

The Department also failed to reply to his question on details of the monitoring mechanism established for assessing the performance of investigation and prosecution officials who have undergone training as per the Court's directions.
