#### Naga accord: Rijiju to respond in Lok Sabha today

ANI New Delhi, March 15: Minister of State for Home Affairs Kiren Rijiju will today make statement on Naga peace accord in Lok Sabha.

The accord was signed in August 2015 in presence of Prime Minister Narendra

Home Minister Rajnath Singh had earlier refuted Rahul Gandhi's claim that he was not informed before signing a peace pact with Naga insurgent group NSCN-IM saying the Congress Vice-President's statement was 'completely false and baseless' and he 'misled' the Parliament.

The Home Minister's reaction came after the Congress vice president told the Lok Sabha that Singh was not aware of Naga peace accord which was signed in August 2015

Launching a scathing attack on Prime Minister Modi in Lok Sabha, Gandhi said the former released Pakistan from a small 'cage' in which it was put after the 26/11 attacks by his sudden visit to Lahore and bringing a 'fair and lovely' scheme to launder black money.

He alleged that Prime Minister Modi did not listen to anyone's opinion, including his ministers and party MPs, on issues like his visit to Pakistan and the Naga accord.

Imphal, March 15: The ASI and SI recruits who are undergoing training at the Manipur Police Training College (MPTC), Pangai today morning protested by shutting down the main gate of the Training Center on the alleged report of collecting money from them by some people on the pretext that the passing out parade would be

Speaking to the media persons, a trainee alleged that Director of MPTC H Chandramani have not made any arrangement for holding the passing out parade for them despite their training period have surpassed over one year. The recruits went into agitation mode today morning as the Director failed

to fix the date for holding the passing out parade after having repeated conversation with the representative of the recruits and the Director.

The trainee protestors alleged media persons that the Director have been collecting a sum of 500 rupees in addition to the ration money of 1000 rupees insuring to provide good food which does not happen, but instead the Training Center has been turned into a business center by forcibly selling books, lottery tickets etc. Meanwhile, another 1600 rupees has been collected on the excuse that shoes would be provided. The recruits alleged that in

## Irom Sharmila scholarship to JNUSU, Rohith Vemula

New Delhi, March 15: The 2016 Irom Sharmila Scholarship was jointly awarded to Rohit Vemula (posthumously) of the Ambedkar Studies Association, Hyderabad

Central University and Jawaharlal Nehru University Students' Union yesterday. The cheques for scholarship was received by the Joint Action Committee on behalf of Vemula and JNUSU president Kanhaiya Kumar on behalf of the students' body. According to Ajay Patnaik, JNUTA president, who handed over the scholarships,

"the award goes to them as student representatives/ bodies seeking to strengthen constitutional democracy by upholding the constitutional ideals of fraternity, equality and right to life, and inspiring many others across the country.

The Irom Sharmila Scholarship was instituted by a faculty from Delhi University in 2012. Professor Nandini Sundar. Faculty of Social Science, DU has set up the scholarship. It is open to any post graduate student (MA-Phd) enrolled in any educational institution in Delhi in any subject who

comes from an area with internal armed conflict, including Northeast, Kashmir and Central India.

The award is based on a combination of financial need, academic merit, contribution to society and suffering as a result of armed conflict. The scholarship is a lump sum of Rs. 50,000 (Rs 60,000 if shared). Sharmila also extended her solidarity via a video message that was played on the occasion where she said, "I think building a university is just like a temple for young minds. So why should government or concerned authority restrict their thoughts and debates? I extend my solidarity to students' democratic, progressive movements and voice of dissent in university campuses to justice for Rohith Vemula and other student." A 22-year-old Kashmir student became the first person to receive the scholarship in 2013. Iymon Majeed, a student of MA political science from Jamia Millia Islamia has been writing about experience of Kashmir with Armed Forces (Special Powers)Act 1958 and militarism

#### JNU panel recommends rustication of Kanhaiya & 4 other students

New Delhi, March 15: A high-level committee of JNU has recommended rustication of Kanhaiya Kumar, Umar Khalid, Anirban Bhattacharya and two other students for their alleged role in a controversial event inside varsity's campus on 9th February. Anti-national slogans were allegedly raised at the event. Quoting sources, PTI reports that a decision on the recommendations by the panel will be taken by the Vice Chancellor and Chief Proctor of JNU after a thorough scrutiny

of the suggestions. A meeting of the university's

top brass chaired by the Vice Chancellor yesterday discussed the report. Following this, the varsity issued show-cause notices to 21 students including Kanhaiya and Umar, who were found guilty of having violated its discipline norms.

The committee was formed on 10th February to probe the event organised to protest hanging of the Parliament attack convict Afzal Guru. Kanhaiya, who was arrested by Delhi police, was released on bail on 3rd March, while Umar and Anirban are still in judicial
