The nine persons were reportedly killed in police action and some killed while burning the houses of the elected representatives of the state legislative assembly and some reportedly killed in police action while they were trying to storm Churachandpur Police

During the total shut down almost all shops and business establishment including schools and colleges remained shuts. No vehicles either private or the government were allowed to move around the streets of Churachandpur town. Even military vehicles were not

JNU row: Delhi Court to pronounce order on Umar Khalid, Anirban Bhattacharya's bail plea today

Agency New Delhi, March 18: A Delhi Court will on Friday

pronounce its order on the bail plea of Jawaharlal Nehru University (JNU) students Umar Khalid and Anirban Bhattacharya, accused of raising anti-national slogans in the varsity campus on

February 9.
During the hearing on Thursday, the Delhi Police counsel opposed Umar Khalid's bail plea and Anirban Bhattacharya's bail plea and stated that they not only depended on the video footage but also relied on the

witness against both of them. However, the counsel of the two JNU students maintained the Delhi government's report suggested that the video was tampered with while asserting that citizens have the right to criticise the government and the same can't be termed as sedition. Earlier, a high-level internal committee of the JNU had found 21 students guilty of holding a controversial event on the campus last month, which had led to the custody of JNU students' union president Kanhaiya Kumar

The committee has reportedly suggested that Kanhaiya along with four other students, be rusticated from

the varsity. Kanhaiya, however, said on Thursday that there was no mention of rustication in the report submitted by the panel. The committee, in its unanimous report submitted to Vice-Chancellor M Jagadesh Kumar, has accused the students of violating university norms and rules by organising an event in the memory of 2001 Parliament attack convict Afzal Guru.

I have been suspended for so long without any charges, says JNU student

Pursuing her Masters in International Relations from JNU, Aishwarva Adhikari was one of the eight students who were academically debarred by the high-level inquiry committee that looked into the February 9 event on the

Ms. Adhikari was left "shattered" and "angry" over her suspension after it came to light that she was not named in the committee's eight-page report that was submitted to the Vice-Chancellor on March 11. Parts of the report were also provided to the students.

"I have been suspended for so long without any charges against me. It has been an extremely emotionally

New Delhi, March 18: tormenting phase. I am in the final semester of my Masters and I am supposed to attend classes, but because of the debarring order I was not even able to do that," said Ms. Adhikari.

"What has added to my anger is the fact that my name is not even mentioned in the committee report that is supposed to have probed the February 9 event. I want to ask the administration, why was I suspended for such a long time then?" she added. A member of the university's

GSCASH (Gender Sensitisation Committee Against Sexual Harassment) since April 2015, Ms. Adhikari has been actively engaged in raising important issues on campus, including the debate creating a fair atmosphere for sexual harassment victims to come out and report.

According to Ms. Adhikari, her name was included in the suspension list like that of Kanhaiya Kumar, Anant Narayan, Rama Naga and Ashutosh Kumar because the administration wanted to "target student voices on the campus". The eight-page-long report of

high-level committee was based entirely document trail. Since none of the students, who were debarred in connection with the event deposed in front of the committee, the students have rejected the report calling it a "sham".

Boy kidnapped for 10 crore, murdered

Courtesy TNN Hvderabad, March 18: Aday after the body of a class X student from Begum Bazar was found stuffed in a carton and abandoned near an eatery in Secunderabad, police have reportedly picked up three suspects for their role in the gruesome murder from Vijayawada. The suspects were picked up based on mobile phone tower location. The boy was kidnapped for a ransom of Rs 10 crore, but he was killed before the family could arrange the money.

Around 11 pm, Gopalpuram

police were alerted about a boy's body, in a crouching position with limbs bound by wires, found stuffed in a carton and abandoned near Alpha Hotel near the Secunderabad railway station. A team was dispatched to the location and other police stations in the city were intimated about the discovery.

Shahinayathgunj police responded and sent a profile of a 15-year-old teenager, Abhay Madhani, who went missing from Begum Bazar at 3 pm. Earlier in the day, the family members had received a ransom call too. Police got confirmation that the body was that of Abhav.

The Gopalpuram police contacted their Shahinayathgunj counterparts and it came to light that Abhay had left his residence at 3 pm to get tiffin, but did not return. At 5 pm, the family members

approached Shahinayathgunj police and lodged a complaint. As the family members were making frantic searches for Abhay they received a ransom call from an anonymous person. Abhay's father Raj Kumar spoke to the abductor, who, in an intimidating tone, asked the businessman for Rs 10 crore in exchange for Abhay. The call

was recorded.

A CCTV footage showed the boy pillion riding a scooter driven by an unidentified man near his house. Kumar, who owns a plastic

company, begged the caller to release his son and expressed his inability to mobilise Rs 10 crore. In his phone conversation with the abductors of the boy, Kumar expressed his inability to mobilise such a huge sum and, instead, offered Rs 5 lakh in cash and gold worth Rs 10 lakh.

The kidnapper shot back, "What rubbish are you talking. If you want safe return of your son, arrange at lease Rs 5 crore and send the cash to the Secunderabad railway station and your son will be released by 6 am on Thursday." By 11 pm, the boy was smothered to death. His body was bound by wires, put in a carton and abandoned near Alpha Hotel. The family members of the victim were shattered on hearing the news.
