SDPO of Tousem Sub-Division found dead

Imphal, March 2: The
Statem Sub-SDPO of Tousem Sub-Division was found dead at his residence today morning. The deceased ha been identified as Nehemiah Jajo Chodang (58) son of Khaprang Chadong of Grihang Village presently staying at Nagaram D-Block.

According to reports, he was last seen on 25 Febuary and that most of his family members were staying outside Manipur. When family members enquired about him at his office it was found that he had taken leave for 3 days. Today morning when his relatives checked his present residence it was found locked from outside with the SDPO lying on the sofa inside. The dead body was highly decomposed and bore injury marks on his head. Police has taken up a case regarding the death and investigation is already underway.

"How could she be arrested when her protest has not yet completed even 24 hours? ", asked Sundarlal, a youth who reached the BT park after her arrest. She was rearrested at around noon.

Sharmila, known as the Iron Lady of Manipur, began her fast in November 2000 after ten people were killed in a shooting at a bus stop at Malom in Imphal West district Manipur. Activists blame the army for the killings.

After border fencing completion, Manipur total geographical area will be reduced to 21,356 Sq. KM – ICHAM

Imphal, March 2: If the ongoing fencing works along the Indo-Myanmar Border in completed without any intervention of the state government then the total geographical area of the state will be reduced to 21,356 Sq. Km. This was stated by founder advisor of Information Centre for Hill Areas Manipur (ICHAM) during a press meet held at his residence at Uripok Yambem Leikai, Imphal.

At present government record showed that the present geographical area of the state s 22,356 Sq. Km. This means if the ongoing border fencing works being underway without proper demarcation, has been completed, a total of around 1000 sq. Km will be

The matter was already put to the notice of the state government representative as well as to the Central government authority during July 2013 after ICHAM and the villagers of the border area had raised strong objection for encroaching to Indian Territory. Following that the objection a joint political party committee along with central government authority led by Joint Secretary Home Sambhu inspected and agreed to stop the fencing work until a proper the fencing work until a proper demarcation is conducted in the presence of state government as well as the Villagers, said Nongthonbam Rajendro aka Boy, President of ICHAM during a press

Rajendra further said that a team of ICHAM along with representatives of the Committee on Protection of Land in Border Fencing recently visited the border area and were surprised to see the border fencing survey being carried out by India government authority and the Myanmar govt. authority without the presence of any state government representatives. Those conducting survey from the side of Myanmar were accompanied by a DC and village chiefs of their border villages, and when the villagers of Indian side objected the encroaching of land, the Mayanmar authority had told them to talk with the Indian authority, added Rajendro

"After the incident a team of ICAM and the Committee on Protection of Land in Border Fencing went to the disputed border site during February 22 to February 24 and inspected 8 border pillars located along N. Satang Maring Villages and Lamlong to other nearby villages. During the inspection the border pillar No. 87 & 88 were found to have been encroached by around 21/2 Km. towards Indian Territory", Rajendro said with frustration. He further said that the site was once a camp of the 95 Battalion of BSF till 1988, which means that the Indian security had proper knowledge of whether the Indian territory are being

encroached by Myanmar or

Ngachonmi Ramshang, Convenor, Committee on Protection of Land in Border Fencing while speaking during the press meet said that the committee had submitted several memorandum time and again since 2013 till this year to pay attention to the encroachment of India's Territory by the Myanmar Govt in the so called border fencing work but never taken up appropriate action towards

Blaming the Okram Ibobi Singh led Government, Ngachonmi Ramshang said that the government seem to have no interest to the grievances of the border villagers.

"If the government does not have interest in protecting the land than what is the use of their stand to the territorial integrity of the state? It seems like the state government is interested only to quarrel with others but did not border to protect the boundary of the state", Ngachonmi Ramshang added.

Paona and Thangal bazaar shops begin indefinite shutdown from today

Imphal, March 2: All the business shops of the Paona bazar and Thangal bazar downed the shutters indefinitely from today. The shutters decision of shutting down the shops was taken by Committee on Bazaar Business Community of Paona Bazar and Thangal Bazar demanding a review of the state cabinet decision which declared no parking zone at the Paona and Thangal Keithel area. Due to the shutdown, a large number of the general public were affected, however the three Ima Keithels remained open for business as normal.

Speaking to the media persons, Huirem Badalkumar-Convener of the Committee on Bazaar Business Community of Paona Bazar and Thangal Bazar said that the Committee itted a memorandum to



cabinet decision before March 1, however there is no any positive responses come the government prompting the committee to take the step of shutting down the shops indefinitely

He further stated that crowding of the road of the Paona and Thangal markets is not because of the customers or the shops but due to the failure of arrangements by the state government transport department. The rule made by state government is ken by the state

HC to pronounce its order on Kanhaiya's bail plea in sedition case

New Delhi, March 2: Delhi High Court is likely to pronounce its order today on JNU Students Union President Kanhaiya Kumar's bail plea in the sedition case Justice Pratibha Rani had reserved the order on Monday after over three hours of hearing. The JNUSU President is accused of raising anti-India slogans inside JNU campus during an event organised on February 9.

Police say, Kanhaiya is not cooperating in the probe and even came out with contradictory statements in joint interrogation by Intelligence Bureau and Delhi Police. Kanhaiya's advocate Kapil Sibal claimed that anti-India slogans inside the campus were raised by people with covered face.

Kanhaiya has also distanced himself from Umar Khalid and Anirban Bhattacharya, the two other accused arrested in the case. Kanhaiya, who is currently in Tihar Jail under judicial custody, was arrested on February 12 in connection with the case.
