Boy lost life while saving motorists from rampaging truck

Imphal, March 28: One person was killed in a road accident today at khabeisoi mamang leikai. The accident occurred today at around 11 am under Heingang police

The person killed in the accident has been identified as Boboi Mayangmayum, age 21, s/o Ayub Khan of Khabeisoi Mamang Leikai. Boboi was run over by one water tanker truck. According to a report from the spot, Boboi lost his life while trying to save two girls travelling in one Activa who were about to be run over by one water tanker truck. The tanker earlier had struck a car which was pulled over by the locals for collecting donation on the road in connection with the Yaoshang festival (Holi). The truck ran over Boboi along with the Activa where he lost

his life. During the accident the

girls who were travelling on the Activa escaped without any injury. The driver of the water tanker bearing registration number MN05-3744fled from the site of the accident, Locals of Khabeisoi Mamang Leikai took out an agitation to bring out the accused driver. Heingang Police have registered a case against the incident. The very water tanker truck reportedly struck 3 vehicles before running over the deceased person.

After Arunachal, Uttarakhand, crisis now surfaces in Manipur

Imphal, March 28: After Arunachal Pradesh and Uttarakhand, a political crisis is now looming over the Congress Government in Manipur, where 25 dissident party legislators are demanding a reshuffle of the Chief Minister Okram Ibobi Singh's cabinet.
In the 2012 assembly polls,

the Congress had bagged 42 seats in the 60 seat Manipur Assembly. Their strength went up to 47 after five MLAs from Manipur State Congress

Congress on April 3, 2014 The Congress dissidents have served an ultimatum to Ibobi Singh, asking him to either induct them in the ministry or face consequences. The dissidents have been demanding a major reshuffle for months so that they could be inducted into the cabinet. Congress president Sonia Gandhi has summoned Ibobi Singh to New Delhi for

discussions.

Party (MSCP) joined dissidents have hinted they may join the BJP, if their demands were not met. Sonia Gandhi has reportedly

taken a serious note of the demands of the dissidents, whose number is said to be Senior Congress leader Kapil

Sibal, while criticising imposition of President's Rule Uttarakhand, yesterday hinted that the saffron party's next target could be Manipur.

Manipur is expected to go to polls in February 2017.

Independence of Manipur only topic for dialogue with India: RPF

Imphal, March 28: When Manipur was flourishing as an independent Nation State more than two thousand years ago with its unique administrative setup, customs and traditions scripts, language as well as social norms, the notion of India as a nation has not even taken root; claims a press release of the proscribed Revolutinary People's Front (RPF) signed by Roben Khuman- Secretary Publicity, Reiterating the fact that Manipur was forcefully annexed to India against the wishes of the King, People and the universal laws, the release states that RPF is carrying out an armed struggle against the nation to win back

the independence snatched away from the people by an Imperialist nation as such an armed struggle is sanctioned and recognized by the UN Resolution 1514 (xv) of 14 Dec. 1960 Declaration on the Granting of Independence to Colonial Country and People which states that "All peoples have other right to Self Determination; by virtue of that right they freely determine their political status and freely pursue their economy, social and cultural development," While the U.N General Assembly declared on December 12, 1974 that the Struggle of peoples under colonial and alien domination and racist regimes for the implementation of their Right to

accordance with the principles of International Law & the armed conflicts involving the struggle of peoples against colonial and alien domination and racist regimes are to be regarded as armed conflict. The call to lay down arms of North Eastern revolutionary groups as a prerequisite to peace talks by Union Home Minister Rajnath, therefore reveals him to be an imperialist without regards for the sensibilities, customs and protocols, and that the only topic on which RPF will entertain a dialogue with India is regarding the Independence of Manipur; the release concludes.

Congress moves high court against Prez rule in Uttarakhand

New Delhi, March 28: The Congress party moved the Nainital high court on Monday against the imposition of President's rule in

The RIP-led Centre cited a constitutional breakdown while imposing President's rule in Uttarakhand on Sunday, a day before Harish Rawat was to take a floor test in the state assembly to prove his

majority.

The Congress had said on Sunday it will challenge the decision in court and show that the Narendra Modi dispensation is out to "destabilise" governments in all the states ruled by the party. Senior party leader Kapil Sibal had said that President's rule v imposed a day before the floor test as the Centre knew that chief

minister Harish Rawat would be able to prove his majority.

"We will explain the law to them in court. We will show the court that the people in the central government are the ones responsible for destabilising every state which is under Congress rule because their policy is to have 'Congress mult Bharat',' he had said.

As Congress cried 'murder of democracy' after losing power in

second state after Arunachal Pradesh, Union finance minister Arun Jaitley countered by accusing the state government of "murdering" provisions of Constitution every day since March 18 when it "lost" majority in the assembly.

Speaking to media shortly after President's Rule was imposed in the speaking to media shortly after 1 research struct was imposed in the lill state, he said there were "cogent, relevant and extremely important grounds" on which the Union Cabinet came to the decision.

"It was not only appropriate but the demand of the time that such an immoral government did not continue in Uttarakhand which has lost its majority. There was complete breakdown of the Constitution in Uttarakhand," he said.

Citing other reasons for dismissing the government, he spoke about the "hard evidence" of Rawat offering allurements to win over MLAs to change the composition of House, discriminatory use of anti-defection law by the Speaker with regard to his action against rebel MLAs of BJP and Congress.

Jaitley said Governor Paul had also mentioned that he had "serious doubts" over what happened in the assembly on March 18 and said his report played a key role in the Cabinet's decision.

Asked about criticism, especially by BJP, of the governor's decision to give Rawat nine days to prove his majority, he said there was no reason for him to arrive at such a conclusion after going through his

The governor had repeated asked the chief minister to convene the assembly in two-three days for floor test but he deliberately prolonged it by insisting that he would do so only on March 28, Jaifley said.

"He wanted to use the time period for allurement, horse-trading to change the composition of the House... During each of the nine days, provisions of the Constitution were violated," the Union

About the sting operation against Rawat, he said, "This is the first time that there is hard evidence about horse-trading by a chief minister who has been caught on camera."

On the Congress charge that BJP was destabilising its governments

he said the opposition party should put its house in order as it was a crisis created by Congress itself.
"There was rebellion in Congress as the party high command had

been refusing to even meet their leaders," he said.
