Woman found dead at Uchiwa

IT News Imphal, May 19: A married woman was found dead in a suspicious manner inside the pond of a fish farm situated at Uchiwa Awang Salam Thamna Houbi Leikai under Mayang Imphal Police station today morning.

The deceased woman was identified by her uncle and grandmother as Wahengbam Echan Devi

(23), d/o late W Birkumar Singh of Sekmaijin Khunou Mavai Leikai.

According to report, the dead body was found tied to a rope, one end of which was lying across the road. When locals who were taking their morning walk came upon the rope and tried to pull it out of the pond they discovered the dead body with a noose on her neck in the water.

Family members of the deceased said that the victim is a divorcee and presently staying at her parental home for around one vear.

Police is investigating the nature of the death. It is suspected that the victim was raped and murdered and police has sent the body for autopsy.

Suspected NSCN-IM cadres ambushed BSF troopers

Imphal, May 19: Armed assailants suspected to be cadres of NSCN-IM today ambushed a convoy of BSF who were on foot patrol at Melei Lampak Chingon under Heirok Police station in Thoubal district using rocket launchers and sophisticated machine guns Miraculously none of the BSF troopers sustained any injury in the deadly attack. Report said that the BSF troopers too retaliated and the gun fight continued for around minutes. Later, additional security force of Thoubal Police Commando reinforced and the armed cadres reportedly fled the area. The BSF personnel belong to

Cong ousted in Assam, Kerala; Jaya, Mamata retain power

New Delhi, May 19: BJP was today set to create history in Assam by ousting Congress which also lost Kerala to the Left front while incumbents AIADMK and Trinamool Congress retained power in Tamil Nadu and West Bengal for a second consecutive term. The tiny Union Territory of Puducherry appears headed for a hung house with the ruling AINRC and Congress-DMK alliance locked in a close

Assam voted for change with Congress, which had been in power for the last 15 years, being routed by the BJP-led alliance which is ahead in 80 out of 126 seats.

Marking a new surge, BJP, which had five seats in the last elections, was on its own leading in 56 seats now. Its allies AGP and Bodo People's Front were ahead in 15 and 12 constituencies. The Congress, which had bagged 78 seats in the last elections, was struggling by leading only in 27 seats. AIUDF, led by Badruddin

Ajmal, was leading in 09 seats while Independents were ahead in 6 constituencies.

The major surprise in the Assembly elections in four states and Puducherry was a strong show by AIADMK, which several exit polls had projected to lose

Bucking tradition, the Jayalalithaa-led party was well on way to retaining power for a second term in a state which had not returned a ruling party to power since 1989. But it was also not a washout for the opposition DMK, which put up a reasonably good show by leading in 87 seats as against AIADMK's 130 in a house of 234. AIADMK has won one

seat. The Congress was ahead in 10 seats and IUML, a DMK ally, PMK and PT were leading in one seat each. The third front of parties headed by Vijaykant's DMDK has failed with even the actor himself trailing in his seat.

KCP Poirei Meitei Lup imposes curfew in the surrounding of Congress and BJP candidates for IMC election

Imphal, May 19: Kangleipak Communist Party Poirei Meitei Lup has imposed curfew at the surrounding of all congress and BJP candidates of the upcoming IMC election accusing both the parties for playing with the sentiments of the people of the state. In a statement issued by the outfit, it is stated that BJP which is in power at the center and the Congress are playing

blame game instead of doing their work to get approval of the 3 ILPS Bills which is pending for around 8 months It said the voice of the people is not listen by the state government and is ignored by the central government. Are Manipur's 3 Bills with Rashtrapati Bhavan or PMO?

Whether or not the three bills - the Protection of Manipur People Bill, 2015, the Manipur Land Revenue and Land Reforms (Seventh Amendment) Bill, 2015, and the Manipur Shops and Establishments (Second Amendment) Bill. 2015 - unanimously Establishments (Second Amendment) Bill, 2013 - unanimously passed by the Manipur Assembly are constitutional is to be decided not even by the Parliament but by the Supreme Court of India, if the bills become an act. The present complexities arising out of the three bills are primarily not constitutionally and legally complex, but the process of converting the bills into act which is not at all difficult is being made to appear so confusing, all because of the very fact that where the bills, whether in Rashtrapati Bhavan or PMO, are at present is still not discussed and less known to the common people of

The all political parties' delegation, which was supposed to reach New Delhi by May 16 but has not yet materialised so far, is still unclear whether who – whether the state's Chief Minister Okram Ibobi Singh or Manipur Pradesh Congress President T.

N. Haokip – will lead it. If it is not led by the elected Leader of the people of Manipur, notably the Chief Minister of the state, then, how will such delegation show seriousness over the matter regarding the bills to either the President of India or the Prime Minister of India? What will happen if the Prime Minister Narendra Modi asks the delegation – where is your Leader, the Chief Minister? Moreover, why should the state presidents of other political parties be a part of the delegation not led by the state's Chief Minister but by the president of one of the political parties? Will BJP Manipur President Bhabhananda Singh, who already left for New Delhi a few days after he became the state's BJP President, allow himself and his party to be a part of the delegation led by the state president of another political party The question, which is a product of why the Chief Minister, if he does not lead at all, would not like to lead the delegation, remains is - who will execute the role of the Chief Minister when the Chief Minister goes to New Delhi and stays for a week or more to ensure that not only meeting the President or the Prime Minister takes place but also the conversion of the

bills into act becomes a nearer possibility? Will a senior Cabinet Minister or Deputy Chief Minister take the temporary charge of the Chief Minister? And, if so, then will the Chief Minister Ibobi Singh be comfortable enough to give a time of a week or weeks to Deputy Chief Minister to take the charge? Will the entire departments, particularly Department of Personnel, under the Chief Minister be smoothly functioning under the Chief Minister in-charge for a week or weeks while the Chief Minister, if away, is to be in New Delhi for exerting the federal rights, enshrined in the Constitution, to ensure the bills to become act?

The larger question is - who is to be blamed and by whom for the delay of the conversion of the bills into act? If the bills are considered to have been sent by the Governor of Manipur to New Delhi, then it is to be presumed that they have been sent to the Rashtrapati, and therefore there needs an official acknowledgement of the receipt of the bills sent by the Governor of Manipur from the Rashtrapati Bhavan. If so, then the bills are firmly understood to have been placed in the Rashtrapati Bhavan.
