Need for a different approach

You know you have an enduring problem in your hands when the first thing your child enquired after waking up is whether there is a bandh or blockade announced for the day. The uncertainty and distortions in the daily routine has begun to run so deep that most school going children have given up on their daily routine that was supposed to instill discipline and shape their future. What is more worrisome is the fact that the constant bickering and incessant chants of separatist ideologue have started to seep into their young minds. There are also an increasing number of people coming out with their opinions against the incessant disruptions in normalcy, raising the question of implementing an alternative method o pressurizing the state government rather than the steps being employed at present which is evidently doing more harm to the cause of enforcing the implementation of the LIPS in the state. What about inconveniencing the elected representatives of the people rather than the public themselves; as a prolonged stifting of the general public will eventually give rise to animosity and negative impact on the issue as for most of the people in the state, wasting a days' work would often mean a step closer to starvation, not to mention the immense loss of revenue for the already fund starved state. Who are we really targeting when we prevent a sick or wounded person from availing that much needed and vital medical help because we are frustrated at the inaction or indifference of the state government? Have those officials of the organizations spearheading the agitations and blockades ever considered the ever growing feelings of resentment against the methods, which are almost always destructive, being used to demand their various issues? What difference is there left if the agitating parties are getting immune to the concerns and condemnations of the common people- the very point for which agitations are being organized against the state government. The level o frustrations of the common people can be gauged by the fact that quite a few individuals have even come out to state their objections against the bandhs and blockades which have become so regular that there is now an overlapping of upto three or four bandhs and blockades on the same day, albeit

for different issues which might be genuine. The growing consensus of the common public is that there has to be another way of drawing the attention of the state government and, or putting pressure to take up issues other than bringing the state to a grinding halt. The present system has to go, and with it the ingrained habit of mindless destruction and mob culture. It is time to adopt a posture of controlled aggression so that the interests and economic conditions of the common public is affected to the minimum. The state government also should consider the various demands and take up timely action for the deserving issues without delay or fear of public opinion. A good point to start is by increasing communication and transparency.

National and International News Islamic states blasts kill almost 150 in Syrian government-held cities

Reuters Beirut, May 24: Bombs killed nearly 150 people and wounded at least 200 in Jableh and Tartous on Syria's Mediterranean coast on Monday in the government-controlled territory that hosts Russian military bases, monitors and state media said Islamic State claimed responsibility

for the attacks in the cities that have up to now escaped the worst of the violence in the five-year-old conflict, saying it was targeting members of President Bashar al-Assad's Alawite minority. The Britain-based Syrian

Observatory for Human Rights said 148 people were killed in attacks by at least five suicide bombers and two devices planted in cars. State media had said 78 people had been killed in what is Assad's coastal heartland

The attacks were the first of their kind in Tartous, capital of Tartous province and home to a Russian naval facility, and in Jableh in Latakia province, near a Russianoperated air base. The Kremlin said the blasts

underscored the need to press ahead with peace talks after the collapse of a Feb. 27 ceasefire in April due to intensifying violence in a war that has killed at least 250,000 people.

"This demonstrates yet again just how fragile the situation in Syria is. And this one more time underscores the need for new urgent steps to continue the negotiating proces Kremlin spokesman Dmitry Peskov

told journalists. Russian President Vladimir Putin reiterated his readiness to fight with

One of the four blasts in Jableh happened when a man walked into a hospital emergency department and blew himself up. Another blast was at a bus station. The Tartous bombs also targeted a bus station the Observatory and state media said.

Younes Hassan, a doctor at the Jableh hospital, said he heard an explosion at the bus station, followed less than a minute later by the hospital blast. "Everything went into emergency

mode, wounded people began arriving," he told Reuters by phone. The International Committee of the Red Cross condemned this latest attack on healthcare.

The Tartous explosions occurred in quick succession, a driver at the bus station said. "People began running but didn't

New Delhi, May 24: Uttarakhand chief minister Harish Rawat was on Tuesday questioned by CBI in connection with a probe into the sting operation involving him

Rawat accompanied by some supporters and an MLA arrived at the CBI headquarters at 11am. The CBI had last week rejected the the state government's notification withdrawing the nod for probing the case which was given during President's rule. The Uttarakhand high court also did not stay the CBI probe as requested by Rawat.

CBI had said the notification was rejected after taking legal opinion, which said there was no ground for its withdrawal and it was "not legally tenable".

'11 dead in Myanmar landslide, many missing'

Yangon, May 24: At least 11 people died in a landslide in a remote jade mining region of northern Myanmar with many more feared missing, authorities said today, in the latest deadly incident to hit the shadowy industry

"We have found 11 dead bodies so far. When the landslide happened, about 50 people were searching for jade," Nilar Myint, a local official from Hpakant in Kachin state, told AFP, adding that the rescue operation was ongoing

a statement posted online by the group's Amaq news agency, saying its fighters had targeted "gatherings of Alawites".

A second statement from the militant group said the attacks were carried out in a government-held area "so they experience the same taste of death which Muslims so far have tasted from Russian (and Syrian government) air strikes on Muslim towns."

Amaq said 10 Islamic State members died in the attacks, 5 in Tartous and 5 in Jableh.

Svria's Information Minister Omran al-Zoubi said in an interview with Ikhbariya that terrorists were resorting to bomb attacks against civilians instead of fighting on the front lines, and vowed to keep battling them. The government refers to all insurgents fighting against it as terrorists. The Observatory said an area of

Tartous hosting internally displaced Syrians near a blast site was briefly attacked by government supporters in reaction to the bombings. Some tents were burned but nobody was killed. Tartous governor Safwan Abu Saadah told Reuters reports on social media about refugees being shot were not true. He said some Tartous residents had gone to refugee areas to protect them from

Bombings in Damascus and the western city of Homs this year killed dozens of people and were also claimed by Islamic State, which is fighting against government forces and their allies in some areas, and separately against its jihadist rival al Qaeda and other insurgent groups. Latakia city, which is north of

Jableh and capital of the province, has been targeted on a number of occasions by bombings and insurgent rocket attacks, including late last year.

Government forces and their allies have recently stepped up bombardment of areas in Aleppo province in the north, which has become a focal point for the escalating violence. Insurgents have also launched major attacks in that area.

The only road into rebel-held areas of Aleppo city has suffered a week of increasingly heavy air strikes. Zakaria Malahefii, a senior official in the rebel group Fastaqim that operates in the Aleppo area told Reuters the road was bombarded again on Monday and was dangerous to use.

He said Iranian-backed fighters who are supporting government forces, were mobilising in the southern Aleppo area. France's Foreign Ministry called

the Tartous and Jableh bombings "odious" and said violence from all sides must stop if a political transition is to take place.

SC refuses to ask Maharashtra to totally cut water supply to liquor industry

New Delhi, May 24: The Supreme Court on Tuesday refused to direct the Maharashtra government to completely cut water supply to distilleries and breweries in the drought-hit regions of the state.

A vacation bench of Justices P C Pant and D Y Chandrachud pulled up the petitioner for approaching the apex court for a complete ban on water supply to the liquor manufacturers, saying the Bombay High Court has already passed an interim order in this regard.

"Why are you coming against an interim order of the high court? The high court has already allowed 60 per cent, now what do you want? These are all policy decisions. There has to be a balance. the bench said

The counsel appearing for petitioner Sanjay Bhaskarrao Kale, said the entire region is severely drought-prone and there is a policy in this regard. To this, the bench said these are all policy

decisions and the court's interference will be like taking over governance.

The apex court dismissed the petition as withdrawn after the counsel agreed to withdraw the plea. The court, however, granted the petitioner the liberty to approach the high court. The Aurangabad Bench of the Bombay

High Court had recently asked the state government to curtail water supply to the liquor industry by 60 per cent from May 10, an order which will be operational till June 27.

The plea filed in the apex court had sought that instead of a curtailed water supply, there should be no supply at all as the entire region is facing acute water

shortage. The petition had said that people were dying in the region due to the shortage of water and there is a limited water stock available.

The counsel for the netitioner had said people were being deprived of drinking water as it is being given to the liquor industry. Earlier, the Bombay High Court had

also asked the Maharashtra government to cut supply to other industrial units in Marathwada by 25 per cent after May 10.
