Eight girl students, who were injured and admitted at RIMS following yesterday's protest at Keishampat Junction where water cannon were used to disperse the student protestors, came out of the

protest at Moirangkhom near Krishnapremi oil station at around 1 pm.

The students carried out the protest by covering their mouths with black scarves. Later, a team of Imphal Police personnel picked up the students from the protest site and were taken into custody.

Meanwhile, two student

MCPCR appeals authorities to use minimum force to control agitation by young people

Imphal, May 30: The Manipur Commission for Protection of Child Rights (MCPCR), while acknowledging the crucial role being played by security forces police in maintaining law and order situation of the state amid the present ongoing agitation. in which students of schools and higher secondary schools, who are young girls and boys under the age of 18 are the main protestors, considers to appeal to all the stakeholders and authority not to adopt wide systemic institutionalized physical abuse and create psychological damage of the young people that will give long lasting negative impact in their future

In a press statement the Commission opined that the strategy and approach for controlling the children protestors must be different from adult targeted ones.

"As a matter of fact the very interpretation of "Minimum Force" needs to be redefined and reviewed contextually. For that matter, lathi charge, tear gas, shells and rubber bullets should not be used arbitrarily and abruptly against the children, and ordering to use such dangerous and deadly means as minimum force without justifiable ground realities against the young children is unwarranted", Chairperson of the MCPCR. SK Sharma said The statement said if required, the security forces should use other less injurious means such as repeated convincing warning through loud speaker, ensuring adequate barricades, water cannon may be an option as last resort, while encountering the voung children. The young children. The proportionate force to their tender age and their probable strength should be taken into consideration before resorting any violent means. There should be always arrangements for ambulance and first aid along the side of such confrontation The underlying principle is-our security forces and police should be rather a child friendly and Protective Force than hostile force unleashing devastating impact to right to life and the rights of the child to freedom of association and to freedom of peaceful assembly. Excessive and disproportionate use of force on children and

young students is unbecoming in a democratic country like India, a country which ratified the UN Convention on Rights of the Child and where Juvenile Justice (Care and Protection of Children) Act, 2015 is in force. A groundbreaking training manual for Police and Security Forces, Juvenile Justice, Human Rights and decent mob control standard must be introduced. It is worth to remind here that the Section 75 (Punishment for cruelty to Juvenile or Child) of the Juvenile Justice (Care and Protection of Children) Act 2015 states that; -"whoever, having the actual charge of, or control over, a child, assaults, abandons, abuses, exposes or willfully neglects the child or causes or procures the child to he assaulted abandoned abused, exposed or neglected in a manner likely to cause such child unnecessary mental or physical suffering, shall be punishable with imprisonment for a term which may extent to three years or with fine of one lakh rupees or both".

Incessant downpour worsens Imphal-Jiribam highway

IT News Imphal, May 30: Incessant heavy downpour in recent days has worsened the already dilapidated National Highway 53 (Imphal-Jiribam). A recent journey from Imphal

to silchar brought to light the fact that the worst sections of National Highway are found nowhere else but in Manipur. Even though the Centre is spending huge amount of funds to complete the repairing work along Imphal-Jiri road, the condition of the highway continues to remain in its worst state due to poor progress in work and frequent occurrence of landslides.



Of the entire stretch of the highway, only a 60 km long Imphal-Noney stretch is in a comparatively good condition while beyond Noney upto Nungba, the road is littered with pot-holes thereby causing lots of inconveniences to transporters and passengers

alike However, the road stretch from Nungba to Keiphundai is in the most pathetic condition making it unsuitable even for pedestrians, let alone plying of

vehicles Like in Manipur where many sections are covered by

columns of dust during dry seasons and thick layers of slush during rainy season, some portions of the highway leading to Silchar in Assam are also proving to be tortuous to travelers.
One would come across such

pathetic conditions on the Imphal-Jiribam (NH 53) highway which connects to Silchar in Assam.

Even though local media have published the existing condition of NH 53 every now and then, it merits a comparative study.

One may say that Imphal-Awangkhul section of the highway has improved considerably but the remaining portions have not seen any

improvement so far. The condition of the highway from Awangkhul to Barak bridge is terrifying. After crossing Barak bridge, the road is all covered by stones (for expansion of the highway) upto Nung Dolan. As for the Barak and Makru suspension bridges which are the vital links of NH 53, they are what they have always been, with no sight of any improvement in the foreseeable future.

The condition of the Irang

bridge is in its worst condition and BRO men were found repairing the bridge.
