5 dengue deaths in AIIMS, toll climbs to 14

New Delhi, Sept 15: The death toll due to dengue in the national capital mounted to 14 as AIIMS on Wednesday confirmed the five cases of fatalities due to the vector-borne disease which has also affected over 1.150 people

On Monday, the premier institute had said that it was looking into the details of these "five suspected cases"

Till yesterday, at least nine deaths due to dengue were reported this year in the national capital, though the South Delhi Municipal Corporation (SDMC), which compiles the report on vector-borne diseases on behalf of all civic bodies here, has maintained the death toll at four. Out of the total number of cases August alone accounted for 652.

Father blames JNIMS doctor for giving him a semi conscious daughter

Imphal, Sept 15: JINMS director, Dr. L. The hard earn image of the institution under the institution under the supervision of the Director JNIMS at which he received numerous applause from the public and civil society organizations for providing free treatment to patients who cannot afford treatment expenditures is likely to be ruined after some doctors and nurses in the hospital were alleged of intentional negligence.

In a press meet held at Manipur Press Club today afternoon, father of a newly delivered baby at JNIMS hospital has alleged authorities' negligence as the reason of the subconscious state of his

"The baby was supposed to be normal but as the nurses injected a medicine which was different from the one that the doctor prescribed her condition is abnormal", Birjit said.

The baby is second child and as according to the advice of the consulting doctor Dr. Devendra and Dr. Thaja, Devendra and Dr. Thaja, Sangita was admitted to JNIMS Gynecology ward on July 31. "Something which was not

supposed to happen occurred, they said it will be normal birth but cesarean was conducted on the day in an emergency way", Birjit said. After sensing some unusual happening, Birjit had happening, Birjit had approached the hospital authority to constitute an enquiry to find out what went wrong to treatment process while delivering the baby. However as the authority failed to provide positive response to his plea he is putting up the matter in the public sphere through media, Birjit said while talking to the

media persons. Everything was fine until the day when my wife was supposed to deliver our daughter", Birjit said.

"But then the doctor told me to buy two injection as it was not available in the hospital, however, before I brought the injection the a nurse in the ward already provided her another injection and following that my wife started vomiting", Birjit said. He further said that the doctor after inspecting the injection given to her by the nurse had told them that it was not the medicine he prescribed.

As the condition deteriorated she was immediately taken to the operation theater and to his surprised the doctor told him that the baby was born in abnormal condition with serious respiratory problem He was also told that the bay's brain will not function properly. Birjit appealed the people of

the state to urge the JNIMS authority to constitute an enquiry into the matter so that those responsible for the condition of his daughter could be punished as according to the law of the land.

29 people on board missing AN-32 aircraft presumed dead, says IAF

New Delhi, Sept. 15: The families of those on board a missing AN-32 aircraft of the Indian Air Force have been informed that their relatives are "presumed dead"

There were 29 people on the transport plane which had vanished over the sea after it took off from Chennai for Port Blair on July 22.

"The Court of Inquiry, upon very careful scrutiny of the circumstantial evidence available and in light of extensive search and rescue operations carried out, has concluded that it is unlikely that the missing personnel on board the ill-fated aircraft would have survived the accident.

"It is with a feeling of profound sadness that the Court of Inquiry has recommended that your son/ daughter be presumed to have been fatally injured," read the August 24-dated letter from Indian Air Force to the families of those in the aircraft

An IAF source said the families have been given the information so that they can go ahead with insurance and other administrative formalities.
The letter came annexed with

a certificate of presumption of death. The search for missing AN32

is still in progress," defence sources said. The plane did not have an

underwater locator system,

which has made the search difficult.
"No fewer than 201 search and

rescue sorties, using all suitable aircraft at our disposal were undertaken.

Approximately 2,17,800 square nautical miles (Sq Nm) have been covered multiple times by these aircraft," the letter stated.
"International emergency response teams and satellites from USA also did not help in getting any concrete information about the missing aircraft," it added

Engineers are Nation Builders

September 15 is observed as the Engineers' Day in the honour of Dr. Mokshagundam Visvesvaraya (1861-1962), India's pioneering engineer and administrator, who was born on that date. The centenarian was so thoroughly a man of action that his memoir, written at the age of 90, begins only with his entry as Assistant Engineering in Public Works Department of Bombay Government in February, 1884. He leaves out his birth and family details as much as his boyhood days. The memoir focuses only on his working life, containing little personal details. Even his foreign visits that were six in number were generally filled with visits to institutions, factories and workshops with hardly any time for leisure. His mind was focussed on nation's progress, as evident in several books

Our scroll of nation builders generally contains names of freedom fighters, politicians and administrators. Most of them hailed from professions like law, teaching, journalism and even medicine etc. But the role of engineers who actually built modern India brick and mortar remain understated. Though medicine and engineering were conventionally coveted

disciplines to study in India, engineers were perceived only as a professional class working for salary. Their contribution towards nation building was ignored. There is a crying need for an authentic history of engineering in modern India.

Engineering as an academic discipline was introduced by the British in the mid-19th century. The initial object was to produce civil engineers who could assist the British in the development works. These development works consisted of road building, bridge construction, canal excavation, irrigation work, drinking water connection, sewerage work etc. The Thomason College of Civil Engineering, Roorkee (now IIT Roorkee) was established in 1847. Its establishment could be attributed to the Ganga Canals project that British were taking up- on the lines of Western Yamuna Canals and Eastern Yamuna Canals on which work were continuing since 1817. Millions of devotees who watch Ganga Aarti on the banks of Har Ki Pauri in Haridwar perhaps do not know it is product of Ganga Canals project in which many unnamed Indian engineers had worked under the British, Sir Ganga Ram (1851-1927) of Lahore, the first Indian engineer of repute was an alumnus of Thomason College. Later he turned an

agriculturalist, who turned thousands of acres of arid land in Punjab arable with his knowledge of irrigation engineering. A College of Engineering at Pune, from where M. Visvesvaraya graduated in 1884, was started in 1854. In 1859, came the

Madras College of Engineering, which trained civil engineers in both military and civil disciplines. In 1880, the Government College of Howrah, later called Bengal College of Engineering-Shibpur, was founded. It started producing India's first batch of mechanical engineers apart from civil engineers.

The names of most of the early Indian engineering graduates who must have played seminal role in building roads, bridges canals, water supply facility, sewerage, irrigation is apparently lost to history.

When Benaras Hindu University was established in 1916 these different engineering disciplines were already recognized amongst Indians. Mahamana Madan Mohan Malaviya got included the studies of different engineering disciplines like metallurgy, mining, industrial chemistry etc in the university curriculum. Pt. Malaviva realized the importance of engineers in advancing nation's prosperity
