Toast to a mirage

The state government, in its efforts to showcase and promote the multifarious potentials of the state has been organizing the Manipur Tourism Mega-Fest which is arguably the biggest and most extravagant affair in the state every year from 21st to 30th November and has been renamed 'Sangai Festival' since 2010 as a way to highlight the uniqueness of the Brow-Antlered Deer of Manipur. The state government, as has witnessed in the past, will spare no efforts or resources to make this year's much anticipated event beginning today an astounding success. Tourists, dignitaries, cultural troupes, artisans and participants from abroad will also be witnessing the event which will undoubtedly provide an international feel to the whole affair. In all, the whole exercise can only be described as an attempt to showcase and promote the best of what the state has to offer to the world in terms of art and culture, handloom, handicrafts & fine arts, indigenous sports, cuisines & music, eco & adventure sports as well as the scenic natural beauty of the land and ethnic diversity of Manipur Society. The intention of the state government cannot be doubted. What remains unclear is the impact of this annual tryst on the state in terms of improvements or achievements of its intended objectives- and more importantly, what should have been inferred from this recurring disappointments in terms of the results rather than the actual hosting of the event which has been successful for the most part albeit with a few unfortunate and violent incidents which have failed to mar the spirits of the public.

And while the euphoric public is anticipating the extravaganza like every year, the overall atmosphere in the state is muted and even cautious. It would be interesting to see what the combined impact of demonetization and the ongoing economic blockade will have on the turnout and spending habits of the visiting public. Admittedly, the limelight for the next many days will be on the Festival. And as with every past years, very few, if ever will even wonder about the plight of the shy and gentle endangered creatures whose namesake festival draws thousands of crowds from far and near to witness and experience the best the state has to offer. The total population of Sangai is at best contentious, for according to the 2013 census report, there are 160 Sangais (after allowing for standard error) in its natural habitat at Keibul Lamjao which jumped to 260 according to the latest census carried out by the Forest Department this year. What is certain though is that the Ithai Barrage has started to wreak havoc with the natural habitat of floating biomass or Phumdis on which the endangered and delicate species have thrived as the natural process of soaking up of vital nutrients by the biomass from the ground during the dry season has been prevented by the perennial waterlogging of the lake due to the barrage. While many schemes and plans are in the offing to address the problem, going by experience, there still remains the very real and imminent danger of the natural habitat of the endangered Sangai thinning down and disappearing, and along with it the prized state animal for good if action is not taken in time and in right earnest. There still is a very distinct possibility of the state holding a toast to a mirage.

6.4-magnitude earthquake jolts Argentina, Chile

Buenos Aires, Nov 21: A 6.4-magnitude earthquake has jolted western Argentina and parts of Chile, with no immediate reports of damage, authorities said. The quake rocked San Juan province at 1757 local time yesterday, striking at a depth of about 130 kilometers, Argentina's seismological institute said. In Chile, the quake was measured at a

magnitude of 6.5, officials at the government's National Emergency Office (ONEM) said. The earthquake was felt in northern and western Chile in the regions of Atacama, Coquimbo, Valparaiso, O'Higgins and the Santiago metro area. Cellular phone service was briefly knocked out in San Juan province.

Demonetization – Modi's Proud Socialist Moment

Move to correct unacceptable level of inequality between rich and poor
Role of big money and black money in politics will come down

November 8, 2016 will perhaps go down in history as the day India ushered in the most comprehensive finance sector reform that transformed the country as never before. Now, ten days later, it can be said, that it has almost been pulled off with aplomb with the least possible hardship to people. There is no doubt that there are queues in front of the banks, the rural economy has to get used to the fast changing monetary reform and that there is going to be a temporary fall in the demand in the retail sector. Making 86 per cent of the currency in circulation illegal in one stroke, the secrecy and shock in a country where still half of the population is outside the banking system and habitually hoard hard earned income and loathe the idea of going to the bank, is itself revolutionary. And of the 14.90 lakh crore high denomination notes almost 70 percent was kept as black money, hidden away from the banking system by those who have stashed away the national wealth. Those opposing the demonetization in the name of the suffering of the poor have not produced a single coherent argument to support their dissent. All agree that corruption has to be fought. They also agree that black money is the biggest source of corruption. It leads to inequality and price rise and devaluing the currency. Equally worrying is the presence of huge chunks of counterfeit currency

"They are also citizens of this country. We want such an obituary reference to come from the Chair," he said, adding that Prime Minister Narendra Modi should also come to the House for the debate. Kurien said if the members were ready, the discussion on demonetisation issue can resume immediately. "I would like to make it very clear that the Chair is ready for discussion if you are ready," he said. Stating that 11 bank employees were among the 70 who lost their lives, Yechury asked the Chair to take the opinion of the House on moving a resolution condoling their death. He said the debate could be held after the obituary reference is made by

Oppn forces RS to adjourn twice over demonetisation issue

PII New Delhi, Nov 21: A united Opposition on Monday forced two adjournments in Rajya Sabha in the pre-noon session, asserting that no discussion on demonetisation would take place till the House mourns the nearly 70 deaths caused by hardships due to the withdrawal of higher denomination currency notes. While Congress, BSP, TMC and CPI(M) among others wanted a resolution condoling the deaths to come from the Chair, Leader of the House and Finance Minister Arun Jaitley charged the Opposition of running away from the demonetisation debate. Slogan-shouting opposition members rushed into the well of the House, forcing Deputy Chairman P J Kurien to first adjourn the proceedings till 1130 hours and then again till noon. "Why are they (opposition parties)

the Chair. Kurien however virtually ruled it out saying "condolences are not done on demand. That has to come spontaneously. You can approach the Chairman (on that)." To this, Yechury said "take consensus of the House". At this point, opposition Congress, BSP and TMC members rushed into the Well shouting slogans. "Narendra Modi sharam karo, sharam karo (shame on Narendra Modi)", "Modi sadan mein jawab do (Modi please reply in the House)", "poonjiwadi ki yeh sarkar nahi chalegi (this government of capitalists will not be tolerated)", "Jan virodhi Narendra Modi sharma karo, sharam karo (shame on anti-people Narendra Modi)," they shouted. TMC members carried placards with "Financial Emergency" written. Kurien then adjourned the proceedings till 1130 hours.

On Saturday morning, Pakistani army resorted to violation of the ceasefire in the Nowshera sector and in the afternoon, they started firing in the Sunderbani sector targeting Indian posts and civilian areas. On Thursday, Pakistani army had targeted Indian posts and civilian villages+ along the LoC in the Pallaanwala sector of Jammu district. Pakistani troops on Tuesday targeted Indian posts with heavy

firing and shelling for four hours along the LoC in Rajouri in Jammu and Kashmir, forcing Indian troops to retaliate. There have been 286 incidents of firing and shelling along the LoC and the International Border (IB) in Jammu and Kashmir by Pakistani troops that have resulted in the death of 26 people, including 14 security personnel, since the surgical strike on terrorist launch pads in PoK on September 29.

1 dead, four soldiers injured as Pak violates ceasefire in Rajouri

PII Jammu, Nov. 21: One BSF jawan died and three others were injured as Pakistani army resorted to heavy cross-border firing in Rajouri sector of Jammu and Kashmir on Sunday night, in third ceasefire violation since Saturday. "Pakistani army resorted to heavy cross-border firing in the Rajouri sector, in which four of our soldiers have been injured," an Army officer said.

He said the army was giving befitting response to the Pakistani fire and the exchange of fire was going on till last reports came in. The ceasefire violation came a day after a BSF jawan and a woman were injured and two houses were damaged when Pakistani troops targeted Indian posts and civilian areas along the Line of Control (LoC) in Nowshera and Sunderbani sectors of Rajouri with mortar attacks and small arms fire.

HC to hear tomorrow plea against demonetisation

PII New Delhi, Nov 21: Delhi High Court today agreed to hear a plea against demonetisation, saying once the currency was invalidated then how could the government direct certain public utilities including hospitals and petrol pumps to accept old notes. A bench of Justices B D Ahmed and Jayant Nath listed for hearing tomorrow the plea which also sought discontinuation of the new Rs 2,000 currency note, terming the move as "unconstitutional and bad in law". Petitioner Pooja Mahajan, running a

designer showroom, mentioned the matter pleading urgency on the ground that she is being deprived of earning her livelihood and her fundamental rights are being infringed. She also blamed the government for taking a dual stand saying on one hand it was encouraging people to deposit old notes in bank accounts and on the other hand threatening them of prosecution for depositing over Rs 2.50 lakh. Advocates, A Maitri and Radhika Chandrashekhar, counsel for the
