Imphal, Nov 25: Transport department of the Government of Manipur has introduced hired Winger vehicles for transportation of Sangai festival visitors instead of the low floor Buses procured under the JNRUM. Most of the JNRUM buses are now lying unused in the MSRTC campus and conditions of some are almost near to condemn.

Last year the state transport department utilised the buses for the Sangai festival visitors but for reason best known the

'Printing errors' in new Rs 500

New Delhi, Nov 25: In its hurry to meet the demand for new notes, the Reserve Bank of India has made major errors which can have serious consequences for the demonetisation exercise. The gaffe - RBI has printed two variants of the new Rs 500

According to a report in The Times of India, the newspaper has seen at least three case studies where the new Rs 500 note varied from each other. According to one customer quoted in the report, Gandhi's face has a more than visible shadow. Apart from this, he has pointed to alignment issues with the national emblem and also serial numbers.

Another Mumbai resident has told the newspaper that the colours of the notes he got were different. The report has cited one more such instance of variation. Meanwhile, a RBI spokesperson has termed them as "printing defects"

Four National Highways projects cleared for the North Eastern region

Ministry of Road Transport & Highways has cleared four projects for the North Eastern region of the country, totalling 112.88 km, at a total cost of Rs 1173.98 Crore. Two of these projects are in Manipur and one each in Nagaland and Arunachal

The first project is for strengthening of the existing two lane pavement and providing paved shoulder on

47.67 km stretch of NH 39 (Mao – Imphal section) in Manipur at a cost of Rs 230.46 crore. Land is already available for the project.
The second project is also

for strengthening of the existing two lane pavement and providing paved shoulder on another 27 km stretch of NH 39 (Mao-Imphal Section) in Manipur at a cost of Rs 139.87Crore Land is already available for this project too.

The project in Arunachal Pradesh is for 4-laning of 10.9 km of Itanagar to Banderdewa Section of NH-415 at a cost of Rs 341.83 crores. The state government is providing 30/40 m ROW free from encumbrances for

The project.
The project in Nagaland is for improvement 27.3 km of city portion of NH- 39 through Dimapur and Kohima at a cost of Rs 461.82 crore. Land is already available for the project.

SC to hear petitions challenging demonetisation on 2 December

New Delhi, Nov 25: The Supreme Court on Friday fixed on 2 December the hearing on a batch of petitions challenging the constitutional validity of the decision to demonetise currency notes of Rs1,000 and Rs500 and the inconvenience faced by the common man due to it.

A bench comprising chief justice T.S. Thakur and justice D.Y. Chandrachud said, "we will examine both aspects (inconvenience and constitutional validity) of the matter. Come on Friday at

2pm". The bench, meanwhile, asked

attorney general Mukul Rohatgi, appearing for the centre, to file additional affidavit, if any, explaining the "schemes and steps" taken to ease the situation that has arisen due to demonetisation Senior advocate Kapil Sibal, appearing for one of the petitioners who has challenged the Centre's 8m November decision on demonetisation, said the court should start hearing the matter

from Tuesday itself. Rohatgi, however, opposed the contention and said let all the petitioners, who have approached various high courts on the issue, come to the apex court which would take a call on 2 December as to whether the Supreme Court or the Delhi high court would hear them all.

Centre has recently moved the apex court seeking transfer of all the petitions pending in various high courts to either the Supreme Court or one of the high courts.

Yesterday, centre had filed an affidavit in the apex court on demonetisation and had said that the "bold move" would eradicate black money and slush funds operating since Independence which cast a "parallel economy" hitting the poor and the middle class.
