registration number AS-11 C 5076. It is strongly suspected that he was killed by someone after serious torture. Meanwhile, driver of the vehicle in which Mr. Laisharm Biswariit was travelling has been disappeared all of a

Dengue alert: Number of positive case reaches 14 as 9 more confirm today

IT News Imphal, Oct 5: The number dengue positive case at Thangmeiband Lourung Purel Leikai has reached 14 with 9 more confirmed case today. Official source, said 3 persons of a same family at Thangmeiband Lourung Purel Leikai here in Imphal West were tested positive two days back and yesterday 2 more from the same family were tested positive again

increasing the number to 5. All the patients are undergoing treatment at Shija Hospital and Research center.

Source however said that 9 more blood sample collected from 20 persons of the locality were found positive today. But Official of the state health department still is not revealing the information as it would create panic situation in the city. The

blood samples were collected from suspected persons from the locality two days back. Meanwhile, State Malaria department has taken up measures to prevent mosquitoes and larva in and around the area. Mosquito nets were dipped in anti mosquito solutions. Counsellor of Thangmeiband area too cleans all drains in and around the area. Garbage piled up were collected too.

NSCN-IM calls UCM 'house of contradiction'

Imphal, Oct 5: Responding to the statement of United Committee Manipur (UCM), the NSCN (IM) said that the Indo-Naga ceasefire is a bilateral ceasefire agreed upon between the Government of India (GoI) and the NSCN (IM).

The rebel group called UCM as a house of contradiction saying that the UCM talks about violation of ceasefire ground rules by the NSCN and at the same time they said that there is no ceasefire in Manipur.

"The so called Manipur State being part of India, you are also part of India whether you like it or not. The issue is between India and Nagas," said a press note issued by the MIP of the NSCN (IM) It termed the UCM's statement as unfortunate and stated that the UCM "is reacting and intimidating public uprising against the release of three NSCN cadres detained by the 35th Assam Rifle at Senapati on 28th

September 2016." The NSCN (IM) claimed that the three cadres were

"detained under wild allegations and were released as they were proved innocent who did not commit any crime at all."

'It is irony that UCM, which always voices against the removal of Armed Forces Special Power Act (AFSPA) from the so called Manipur State, on the one hand totally oppose the ceasefire between NSCN and GoI thereby propagating continuous killing and shooting between the NSCN and the Indian Army.
