

# **Chief Minister** intervene MU crisis: Academic Council hold another meeting; fails to take a decision

Imphal, Oct 11: Taking the prevailing issue at Manipur University in the aftermath of the Academic Council's resolution of October 8 regarding reservation of seats in the Manipur University, Maif Minister Okram Ibobi had reportedly intervene the issue by directing the University authority to revoke the resolution adopted on the day. A high level source said that the Chief Minister had taken the matter seriously as the tribal students' body had threaten to called total shut down in Hill district if the resolution adopted on the day has not been revoke within four days starting yesterday. On the other hand the departure of Tribal students from Manipur University complex has make worried to the Chief Minister as it has the

tendency to break down the prevailing law and order

condition of the state. Even though the Manipur University is not in the purview of the State Government, as the crisis arises out of the University has the tendency to break down the law and order condition of the state, the Chief Minister's directives is somewhat serious and is taken seriously by the

University authority. The members of the Academic Council were seem to put in the middle of the devil and deep blue sea and the meeting convened today failed to arrived at any amicable situation.

Meanwhile, large number of Tribal students staged protest demonstration in front of the main gate of the Manipur University. Police face tough time controlling the agitators.

## District and Block level committee of MPCC supports ST demands for Meetei/Meitei community

The members of the MPCC committee also agreed to committee also agreed to endorse the demand put up by the Coordinating Body on Scheduled Tribe Demand Committee (CBSTDC) Manipur to the Chief Minister and other leaders of the MPCC.

The decision to support the movement for inclusion of Meitei/Meetei to Scheduled Tribe list was taken during an interaction programme held today at Manipur Press Club. Almost all office bearers of the District and Blocked Level Committee of the MPCC from Valley districts attended the interaction programme.

Convenor of the CBSTDC, M Churamani, while speaking to media persons said that the interaction programme from the grass root workers of the Congress party is being organized in consideration to the importance of the Congress party in pushing up the matters for saving the indigenous people as it is in power in the state government. He expected hopes that the Congress leadership including the Chief Minister of Manipur will take the demand for ST status of Meitei/ Meetei community as genuine and serious as it is the only means to

# MUTSU stage protest; demands revocation of Oct 8 Academic Council resolution

IT News Imphal, Oct 11: Members of the Manipur University Tribal Students' Union (MUTSU) today stage protest in front of Youth Hostel at Khuman Lampak in Imphal West demanding revocation of the resolution adopted by the Academic Council of the Manipur University Regarding reservation of Admission to the University. The MUTSU volunteers along with other tribal students yesterday left the Manipur University in protest against the resolution on reservation by the Academic

Council of the Manipur University and have been staying at Youth Hostel at Khuman Lampak.

A representative of the MUTSU while speaking to media persons said that there are around 900 (nine hundred) tribal students studying in the Manipur University. He appealed all tribal students to endorse the decision of the MUTSU on reservation issue and appealed them not to write any assignments, test or class related activities until the demand is met. He warns serious consequences to

those students who failed to follow the directives of the Students' Body. On the other hand the student body also appealed the University authority not to conduct any form of test or assignment writing before the ongoing impasse on reservation issue is not settled.

The MUTSU further stated that the Academic Council should follow and implement the Central Educational Institutions Reservation in Admission Amendment Act. 2012 at which the court had also directed to the University authority

#### NPF stands with Tribal students' body; says MU Academic Council should revoke resolution on Reservation of seats

Manipur State Unit has extended its support to the demand of the Manipur University Tribal Students' Union (MUTSU) on reservation policy at Manipur University. The NPF state unit said that the Academic Coursel of the

the Academic Council of the Manipur University should endorse the Central endorse the Central Educational Institutions Reservation in Admission Amendment Act, 2012 instead of going with the Central Educational Institutions Reservation in Admission Act 2006 which put the quotas for admission of tribal student to 7.5 % despite the fact that 45% of the population is comprised with Tribal people in the state of Manipur. Speaking to media persons at

the Office of NPF Manipur State Unit, Dewlaland, Awangbou Newmai, President of NPF Manipur State Unit said that the decision of the MU Academic Council to adopt the norms of the Central Educational Institutions Reservation in Admission Act 2006 for the current academic session is highly condemnable The decision taken through the Academic Council of MU is totally biased and in violation

of the Central Educational Institutions (Reservation in Admission) Amendment Act 2012 and orders of the High Court of Manipur, he added. Awangbou Newmai also said that Central Educational Institutions (Reservation in Admission) Amendment Act 2012 clearly states that reservation for ST should be reservation for S1 should be 31%, SC 2% and 17% for OBCs based on the population of the State. Decision of the Academic Council of MU is nothing but

suppression of justice and denial of constitutional rights of the tribals who constitutes about 45% of the population of Manipur and who have long been denied their rights and privileges. Mu Authority Council should

revoke their decision immediately and bring the present imbroglio to its logical conclusion, he added.

Awangbou Newmai further said that they are deeply concerned with the prevailing situation in Manipur situation in Manipur University regarding the reservation for admission in the university for the students. It is unfortunate that the present crisis is hampering the careers of thousands of students who are looking further study at their desire field in the

university, he added. NPF Manipur State Unit also appeals to all the students of the university to avoid any violence, arson and destruction of properties, instead they should try to solved the problem amicably based on truth and Justice. Meanwhile, Awangbou Newmai states that the current government seems to be of one sided. Under the governance of Chief Minister O Ibobi Singh for 3 terms, the current issues faced by the people state is not the first, the system cannot deny that it is corrupted in case of job recruitments, etc. NPF strongly condemned the

prolonged issues by the state government. The attitude of the Congress Political Party will not bring any development in the society except for more issues. It is very disappointing to state that even common and small problems are still remains unsolved by the State Government.

Manipur will never be a developed if the current Government continues to rule but development could be bought in the state if the government takes same steps with the people of both Hill and Valley areas.

## Shop owners of Governor's road Paona Keithel protest prohibition of parking

Imphal, Oct 11: Shop owners of Governor's Road, Paona Keithel today staged a protest demonstration against the prohibition of Parking to vehicles at the roadside. Memorandums drawing attention to the grievances of the shop owners and runners were also submitted to the Governor of Manipur, Director of Transport as well as to the Superintendent of Police Imphal West.

Parking along the route has been prohibited by security force particularly by the CRPF on duty safeguarding the Raj Bhavan since August middle week after miscreants blasted a bomb near Manipur State Museum on the evening of August 15 this year. A day after the blast another explosive was also recovered near Johnston Higher Secondary School.

Shop keepers of the area said that since the security forces had prohibited parking of vehicles on the road side all business has been put to a

complete halt as customers had stopped coming due to the inconveniences.

K. Hemanta, owner of L.I. Electronics said that their business has been put to serious trouble as the customers can't stopped even for a minute to buy goods

from their shops. The ban on parking was imposed since August 15 in connection with a bomb blast that occurred near state museum without giving any notification by transport department, he said. He further said that there are

around 140 shops along the road and families of those running the business are dependent to them.
