Committee demands nomination of RJ MP from 8 deprived ACs

Imphal, April 16: Thoual District MP Candidature Demand Committee has submitted a memorandum to the prime Minister of India urging him to elect Raiva Sabha MP from among the candidates from 8 Assembly constituencies of the outer Manipur Parliamentary constituencies who are deprived of contesting election as the outer seat is reserved for ST candidate. Around 2,35,182 voters of the

8 Assembly constituencies viz, Sugunu, Hiyanglam, Waagai,

Kakching, Heirok, Wangjing Tentha, Kangabok and Jiribam Assembly Constituencies are allowed to cast their vote in the Lok Sabha election, but they are deprived from contesting the election as the seat is reserved for ST candidate. In a press meet held today at

Manipur Press Club, spokesperson of the Thoubal District MP Candidate Demand Committee said that after the demise of the Rajya Sabha MP Haji Abdul Salam, the RS seat remain vacant so while filling the vacant seat the candidate should be from the 8 Assembly

Imphal, April 16: Lawyers of Manipur have raised their voice against the amendment of advocate act of 1961 by the Law Commission of India and threaten to launch protest at New Delhi

Speaking at a meeting held at High Court, Manipur complex organise by Bar Council of Manipur (BCM) and All Bar Association of Manipur (ABAM), A Jagjit, Spokesperson of BCM said that few provisions have been added to the existing advocate act 1961. According to a propose amendment, if a lawyer loses a case, he or she liable to pay a sum of Rs 3 lakhs and expenses involve d in the case to the client.

It also allows the advocate from the foreign countries to practice in India, he added. Jagjit also said that this is a violation of the rights of the

Advocates of Manipur will hold a signature campaign and will submit a memorandum to the governor of Manipur weather it will be through the District Magistrate in-order to reach out at Union Government.

Report of the Law Commission will also be burn in front of the complex of High Court, Manipur he added

Jagjit further said that if all the submitted terms are fails to approve by the Union Government or authority concern on or before Many 1, 2017, on the next day, i.e, May 2, 2017, will leave for Delhi and protest rally will be carried out from Patiala High Court to Rajgath.

Despite the protest if the concern fails to provide positive response, the lawyers have decided to launch a series of protest against the decision to make amendment to the advocate act of 1961, he added.

The protest is part of the protest carried out in the country by the lawyers.

Barred from singing in Hindi, Assam singer leaves Bihu stage

top singer Zubeen Garg late Friday night quit a bihu stage after the organisers stopped him from singing a Hindi number, but not before hurling an abuse and stating through the microphone that an artist had the right to sing according to his choice. The organisers however claimed that the singer had agreed beforehand not to sing Hindi songs.

"His event manager had assured us even before he went up to the stage that Zubeen Garg would not sing any Hindi song on the bihu stage. It was a gentleman's agreement that

he flouted, prompting us to stop him. We are not opposed to any language, but bihu is not for singing Hindi songs," said Madhu Ranjan Nath, president of the Noonmati Bihu Sanmilan. Zubeen Garg, Assam's

highest-paid singer had just started singing a Hindi song – one of his own Hindi songs – after having presented a few Assamese and bihu songs, when Nath and a few other organisers walked up to the stage and asked him to stop. This led to exchange of words between the singer and the organisers for a few minutes, both sides pulling the

microphone, until Zubeen Garg announced his quitting, but not before hurling an abusive word that was heard clearly over the sound system as also

on local TV channels live.
"I am an artist and I have the freedom to sing. I have sung rrectom to sing. I have stung over 16,000 songs in 25 years. Moreover, while Hindi is our national language, bihu is a festival of music," the singer later said. "Assamese, Hindi, Bengali and most other languages have originated from Sanskrit, and I don't understand why I was stopped," he said. Nath, speaking on behalf of the

organisers said pioneers of

modern-day bihu, like RG Baruah and Ambikagiri Ray-Choudhury had definitely brought the bihu festival to the urban stage to preserve, promote and propagate it. "Great men like RG Baruah and Ambikagiri Ray-Choudhury had designed the modern-day bihu to popularise it among the urban and younger generation. Moreover, no singer had ever sung a Hindi song in the Noonmati Bihu Sanmilan in the

past 53 years," Nath said. Zubeen Garg, who left the pandal leaving "Dil tu hi bata" (from Krrish-3) incomplete after telling the audience that he had no ill-feeling against them, later

sang a number of Hindi songs in another bihu pandal in Bharalumukh in the city. 'Nobody can dictate me or any other artist. I don't care Everybody knows what happens when I get angry," he

The issue meanwhile has generated a debate with a section of people condemning it as an attempt to curb the right to freedom of expression. Veteran Assamese actor Biju Phukan said, "Every artist has the right to express freely." But senior journalist Haidar Hussain said, "Bihu is not the occasion to sing Hindi
