There is no doubt that the distinct aroma, varieties and extent of availability of these plants, herbs and vegetables has been confined to the local market. While the reasons are many and varied, yet it is pretty clear that there is an apparent lack of enthusiasm and earnestness on the part of the Government to explore and exploit markets outside the State and beyond. The latest confirmation of the interest shown by people

PTI New Delhi, Aug 1: The Rajya Sabha was today rocked by opposition protests over an Election Commission (EC) notification that provides the MLAs the 'None of the Above' (NOTA) option in the vote for the elections to the Upper

House. Angry members of the Congress and other opposition parties forced adjournments of the proceedings as they questioned the NOTA provision for these elections.

Significantly, the protests come at a time when a high profile battle for Rajya Sabha seats from Gujarat is round the corner involving heavyweights like BJP chief Amit Shah, HRD minister Smriti Irani and veteran Congressman Ahmed Patel. As soon as the House Assembled at noon, deputy leader of the Congress Anand Sharma said the decision to provide the NOTA option had been made without amending the Constitution or the law as per the direction of the Election Commission.

"It vitiates the election... Constitution has not been amended. Representation of People Act has not been amended. NOTA has been introduced...unless

Constitution is amended, how can this be done," Sharma asked. He said the vacancies are notified

by the House and asked how could a new provision be introduced in between. Chairman M Hamid Ansari

suggested that the matter be taken up with the Election Commission and tried to proceed with the Question Hour.However, the opposition kept on raising the issue. Finance Minister Arun Jaitley, who is the Leader of the House, said that from what he understood, there was a Supreme Court judgement which provided for the NOTA option.

"The judgement came several years before this government came to power. The Election Commission pursuant to that judgement had issued some notification under Article 324.

Article 324 covers all election in this country and therefore that's a cirucular which they issued, not now, but earlier." Jaitley said.

He said if somebody is aggrieved with the circular, he has his own options.

## Educational institutes closed in Kashmir after protests

РП Srinagar, Aug 1: Authorities today suspended class work in all educational institutions across Kashmir in the wake of protests after the killing of top Lashkar-e-Toiba (LeT) commander Abu Dujana in an encounter with security forces. All schools, colleges and universities have been closed for the day, Divisional Commissioner, Kashmir, Baseer Ahmad Khan told PTL Khan said he issued the order for the closure of educational institutions as a precautionary

measure in view of the prevailing situation. Clashes broke out in many parts of the Valley following killing of two LeT militants, including Dujana, in south Kashmir's Pulwama district this morning. A civilian was killed and several

others injured today as security forces opened fire on stone-pelting protestors near the encounter site where two militants were killed. The authorities have also suspended mobile Internet services across the Valley

 "No" means No. Not "maybe." Not "I'm just playing hard to get." Not "later." Not anything but NO. This isn't rocket science so I'm not sure why so many men aren't getting the message. Start listening to what women are saying not what you want them to be saying. And, if a woman is too drunk, stoned, drugged, or medicated, that means NO too. And, having sex with a woman in that condition is RAPE and a CRIME

. Stop supporting movies and television that depict women in subordinate roles and as sex objects. Avoid movies and television that glorify rape and other sexual abuses

3. Don't support porn. Not only is the porn industry engaged in violence against women, research in *Psychology Today* found that people who watch porn are: 1) more likely to be desensitized to violence against women; 2) more likely to blame the victim of rape and violent crimes against women; and 3) more likely to rape a woman

4. Avoid strip clubs and don't accept a partner who supports these places. I was reading an article recently that indicated many female strippers are threatened with or subjected to violence and are also often the victims of human trafficking. 5. Stop demeaning the feminine by saying things like "you run like a girl," "you throw like a girl," or "he cried like a little girl." That includes

eferring to move net agin, of netricented and and gin. That netrotext referring to men or boys as "girls" when you are meaning something derogatory. Don't refer to a woman as a "bitch," "ho' or "whore." 6. Speak up against violence against women. Years ago I overheard a

guy I went to school with say to his buddies, "I'd love to rape her" and motion in the direction of a waitress. No one said anything to him. There is no excuse for violence against women or even language that condones or promotes it.
7. If you know a victim of abuse get the police involved. This woman's

life may be at risk. 8. Be a hero. Reach out to show your support and assistance to women

who are victims of violence.

9. Speak up against sexism, sexist comments and sexist jokes. Devaluing women or valuing them for sex is at the root of violent crimes against women. Sexist comments and jokes devalue women

10. Learn the law and use it. Ask for police support. Press charges against a man who is violent toward you or one who threatens violence ainst you

against you. 11. Don't buy from sexist companies and don't support sexist organizations. They're only profiting from sexism or from promoting women as sex objects. A colleague told me her partner bought a "Wife Beater" T-shirt. Astounded, I asked her why she accepted that her partner was sexist and promoting violence against women, not to mention demeaning a serious crime that causes thousands of women's deaths every year. 12. Donate to legitimate organizations and charities that advocate for

women, support them when they've been victimized by violence, or help them overcome difficult circumstances. 13. Teach your daughters and sons about fair and respectful treatment

of girls and women, including rape myths (the disturbing notion that a woman actually wants to be raped or somehow deserves to be raped) Teach them that date rape is a serious crime, making any man who

pushes or forces a woman to have sex a rapist and a criminal. **14. Don't engage in revenge porn**—posting naked pictures of a partner on websites after she breaks up with you. And, women, if he loves you

a doesn't need to exploit you through naked photos.
15. Recognize that the way a woman is dressed or not dressed has nothing to do with whether she "deserved it" or "had it coming." No matter how a woman is dressed, it is not an invitation to any man to mistreat her.

Instructure: 16. Expect more from the men in your life. Men: expect more from yourself. Don't accept or engage in language or actions that condone or promote sexism or violence against women. 17. Think before you speak. Next time you say something about "girls"

substituted the name of an ethnic, cultural or religious group. If it sounds racist or prejudice then you know it will be sexist and equally unacceptable if you say the same comment against women or girls. 18. Stop prematurely sexualizing young girls. Parents don't let your

kids dress in micro-miniskirts, high heels, and makeup. I was in a café where a girl about 9 or 10 kept falling on the ground. It was obvious that her high heels were the issue. She can make these choices for

herself when she's older. 19. If you're involved in an abusive relationship, **reach out to a shelter** or women's group for help. You don't need to remain isolated. Most abusive men attempt to keep their abused partners isolated and controlled. If you're subjected to verbal abuse tell yourself you deserve better (you do!) and get out. With 7 billion people on the planet, you

 cally can do better than someone who abuses you.
 20. Share articles and information about ending sexism and violence against women through social media like Facebook and Twitter. Raising awareness helps overcome the problem. 21. Write to your political representatives making them accountable

for sexist legislation, including insufficient sentences for men who commit crimes against women.

22. Take a self defense or martial arts course. When I was 17, my mom asked me to take a self defense course with her. I not only came out feeling more capable of protecting myself, I felt empowered. Most men who commit crimes against women are cowards who frequently back down when they suspect they'll be challenged.

However, when it met again, several other opposition members also raised their voice on the issue. Satish Chandra Mishra (BSP) said it seemed the rules were not proper and the election of three members to the Upper House may get cancelled. He sought that the issue

be taken up. Ram Gopal Yadav (SP) said that important people were contesting the election and it needs to be

looked into. Anand Sharma said that if a change required amending a legislation, it has to be done by Parliament.

Ansari said that he was caught between lawyers of eminence from both sides and again sought that queries under the Question Hour be

taken up. However, as the protests continued the House was adjourned till 2 PM. Meanwhile, an Election Commission official, on the condition of anonymity, said that a provision to have the NOTA option in the Rajya Sabha polls came in to force in 2014, after a Supreme Court order said that NOTA button should be installed on electronic voting machines.

The official also pointed out that MLAs of a particular party have to show their marked ballot papers to the authorised agent of the party before putting it in the ballot box.
