Internet Game 'Blue Whale Challenge' may be the cause of Siddharth's death - Report

Imphal, Aug 16: Delhi Police investigating the mysterious death of former Minister Okendro's son Siddarth said that the deceased might be a victim of the notorious Blue Whale game challenge, a report appeared in **Times of** India said today.

The report also said Siddarth, was either already drunk or unwell when he came to the restaurant on August 12. CCTV footage show him staggering his way up the

Police are also checking his phone and laptop. The game allegedly consists of a series of tasks assigned to players by administrators during a 50-day period, with the final challenge requiring the player to commit suicide. The term "Blue Whale" comes from the phenomenon of

beached whales, which is linked to suicide

As per report of the Times of India, a police team visited the MyBar Grill restaurant to recreate the sequence of events on Monday. So far, they have been unable to find out if Siddharth Singh was accompanied by anyone to the terrace from where he fell to his death. Police had found his phone and sunglasses on the staircase on Sunday. Sources said Siddharth Singh

had made calls and sent messages to some unknown numbers before his death; these are also being checked. While the victim's body was cremated at his hometown in Imphal, police have preserved his viscera samples and sent them to a laboratory in Hyderabad to check for the possibility of poisoning.
They are also trying to find out whether Siddharth Singh had visited any other restaurant before coming to MvBar Grill. On Monday. investigators questioned waiters at the restaurant to verify different versions Sources said Manipur police may join the investigation. Meanwhile, police are trying to

reach out to Siddharth Singh's friends for information. A family friend told The Times of India "We have found nothing so far that indicates that it was a suicide; so, there is a strong possibility of a foul play. The restaurant management needs to answer how Singh entered the terrace when it is a restricted area."

Doctors who conducted the autopsy had on Sunday said that Siddharth Singh had multiple fractures on the shoulder and collar bone and had severe internal bleeding.

Cabinet approves Scheme of Budgetary Support under GST Regime in NE states

New Delhi, Aug 16: The Cabinet Committee on Economic Affairs chaired by the Prime Minister Narendra Modi today has given its approval to the Scheme of providing Budgetary Support under Goods and Service Tax Regime for the eligible industrial units located in States of North East India including Sikkim, Jammu & Kashmir, Uttarakhand and Himachal Pradesh. Budgetary support of Rs. 27,413 crore for the said Scheme has been approved for the period from 1.7.2017 till 31.03.2027 for such industrial units located in aforesaid States which availed the benefit of Central Excise exemption prior to coming into force of GST

The Government of India was implementing North East Industrial and Investment Promotion Policy (NEIIPP), 2007 for North Eastern States including Sikkim and Package for Special Category States for Jammu & Kashmir. Uttarakhand and Himachal Pradesh to promote industrialization. One of the benefits of the NEIIPP, 2007 and Package for Special Category States was excise duty exemption for first 10 years after commencement of commercial production.

It is estimated that total number of 4284 eligible units located in these States will be benefitted from the above

Assam, Manipur can now decide on AFSPA

News Delhi, Aug 16: The Union Home Ministry is set to give up its power to impose the 'disturbed areas' tag on Assam and Manipur, both ruled by the BJP. The move effectively means it will be the States' decision to either continue the Armed Forces (Special Powers) Act (AFSPA) or revoke it.

As per Section 3 of the AFSPA, it can be invoked in places where "the use of armed forces in aid of the civil power is necessary."

A senior official told *The*

Hindu that it would be the first time since 1990 — when the AFSPA was first invoked in Assam - that the Centre would give up its power to continue or discontinue it. The AFSPA empowers the Army and Central forces deployed in "disturbed areas" to kill anyone breaking the law and arrest and search any premises without warrant. ..we have decided to rescind the power of invoking the AFSPA in two States for now: Assam and Manipur. The States are competent to decide whether they want to continue with it in entirety or impose it in a few pockets where disturbance is expected," the official said

Another official clarified that Jammu and Kashmir. Earlier, the Home Ministry

used to issue a notification declaring States "disturbed

areas" every six months. The duration was later changed to three months, pending a periodic review. On August 4, the Ministry extended the AFSPA in Assam for 27 days. It is effective in the whole of Nagaland, Assam and Manipur (excluding seven Assembly constituencies of Imphal). In Arunachal Pradesh, it is in force in 16 police station areas and in Tirap, Longding and Changlang districts bordering Assam. Tripura withdrew the AFSPA in 2015. It is not in force in Meghalaya (except in a 20-km area along the border with Assam) and

To justify the continuation of the AFSPA in Assam, the Home Ministry had said in the notification that the security situation in Assam "remained vitiated owing to the belligerent attitude of the underground groups, including the ULFA(I), the NDFB(S), the KLO and the

KPLT."
While 246 insurgency-related incidents were reported in Assam in 2014, the number came down to 11 in 2017 (till March 31). Cases of abduction also declined, with 94 reported in 2014 and nil from January to March this year. In Manipur, 56 incidents were

reported till March this year, while 278, 229 and 233 incidents were reported in 2014, 2015 and 2016

'YMC Chairperson playing 'divide and rule' among vendor ladies'

Imphal, Aug 16: Vendor ladies of Tampha Keithel in Yairipok blamed the Chairperson of Yairipok Municipal Council (YMC) for playing divide and rule among the vendor ladies of Yairipok Keithel. The Keithel ladies has been staging protest against the biased attitude of the YMC Chairperson since August 13. Yairipok market complex has been divided into three parts

– 1) Tampha Keithel, 2) New Market and 3) Nga Yonpham (Fish Market). The vendor ladies of Tampha Keithel alleged that the YMC chairperson allowed the New Market vendor ladies to sold goods that were not mentioned in the trade

licence however she put ban to the selling of goods that are not in the trade license for

Tampha Keithel vendors. There were misunderstanding between the vendor ladies and amidst the situation the Chairperson came supporting the New Market vendor ladies and even threw the goods on the face of a vendor lady, alleged the Keithel lady of Tampha Keithel.

In protest against the act of the Chairperson, the protestors said that the Chairperson and his followers are boycott in Tampha Keithel until she has been replaced. Any unwanted consequences should be bear by the Chairperson, said a
