He was speaking at the World AIDS Day - 2017 observance held under theme 'Right to Health' at 1st Battalion Manipur

Rifles ground today.
Stating that Government agencies like Manipur State AIDS Control Society (MACS) together with NGOs have been trying hard to achieve 'Zero Infection' rate, the Chief Minister expressed pleasure that the HIV prevalence rate of the State has reduced considerably due to their dedicated efforts

Informing that the State Government will acquire equipments for Hepatitis-C testing in January next year, the Chief Minister expressed hope that this would bring lots of relief to the persons, who have HIV/HCV co-infection. As drug addiction is one of the factors for spread of HIV



virus. N. Biren said that the Government had launched mass drives against drugs and other intoxicants.

He also said that the State Government is all set to implement different social security schemes to support needy people, differentlyabled persons and widows Stating that the Government had announced free diagnosis for 57 different items in Government medical facilities, the Chief Minister further said that this noble initiative will never fructify without doctors' co-operation

The Chief Minister further contended that the officials concerned should ensure to the public that quality of diagnosis is not inferior to that of the test done by private

institutes.
Urging the public to immediately lodge complaints at Grievance Cell and Anti-Corruption Cell opened at CM's secretariat if they come across any irregularity on the Government employees including doctors and other health workers, N.

Biren informed the gathering that all the reasonable and complaints logical grievances reach his table the next day.

Mary Kom resigns as boxing's national observer

New Delhi, Dec 1: Five-time world champion M C Mary Kom has resigned as the national observer for Indian boxing after Sports Minister Rajyavardhan Singh Rathore made it clear that active sportspersons will not be considered for the position.

"I resigned as national observer 10 days ago after having a word with Mr Rathore. I had been requested to take up the position, it was not something I position, it was not sometining I had asked for," Mary Kom, who claimed her fifth Asian Championships gold medal last month, told PTI today. "I had inquired about the rule

on not having active athletes as observers with the then Sports Secretary Injeti Srinivas when it was offered to me," she explained, reacting to insinuation that her appointment smacked of conflict of interest given that she is still an active national

But at that time, I was told that I should nonetheless accept the position. I did so on insistence of the Ministry and I don't unnecessary controversies about something that I had not asked

The 35-year-old Olympic bronze-medallist was among 12 national observers appointed by the then Sports Minister Vijay Goel in March.

The list also includes the likes of Olympic-gold- medallist shooter Abhinav Bindra, double Olympic-medallist Sushil Kumar and former Commonwealth Games goldmedallist Akhil Kumar among

Of these, Sushil and Mary Kom are still active in their respective sports. Akhil, on the other hand, is no longer a part of the national camp after

giving up amateur boxing. He has already rejected the conflict of interest charge, saving that he is neither a beneficiary of government schemes nor a part of the

national camp.
"I was never interested in this but accepted the position because I had been requested. I have my hands full with a lot of things. I am happy to let it go and have no complaints,

said Mary Kom.
The decorated boxer is also a Rajya Sabha MP and is in contention for the Commonwealth and Asian Games next year

It further stated that even if the government of India assures that the geographical boundary of the North Eastern states will remain intact, anything which subsequently relates to the ongoing Framework Agreement cannot be taken up inside Manipur without the prior sanction

and approval of the State Government and the People of Manipur.

The memorandum also stated its strong opposition to any steps that might directly or indirectly disintegrate the state to endorse the long standing demand of the NSCN-IM to integrate naga inhabited area such as arrangement of Pan Territorial Council or any other arrangement for financial autonomy or similar type.

Supreme Court directs Delhi, other states to set up road safety policy by January 31

Agency New Delhi, Dec 1: The Supreme Court on Thursday directed all states and union territories that have not already framed a road safety policy to do so by January 31,

and implement it.
Delhi, Assam, Nagaland,
Tripura, Lakshadweep, Dadra and Nagar Haveli, and Andaman and Nicobar Islands have not yet set up this policy.

The court passed a slew of other directives in an effort to prevent road accidents. All states must set up a road safety committee in every district by January, it said. These committees would include the superintendent of police, the health officer and representatives from Public Works Department, National Highways Authority of India and road transport besides a member of civil society.

The court also told the states

each district with necessary

facilities and an ambulance. "The state governments and union territories should take up this recommendation at the earliest since it is on record that treatment soon after a road accident is crucial for saving the life of the victim," the bench said.

The Supreme Court bench, comprising Justices MB Lokur and Deepak Gupta, was hearing a public interest litigation filed by an orthopaedic surgeon from Coimbatore, S Rajaseekaran. The doctor had submitted that 90% of road accident deaths occur because safety rules are not strictly enforced and the punishment is also not severe. The court noted that the

number of deaths due to road accidents in the country is more than 1 lakh a year, which translates to about one death

every three minutes. The judges then told the states to create a lead agency which would "coordinate activities such as licensing issues. including driving licences, registration of vehicles, road safety and features of vehicles, along with allied matters such as emission norms."

The court has made it mandatory for States and Union Territories to establish a Road Safety Fund, frame the Road Safety Action Plan by March 31 and set up a universal accidental helpline number, among other directives

The Union Ministry of Transport has been directed to frame a protocol for road design, road quality and to identify black spots, as well as implement "traffic calming" measures at accident spots. The court said it would review the situation in February 2018
