NHPC quarter gutted

IT News Imphal, Feb 10: A family quarter of the National Hydro Power Corporation Downstream Project at Bishnupur district was gutted early today

morning.

Report said that the family quarter allotted to a contract employee identified as Jiten Singh is about 400 meters away from the head quarter (HQ/32) of the Loktak Downstream project. The fire broke out at around 3.30

am today morning. Staffs and security of the project rushed that site and poured all effort to extinguish the fire and fire fighter from Bishnupur district head quarter too rushed the spot. The quarter was reported completely burnt into ashes however, there are no report of any human

casualty. Cause of the fire could not be established at the moment but source said that the fire could have been broke out due to short

Protest against kidnapping of auto driver put NH 2 to a grinding halt



Imphal. Feb 10: Vehicular traffic along National Highway 2 was put to a grinding halt for around 8 hours today after passenger auto drivers and locals of Sekmai area protest kidnapping of an auto driver by armed group, preventing all sort of vehicular movement along the highway. The protest was however wind up after the driver was released at around noon today.

Already the NH 2 has been partially crippled due to the ongoing economic blockade by the UNC. However, passenger service vehicles were allowed to travel by the UNC. Today's sudden bandh had created immense suffering to the passengers who were returning back to Imphal and also who were supposed to leave Imphal for Senapati.

The auto driver identified as Robin Thapa (about 26 years old) son of Kumar Thapa of Kanglatombi AR Colony who ran passenger service along the highway has been reported missing since yesterday morning. Later, an armed organization called Thadou Peoples' Liberation Army had claimed responsibility about the kidnapping of the auto driver and demanded a sum of Rs. One lakh for his released. He was later released at around 10.30 am at Gampiphai area near Kanglatombi.

On learning the report drivers of passenger auto gathered at Sekmai Keithel and staged protest in the middle of the road using placards decrying harassment to drivers. The locals of the area also joined the protest and prevented all sort of vehicular movement along the route, until the time when the armed militants

Tripura launches fortified mid-day meal programme for students

Agartala, Feb. 10: The Tripura with TATA Trust has launched a programme to distribute fortified meals in all schools so that all students are covered under the health benefits. Under the programme, the

government will try to provide fortified meals to students in order to counter disorders like stunting, overweight and anaemia - the major causes of maternal and child deaths said

Tripura Education Minister Tapan Chakraborty after launching the programme.

About 70 per cent of preschool children and over 50 per cent of women suffer from anaemia, caused by iron deficiency, National Survey data show. In the first phase, the

double fortified salt in school midday-meals and in the Integrated Child Development Scheme (ICDS) and mid-day meal in all schools. In January 2016 that Prime Minister Narendra Modi had

Sasikala vs Panneerselvam: It is serious if MLAs are confined and if they are refusing food, Madras HC says

Chennai, Feb.10: A day after telling the Madras high court that AIADMK legislators supporting party general secretary V K Sasikala for chief minister's post were not under illegal confinement and that they were staving in the government MLA Hostel in Chennai, the Tamil Nadu government admitted in the court on Friday that it was an 'incorrect' statement. Also, taking note of the allegation that at least 20 MLAs were refusing to take food and water because they had been kept in confinement, the court said, "If true, it is a matter of serious concern.'

A division bench comprising Justice C T Selvam and Justice T Mathivanan recorded the 'incorrect' statement, and said: "This court records the submission of public prosecutor of the state that the submission made before this court on February 9 to the effect that persons/MLAs, who are alleged

to be in illegal detention, are free and are staying on their

to be in illegal detention, are free and are staying on their own volition in MLA Hostel is incorrect."

The bench also recorded the submission that many MLAs were refusing food and drink protesting their illegal confinement. "K Balu submits that 20 of the MLAs are refusing food and drink owing to their illegal confinement. If it is true, the matter is one of serious concern. However, this court cannot act on the mere say of the counsel. Given the nature of the case, it would only be appropriate to afford the state an opportunity to inform its response." It then adjourned the case to February 13 for further proceedings. It all started on Thursday when advocate K Balu and social activist K R 'Traffic' Ramaswamy mentioned the issue of AIADMK MLAs being escorted to resorts in luxury buses in a bid to keep them together and said they were under unlawful confinement. The additional public prosecutor denied the allegation and told a division bench that all the AIAMDK MLAs were in the hostel and were free.

The bench of Justice M Jaichandren and Justice T

Mathivanan then refused to offer urgent hearing of the habeas corpus petitions, and said it would be heard in normal

Course.
