## 7 dead, 20 injured in bomb attack in Pakistan's Lahore

Lahore, Feb. 23: At least seven persons were killed and 20 others injured on Thursday in a powerful explosion that ripped through a building in a defence locality in this Pakistani city, the latest in a series of terror attacks in the country

Panic gripped the area a little before noon when the loud explosion resonated across Z-Block in Defence Housing Authority area in

"Seven persons have been killed and 20 suffered injuries," officials said.

The nature of the blast is yet to be determined and bomb disposal squad and forensic expert are collecting evidences from the spot. 'It appears to be a planted device," Punjab police spokesman Niyab Haider told PTI.

The Z-block market houses restaurants frequented by young

vehicles were also Several damaged in the blast. The injured are being shifted to different city hospitals

The latest blast came as security has been tightened across Pakistan after a recent wave of terrorist strikes killed more than 100 people On February 16, a suicide bomber killed 88 people at a famed Sufi shrine in Sindh province. Following the attack, the army launched an offensive against militants and claimed to have killed more than 130 terrorists across the country.

Earlier on 13 February, at least 14 people were killed in a suicide bombing near the Punjab Assembly.

Metaphorically, Manipur has differently been described as "The Swizerland of the East" and "The another Kashmir". But it is not such a big sate only 22,327 sqkm. in area with a population of about 23 lakhs. The population of the state is less than that of even Cassar, a small district of Assam. The population of Cassar has already touched 31 lakhs. On one sense, it questionable on how the state is still doing in some way or another. Prices of goods reaching sky-high. killing and death, threat and intimation, extortion of money, collection of percentage from development works in illegal forms, passing of bills only after doing the works on paper, terrorizing members of certain families-all these undesirable things engulve our state now. It is the work of a state organized group or else? Such an act of extorting money is happening everyday while the government is as much corrupted as possible. It is said that a post of ASI or SI can be bought at the rate of rupees more than 10 lakhs. It is talked about whether right or wrong. There is no limit in doing corruption. The government officers and employees are taking advantage of the insurgency problem. In this situation, the common people are just like being fried in a pan put on

the top of a fireplace. Meanwhile, some people very clever are looking at the public money at the cost of public welfare. The only people who are leading a comfortable life are the ministers elected MLA's and some officers being protected by security personnel. Maintaining low and order means protecting only a few people belonging to this group. Whether the law and order situation is good or bad is assessed by their way of life. The government seems to be unconcerned about how hard a life the common people are living, finding no ways to employment generation. Bureaucrats and their coins are putting many efforts up to the way to make money without doing hard works and enjoying a comfortable way of life on the blood of common people. To this, people remain dumb spectators and are unable to stage a protest against them and the collaborators. A lot of people then would become sycophants to the winning candidates. Not this all, a priority should be given first in education system, health services and sound economy conditions. We can't say that how far we have achieved in this matter as a whole. More than six populace educated unemployed youths out of about 26 populace of the state have already crossed over a statistical margin, finding no job-oriented employment no job-oriented

employment and it is the permission that they see no hope for a bring future. Some are those who would stay away from their own homes when they become disappointed, frustrated and disillusioned with the negligence and ignorance of the government in launching rural development programme. It will not be a far wrong to say that in the rural areas people have no rights areas people have no rights to lead a decent life as a human being because the government seems to be clever and powerful in scooping public properties while the rural poor have forgotten that there is a governance. It is the duty of the state to eradicate poverty. Being a poor is not a sin. The poor can't live on charity. The government should try to protect their rights as they too have the right to life. Now, the people have come to accept that nothing can be done without corruption. The moral fibre of the present government is tenuous Still, we have not seen the emergence of any good personalities in each of government departments, offices, administrative units etc. So, the state is in chaos or turmoil. To this situation, might is right. The law seems to be in the hands of individuals and they do whatever they like. There is a sublime of government.

# Four killed and five soldiers injured in militant attack

and a woman were killed while five army personnel were injured in a militant attack on wee hours of Thursday in Shopian district of South Kashmir.
The attack took place in Mulu

Chitragam area of Shopian around 60kms from Srinagar, when militants ambushed a patrolling party of 44-RR at around 2:00am, when they were returning from cordon and search operation in a

nearby village Kungnoo. The party was returning without any arrest or recovery from Kungnoo, when militants opened fire at the government forces in Chitragam village.

Even though extra contingents of forces were rushed to spot, but militants managed to flee from the spot, after inflicting heavy loses on the government forces.

In the exchange of fire, according to initial reports, a bullet hit a local resident, Taja Begum, who was inside her house and she died.

The army personnel killed in the attack have been identified as Sreejit MJ, Vikas Kumar and Ghulam Muhammad Rather while the injured include Lt Col Mukesh Jha, Major Amardeep Singh Surendra Kumar, Sumer Singh and

While returning from Kungnoo the CASO party was attacked by unknown militants at Mulu Chitragam at about 2 am resulting in injuries to six army personnel including two officers of whom three succumbed to their injuries, read the official statement of police Former chief minister and opposition National Conference leader in response to the incident tweeted, "Tragic news & deeply worrying situation in the valley. May the souls of the departed rest in peace."

Militancy is on a steep rise in Kashmir, especially after the killing of Hizb ul Mujahideen commander Burhan Wani along with his two colleagues on July 8 last year.

According to official figures, 29 Armymen and 22 militants have been killed in first two months of this year, till now. The police figures claim that around 100 locals have joined militant ranks in last year and 59 of them joined after Wani was killed. More than 60 weapons have been snatched from police and other government forces in 2016.

"South Kashmir as whole is a major concern for us as for as militancy is concerned. However, Pulwama and Shopian area a major concern as we have both militancy and law and order problem here," a senior police official told ET.

The counter militancy operations had completed stopped during five months of street protests, but resumed and are continuing at fast pace, as protests subsided since November last vear

J&K chief minister Mehbooba Mufti has urged J&K police to persuade local militants for surrender and manage their reentry into mainstream of development. Police claims that they successful in persuading few militants for surrender. However the militants alleged that the government was harassing their families under the garb of surrender policy. Local Hizb-ul-Mujahideen militant, Zakir, in a video message, warned police of dire consequences, if latter continue to harass families of militants.

## India hails UN initiative to create counter-terrorism office

United Nations, Feb 23: India l welcomed an initiative by UN Secretary General Antonio Guterres to create a new office for counterterrorism and stressed the nations should not allow "turf battles" to "hobble" the proposal.

"Every day our collective conscience is being ravaged by terrorists in some part of the world or other. It is in this background of growing concerns, that we greatly appreciate the Secretary General's initiative to promptly address the need to enhance coordination of the UN s Counter-Terrorism efforts," India's Permanent Representative to the UN Ambassador Syed Akbaruddin said. Guterres mooted the proposal to move

Counter-Terrorism Implementation Task Force (CTITF)
Office and the UN Counter-Terrorism Centre out of the Department of Political Affairs and create a new office for counter-terrorism.

This office would be headed by a new Under-Secretary- General. The UN Chief said the only objective of the new body is to improve efficiency in combating terrorism and not to change the different mandates in the field of counter-terrorism.

Akbaruddin said India welcomes the initiative and fully supports the proposal for creation of the Office of Counter-Terrorism, assuring all possible support in taking the proposal to its fruition. He however said that nations should not let differences impact the initiative and dent its credibility.

"So let us not allow turf battles to hobble this initiative, if we have to maintain its credibility," he said during an informal meeting on strengthening of the capability of the UN system in implementing Global Counter-Terrorism Strategy here yesterday. "As terrorism thrives on and is

sustained by its trans-boundary

networks for ideology, recruitment, propaganda, funding, arms, training and sanctuary, no single nation alone can tackle this menace decisively. There is no stronger case for more multilateral action, more coordination and more cooperation on any matter amongst all stakeholders than on terrorism." he said.

Akbaruddin said India envisages the Under-Secretary General for Counter-Terrorism to be able to take positions and speak on behalf of "all of UN" and develop a comprehensive narrative on terrorism including on all issues relating to counter-terrorism. He added that there are differing mandates of various UN bodies and if the counter-terrorism coordinator is to have credibility, the individual needs to be seen as the issues

"Such differentiation of mandates is only known to those in this room or those who use this building as work space. It will never be comprehensible to the ordinary people at large," the Indian envoy

#### Former Delhi BJP MLA Vijay Jolly booked for rape after victim alleges he drugged her drink

New Delhi, Feb. 23: Former Delhi BJP MLA Vijay Jolly has been booked in a case of rape after a woman alleged that he drugged and assaulted her, police

The former Saket legislator was booked under sections 376 (rape), 328 (causing hurt by means of poison, etc.) and 506 (criminal intimidation) of the Indian Penal Code after the Delhi-based woman filed a complaint at a women's police station here on February 21.

The woman has alleged in her

complaint that Jolly spiked her drink before sexually assaulting her at

Gurgaon's Aapno Ghar Resort on February 10. Jolly an MLA from 2003 to 2008 said

he filed a police complaint against the woman, who he alleged was blackmailing and extorting him, on February 17. He told PTI that the allegations were fabricated, meant to defame him and tarnish his political

Jolly said that the woman was a member of the BJP's women's wing and had met him alone at the resort on February 10. There she tried to extort a sum of Rs 5 lakh from him and

thretated to file a rape case if he did not comply, he said.

An FIR under IPC sections 384 (extortion), 120 B (criminal conspiracy) and other relevant sections had been lodged against the woman at Khidki Daula Police Station on the basis of Jolly's complaint, a senior police officer said. "When the woman and her husband came to know that I had filed a complaint against her for threatening and extorting me, she to divert police investigation and action against her, filed fabricated allegations against
