Tension runs high in Khundrakpam after police team tried to arrest a person



Imphal, Feb. 26: Tension runs high at Khundrakpam Awang Leikai in Khundrakpam Assembly Constituency early today morning after a police team tried to picked up a person of the locality who is also a sub inspector of Manipur police.

A brief confrontation occurred between the locals of the area and the police team as the police team who came to picked the Sub- Inspector

identified as Maibam Khogen Singh. Report said that the police team refused to give any arrest memo if he was

supposed to pick up.
As locals of the area swung into action by destroying the police vehicles the polic team fire several round of tear gas shells and mock bomb to disperse them.

According to report, the poli team led by Additional SP of Imphal East Meghachandra and OC of Imphal East district

police commando Vaiphe came in four vehicles at around 3.30 am today. The police team reportedly entered to the residence of SI Maibam Khogen at Khundrapam Awang Leikai. He was charged for firing gunshots late yesterday night and the police team told him to provide the gun. Maibam Khoge is posted at DG Head Quarter.

Later locals of the area organised a public meeting condemning the police action.

NIA likely to give clean chit for Pakistani boys accused of guiding Uri attackers

New Delhi, Feb. 26: The National Investigation Agency (NIA) is likely to give a clean chit to the two Pakistani boys who were arrested on charges of guiding the Uri Army camp attackers across the Line of Control (LoC) as they had just strayed across the border.
But the agency has not filed a

closure report in the court so far. "We have not filed any closure report in the case. We will file a report soon," the NIA spokesman said. The boys, Faisal Husain

Awan and his school friend Ahsan Khursheed, will get a formal reprieve only after the court is told about the findings of the probe and the court accepts the findings of the agency. Only then, the process of sending them back to Pakistan will be initiated.
The duo was first picked up
by villagers in Uri who found their movements suspicious and beat them up before handing them to the BSF and the Army on September 21, three days after the suicide attack on 12 Infantry Brigade's headquarters in which 19 soldiers were killed.

Contrary to initial suspicion of the boys being guides for Jaish-e-Mohammad (JeM), the NIA didn't find any evidence of their links with the Pakistan-based terror outfit. In fact, the agency is yet to find evidence suggesting that JeM carried out the Uri attack. After comparing the food items and arms and ammunition recovered from the Uri attackers with the recoveries made during the previous attacks in the Valley, the agency believes that the attack was carried out by operatives of another Pakistani terrorist outfit,

Lashkar-e-Taiba (LeT). NIA investigators found that the villages of the boys, Pitha Jandgran and Khiyana Khurd in Pakistan-occupied-Kashmir (PoK), are very close to the

LoC.
Details of their family members and the school in PoK, given

by the boys, have been found to be correct, sources said. Awan and Khursheed were very initially scared of being beaten up in custody if they "didn't confess their crime" and had even "identified" one of the dead attackers. But once their apprehension of being beaten up in custody was proved wrong, the boys told the investigators that they have no links with the JeM and had straved across the LoC while taking a "short cut" to their villages.
The NIA had in October last

year said that they had confessed to their crime. Based on their preliminary statement, India had even lodged a diplomatic protest with Pakistan.

India will not allow any defaulter to escape law: Jaitley

New Delhi, Feb. 26: Finance Minister Arun Jaitley has said, India is no longer willing to let defaulters escape the law. let defaulters escape the law. Mr Jaitley was speaking at a session on 'Transforming India: Vision for the Next Decade' organised by the London School of Economics' South Asia Centre. The remarks were an apparent reference to liquor baron Vijay Mallya, who is wanted in India for loan default and other Mr Jaitley said, it is the first

time that such strong action is being taken and defaulters are on the run. He referred to loan default as a major problem that needs to be addressed. Mallya, the chief of the now defunct Kingfisher Airlines, had moved to Britain in March last year after banks sued him to recover around 1.4 billion US dollars owed by the

Earlier this month, India had formally requested Britain to extradite Mallya for standing trial. India and the UK have

an extradition treaty since 1993, under which only one extradition from the UK to India has ever taken place, that of Samirbhai Vinubhai Patel in October, 2016, to stand trial for his alleged role in the 2002 riots in Gujarat.

Mr Jaitley refused to confirm if the issue of Mallya's extradition would feature in his talks with senior British ministers. However, senior officials in London had indicated earlier that the issue is likely to be on the agenda.
