a year. The apex court said that there are over 100 crore mobile subscribers while making it mandatory for all mobile subscribers, including those having pre-paid SIM cards, to have their phone number linked to Aadhaar without

fail within one year. The court also directed the Centre to device a way so that each person with a pre-paid sim would have to fill and deposit a form whenever he or she recharges.

NFP facing wrath from intending candidates after ticket announcement

IT News Imphal. Feb 6: A day after the Central Election Committee of the Naga Peoples' Front (NPF) has finalized the candidates of the party to contest in the upcoming Manipur assembly election, intending candidates of some assembly constituencies has showed its anger to the party leadership.
The NPF Central Election

Committee had announced names of candidates to contest in 15 assembly constituencies. Supporters of intending candidate of Phunyar Assembly constituency identified as one Hoppingson had vandalized the NFP office at Phungyar over denial of ticket to their candidate. The NFP had name K Leisho has the NPF candidates from the constituency.
On the other hand many NFP

members had expressed anger to the allotment of party ticket to Dr. Alexander Pao from Karong Assembly constituency. Five former intending candidates of the same party had threaten to resigned from the party against the issuance of NPF ticket to Dr. Alexander Pao. It is likely that the five candidates field a consensus candidate in the assembly constituency.

Irom Sharmila to Contest against Manipur CM Okram Ibobi Singh

Imphal, Feb. 6: Rights activist Irom Sharmila will contest against Manipur Chief Minister and Congress candidate Okram Ibobi Singh from Thoubal constituency in the Assembly elections to be held next month. Sharmila will contest from

Thoubal seat, convenor of her party People's Resurgence and Justice Alliance (PRJA) Frendro Leichonham said Armed Forces Special Powers Act, Sharmila is a political greenhorn while Congress has been in power in Manipur for

three successive terms under Ibobi Singh.

Congress on February 3 had released a list of 60 candidates for Manipur Assembly elections, with Chief Minister Okram Ibobi Singh contesting Thoubal seat.

In August last year, the 44-year-old Iron Lady broke her 16-year-old hunger strike, the world's longest such campaign, and declared that she wants to become the chief minister so that she could press for repeal of the contentious AFSPA.

While launching her party PRJA in October last year.

Sharmila had said she would contest from two seats Thoubal and Khurai. While she belongs to Khurai, Thoubal is the Assembly constituency of the Chief Minister.

Leichonbam said the party has already started campaigning in Thoubal for Sharmila.

However, there is no word yet about her contesting Khurai seat. Leichonbam said PRJA, which recently was alloted 'whistle' as the party's symbol, is likely to field altogether 10 candidates for the Assembly elections to be held on March 4 and 8.

Manipur Maoist claims attack

Imphal, Feb 6: Maoist Communist Party Manipur, today claims responsibility to the attack on Indian army camp at Sagolmang area in Imphal East on the adjoining night of February 4 and February 5. A statement of the outfit said that the armed cadres of the Maoist Communist Party Manipur has been launching operation to strike at those armed group ensuing suspension of operation with the government, who were

responsible of killing of two workers recently. It further added that the cadres has been conducting operation at various places including Ukhrul district and Saikul area It said on the adjoining night of Feb 4 and 5 some armed cadres, ensuing SoO with the government were reported to have been present at Saikul area and following that the cadres of Maoist Communist Party rushed the site. But later it was came to know that the cadres had fled the area and took refuge inside the camp of

Indian army located at Sagolmang in Imphal east. The statement said that the cadres fires some round of gunshots and return back as they have not prepared to attack the Indian army post. Moreover, bark wire were seen fencing at the paddy field which lies next to the Indian army pist so could not strike more, the statement added. On the other hand the Indian army too tried to find the position of the Maoist cadres using flash light, the statement added.

Nagaland cabinet to submit memorandum to PM to exempt it Part IX A of Constitution

Dimapur, Feb. 6: Nagaland cabinet has decided to submit a memorandum to the Prime Minister to issue an ordinance to exempt the state from the provision of Part IX A of the Constitution which deals with the municipalities. According to a communique issued by the media cell of Chief Minister's Office, the decision was taken in an emergency meeting of the state Cabinet was attended by special

from all tribes yesterday. The decision comes in the wake of various tribal organisations organisations opposing elections to Urban Local Bodies (ULB) with 33 per cent reservation of seats for women and demanding the resignation of Chief Minister T R Zeliang and his cabinet.

However, the agitating tribal bodies and civil societies rejected the decision, saying it is a total sellout of the Article 371(A) of the Constitution which accords special provisions to the state of Nagaland. Nagaland Tribes Action Committee (NTAC) Kohima has expressed shock over the decision.

Silchar, January 6: The Manipuri Youths Front Assam, MYFA, today submits a memorandum to Assam Chief Minister Sarbananda Sonowal and Assam minister Dr. Hemanta Biswa Sharma demanding the inclusion of Manipuri community of Assam as indigenous ethnic community of the state.

In their memorandum signed by Seram Herajit Singh, president of MYFA, mentioned that the Manipuri community are coming from neighbouring state Manipur from 300 years ago under different historical circumstances like war, matrimony and business

In their memorendum, the Youths Front also cited many historical points of the earlier settlement of Manipuri in Assam as supportive points. In the said memorandum it is also narrated that the there have good relations between the Ahom kingdom and Manipuri king becuase of which many Manipuri princes were married to Ahom.

From the reliable sources, it is also learnt that as per the report of Census of Assam 1881, the population of Manipuri community in Surma Valley is 47356 while the population of this community in Brahmaputra and Hills tracts is 149 and 115 respectively.

From many historical books and documents and also from many research findings, it can be noted that Manipuri community is residing in different parts of Assam before the historic incident of Seven years of devastation. While talking with this correspondence, MYFA supremo S.Herajit, today over the phone from Guwahati,

opined that from the many historical books and documents it is clear that the Manipuri community of Assam is indigenous in nature.So the State government should include Manipuri as indigenous community of the state. He also added that, if the state

governments fails to fulfill the demand than the Front will lodge a series of strong democratic form of agitation in near future. Nilu Singh, member of MYFA
