This is the point where every stakeholder needs to shed their preconceived notions of communal rivalries and instead embrace the stark reality staring us in the face and put in earnest efforts to make a fresh start. As long as we cling on to the mindset of the past, we will remain fettered and any step forward towards a better inclusive future of the state will remain a tantalizing illusion. We need to be prepared to give grounds to make new grounds, and nothing can distort or wish away the fact. The greatest obstacle to inclusive growth and building understanding is lack of communication and productive engagement. Once everyone in the state start travelling and discovering places in the remote parts of the state inhibitions, suspicions and reservations will automatically disappear and the bond of friendship will grow stronger. That is the only way to bridge the psychological divide and reach out to each other.

Prof. Gangmumei (Kabui) Kamei (1941-2017): A Personal Tribute

It is hard to believe that our belove teacher Professor Gangmumei Kamei is no more among us. His innocent and ever smiling face will be very difficult to erase from our minds. A true worshipper of *Clio*, the Muse of History whose concern and mission for life was devoted to understand not only the past but also the present and future of this small place on a corner of the earth called Manipur. My words cannot begin to assess the life, work, achievements and rare shortcomings of this man who stood and shone like a star in the intellectual horizon of Manipur. Despite encyclopaedic knowledge of the history and culture of the

region, our teacher was humble enough to claim himself "a student of history", who is proud of the heritage and civilisation of a community of people called Manipur where a number of ethnos adopted the land as their home and shared and enjoyed vicissitudes of life

My personal acquaintance with OjaKabui goes back to 1986 when I was enrolled as a student pursuing Bridge Course in history at Manipur University and our teacher was then the Dean of Students' Welfare. However, I have been introduced to his writings since the 70's of the past century through his columns in the then popular Manipuri monthly

'Lamyanba' edited by the firebrand (Late)NonmeikappamSanajaoba. In this journal he regularly contributed articles on the neighbouring countries of Southeast Asia under the caption Southeast Asia under the caption 'EikhoigeeYunlonmabaLeibakshing' which we read with awe how a person belonging to Kabui community could write such beautiful prose in Manipuri language. But when I enquired how he could perform such a feat, he laughed it off saying "your OjaThaimei (late Prof. Mangthofishimaiof Du Collarea) MangthoiThaimei of D.M College) writes better than me in Manipuri language!" Such was the simplicity of a man called Gangmumei Kamei who was kind enough to offer us a

Pak hands over dossier on 'India's interference' to UN chief confessional statement admitting

United Nations, Jan 7: Pakistan has handed over a dossier on India's alleged "interference" in the country to new UN Secretary-General Antonio Guterres and asked the world body to play a role in "restraining" India from such activities

Pakistan's Permanent Representative to the UN Ambassador Maleeha Lodhi delivered the dossier on "India's interference and terrorism in Pakistan" in a meeting with the UN chief here yesterday along with a letter from the Prime Minister's Adviser on Foreign

Affairs Sartaj Aziz. Guterres' spokesperson Stephane Dujarric said that the meeting was held at the request of the Pakistani envoy. When asked about what was discussed in the meeting, which took place at around noon he said he did not have "any indication" of what was discussed in the meeting. "The dossier contains additional

information and proof of Indian/ RAW interference in Pakistan and involvement in terrorism particularly in Balochistan, FATA and Karachi. This is a follow up to the three dossiers, which were shared with the United Nations in October 2015," the Pakistan Foreign Office said in a statement in Islamabad.

In the covering letter sent with the dossier, Aziz claimed that the arrest of "Indian RAW agent Kulbhushan Jadhav from Balochistan and his

Pakistan military courts to be discontinued after 2 years

Islamabad, Jan. 7: Pakistan will wind up its special military courts from on Saturday, two years after they were set up for speedy trial of hardcore militants following the deadly Taliban attack on an army school that killed nearly 150 children. The courts were established through an amendment in the Constitution after the horrendous attack in Peshawar on December 16, 2014. The move generated heated debate

as the courts were billed by rights activists as violation of basic human rights as enshrined in the Constitution of the country and international charters.

However, they were allowed to function after the Supreme Court upheld as valid the 21st constitutional amendment and the Pakistan Army (Amendment) Bill, 2015, enacted by Parliament in 2015. The amendment ensured that the courts will end after two years

India's "hostile intentions" towards Pakistan were also borne out by recent statements of its political and military leadership. Aziz was quoted as saying in the letter. He claimed Pakistan had made a

major contribution to global counter terrorism efforts and secured significant gains in its domestic fight against terrorism. Aziz urged the Secretary-General and relevant UN bodies to seriously consider the matter in the light of information shared by Pakistan and play a role in "restraining India from these activities, which were in clear violation of international law and posed a threat to regional and international peace and security"

New Delhi World Book Fair begins today

ew Delhi, Jan. 7: The 9-day New Delhi World Book Fair began at Pragati Maidan in national capital. The theme for this year's event is 'Manushi' which focuses on

writings on and by women. The fair will exhibit the rich tradition of women writings from ancient times till the present. Minister of State for Human Development, Nath Pandey Resources Nath Mahendra Nath inaugurated the fair.

Speaking on the occasion, Mr. Pandey said in the context of technological development, the books have to be viewed accordingly in tune with digital age. The minister also said, books continue to be more important as they reflect change in the society. He said, books have contributed in making India a culturally unique country. Nearly 800 publishers from across

the country and abroad are participating in it. About 20 countries including China, Egypt, France, Germany, Japan and Iran are taking part in the Foreign Pavilion.

Posters and panels of some of the eminent women scholars of ancient and medieval India, and women pioneers of modern India will provide an intellectual ambiance to the presentation. Books on different genres like fiction, poetry, social science, and children's literature are forming the main ingredients of the exhibition.
