Imphal, Jan 23: Two soldiers of the Assam Rifles were killed and two others injured yesterday when militants ambushed a convoy near Jairampur on the Assam-Arunachal Pradesh border, police said. The security forces launched a counterinsurgency operation immediately in the area and killed two of the militants involved in the ambush and aslo recovered two weapons from their possession. According to reports, the attackers belonged to the United Liberation Front of South East Asia, a joint platform of most of the North Eastern militant outfits, including the antitalk faction of the United Liberation Front of Asom (ULFA), National Socialist Council of Nagaland led by Khaplang (NSCN-K) and Coordination Committee (CorCom) of Manipur. Tinsukia Superintendent of Police Mugdhajyoti Mahanta said that 15 to 20 militants carried out the ambush Meanwhile, a joint statement by the CorCom and the ULFA faction claimed responsibility for the attack named "Operation BARAK".

83 crores cash, 7 lakh litre of liquor seized in poll-bound states in Manipur. In other illegal incentives

PTI New Delhi: Over Rs. 83 crore cash, 7 lakh litres of liquor worth Rs. 12.65 crore and narcotics valued at Rs. 10.30 crore have been seized, mostly from Uttar Pradesh and Punjab, by Election Commission-appointed surveillance and expenditure

monitoring teams in the five poll-bound states. As per official data compiled since the announcement of polls early this year till yesterday, Uttar Pradesh has witnessed the maximum seizure of Rs. 79.13 crore (Rs. 31.65 lakh in old notes) followed by Rs. 4.05 crore from Punjab, Rs. 33.27 lakh in Uttarakhand and Rs. 6.95 lakh

suspected to be used to lure voters in these states, a whopping 7.36 lakh litres of liquor and over 500 bottles of canned beer worth Rs. 12.65 crore has been seized by Election Commission-appointed police and state excise teams in these states. In UP, these seizures were recorded at 3.95 lakh litres worth Rs. 10.7 crore followed by 3,09,351 litres spirits worth Rs. 1.14 crore seized in Punjab, over 25,907 litres worth Rs. 72.91 lakh in Uttarakhand, 4,605 litres worth Rs. 7.5 lakh in Manipur and beer and other hard spirits worth Rs. 1.35 lakh

Appoint National Human Rights Commission Director General within a week: Supreme Court to Centre

1, no delay, says SC

New Delhi, Jan. 23: The Supreme Court today directed the Centre to appoint Director General in the National Human Rights Commission (NHRC) within a week. A bench headed by Chief Justice J S Khehar also asked the central government to appoint the members of the human rights body within four weeks.

"You (Centre) will be in trouble if we start hearing this matter and pass some order. We are granting you four weeks to appoint the members. We hope and expect that the process of appointment of members can be concluded in four weeks," the bench said.

At the outset of the hearing, the bench said, "Why don't you (Centre) appoint somebody? You have to do it. We are not going to grant you so much time." "We will give you three weeks for appointing the members and

you appoint the DG in a week," the bench, also comprising Justices N V Ramana and D Y Chandrachud said.

Later, the apex court granted four weeks time for appointing the members of the human rights body after the Centre requested for some more time

The apex court had on December 2 last year expressed displeasure over inordinate delay in filling up vacant positions in the NHRC including that of the Director General of investigation and a member while directing the Centre to enumerate reasons for the delay.

It had asked the Centre to make these appointments as soon as possible, saying, "How long do you want to drag on? Right from March 2014, there has been vacancy in the commission." "As regards appointment of Director General (investigation) when was the recommendation for appointment of a suitable officer made and by whom was it approved. The cause for delay in making of the selection/recommendation may also be

explained," the bench had said. The apex court was hearing a plea filed by advocate Radhakanta Tripathy who had said that the "commission cannot function without its chairperson, member and director general of investigation. It has become handicapped due to inaction of the government.

He had contended that due to vacant posts in NHRC for a long Tripathy had said that under the Protection of Human Rights

Act, 1993, NHRC is supposed to comprise a chairperson, who has been a Chief Justice of India, one member who is or has been a judge of the Supreme Court, one member who is, or has been, the chief justice of a high court and two members from amongst persons having knowledge of, or practical experience in matters relating to human rights.
